1.2 relating to health; providing for registration of transfer care specialists; authorizing

1.3 a transfer care specialist to remove a dead human body from the place of death;

1.4 providing for refrigeration of dead human bodies for certain time periods;

1.5 appropriating money; amending Minnesota Statutes 2020, sections 149A.01,

1.6 subdivisions 2, 3; 149A.02, subdivision 13a, by adding subdivisions; 149A.03;

1.7 149A.09; 149A.11; 149A.60; 149A.61, subdivisions 4, 5; 149A.62; 149A.63;

1.8 149A.65, subdivision 2; 149A.70, subdivisions 3, 4, 5, 7; 149A.90, subdivisions

1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 Section 1. Minnesota Statutes 2020, section 149A.01, subdivision 2, is amended to read:

1.13 Subd. 2. **Scope.** In Minnesota no person shall, without being licensed or registered by

1.14 the commissioner of health:

- 1.15 (1) take charge of or remove from the place of death a dead human body;
- 1.16 (2) prepare a dead human body for final disposition, in any manner; or
- 1.17 (3) arrange, direct, or supervise a funeral, memorial service, or graveside service.

1.18 Sec. 2. Minnesota Statutes 2020, section 149A.01, subdivision 3, is amended to read:

1.19 Subd. 3. **Exceptions to licensure.** (a) Except as otherwise provided in this chapter,

1.20 nothing in this chapter shall in any way interfere with the duties of:

- 1.21 (1) an anatomical bequest program located within an accredited school of medicine or
- 1.22 an accredited college of mortuary science;

2.1 (2) a person engaged in the performance of duties prescribed by law relating to the
2.2 conditions under which unclaimed dead human bodies are held subject to anatomical study;

2.3 (3) authorized personnel from a licensed ambulance service in the performance of their
2.4 duties;

2.5 (4) licensed medical personnel in the performance of their duties; or

2.6 (5) the coroner or medical examiner in the performance of the duties of their offices.

2.7 (b) This chapter does not apply to or interfere with the recognized customs or rites of
2.8 any culture or recognized religion in the ceremonial washing, dressing, casketing, and public
2.9 transportation of their dead, to the extent that all other provisions of this chapter are complied
2.10 with.

2.11 (c) Noncompensated persons with the right to control the dead human body, under section
2.12 149A.80, subdivision 2, may remove a body from the place of death; transport the body;
2.13 prepare the body for disposition, except embalming; or arrange for final disposition of the
2.14 body, provided that all actions are in compliance with this chapter.

2.15 (d) Persons serving internships pursuant to section 149A.20, subdivision 6, ~~or~~ students
2.16 officially registered for a practicum or clinical through a program of mortuary science
2.17 accredited by the American Board of Funeral Service Education, or transfer care specialists
2.18 registered pursuant to section 149A.47 are not required to be licensed, provided that the
2.19 persons or students are registered with the commissioner and act under the direct and
2.20 exclusive supervision of a person holding a current license to practice mortuary science in
2.21 Minnesota.

2.22 (e) Notwithstanding this subdivision, nothing in this section shall be construed to prohibit
2.23 an institution or entity from establishing, implementing, or enforcing a policy that permits
2.24 only persons licensed by the commissioner to remove or cause to be removed a dead body
2.25 or body part from the institution or entity.

2.26 (f) An unlicensed person may arrange for and direct or supervise a memorial service if
2.27 that person or that person's employer does not have charge of the dead human body. An
2.28 unlicensed person may not take charge of the dead human body, unless that person has the
2.29 right to control the dead human body under section 149A.80, subdivision 2, or is that person's
2.30 noncompensated designee.

3.6 Subd. 13a. **Direct supervision.** "Direct supervision" means overseeing the performance

3.8 supervision means that the supervisor is available to observe and correct, as needed, the
3.9 performance of the trainee or registrant. The mortician supervisor is accountable for the
3.10 actions of the clinical student, practicum student, ~~or~~ intern, or registrant throughout the
3.11 course of the training. The supervising mortician is accountable for any violations of law
3.12 or rule, in the performance of their duties, by the clinical student, practicum student, ~~or~~
3.13 intern, or registrant.

3.20 Subd. 37e. **Transfer care specialist.** "Transfer care specialist" means an individual who

3.23 supervision of a licensed mortician.

3.25 **149A.03 DUTIES OF COMMISSIONER.**

3.26 The commissioner shall:

3.27 (1) enforce all laws and adopt and enforce rules relating to the:

3.28 (i) removal, preparation, transportation, arrangements for disposition, and final disposition
3.29 of dead human bodies;

- 4.1 (ii) licensure, registration, and professional conduct of funeral directors, morticians,
4.2 interns, transfer care specialists, practicum students, and clinical students;
- 4.3 (iii) licensing and operation of a funeral establishment;
- 4.4 (iv) licensing and operation of an alkaline hydrolysis facility; and
- 4.5 (v) licensing and operation of a crematory;

5.2 **149A.09 DENIAL; REFUSAL TO REISSUE; REVOCATION; SUSPENSION;**
5.3 **LIMITATION OF LICENSE, REGISTRATION, OR PERMIT.**

5.4 Subdivision 1. **Denial; refusal to renew; revocation; and suspension.** The regulatory
5.5 agency may deny, refuse to renew, revoke, or suspend any license, registration, or permit
5.6 applied for or issued pursuant to this chapter when the person subject to regulation under
5.7 this chapter:

5.8 (1) does not meet or fails to maintain the minimum qualification for holding a license,
5.9 registration, or permit under this chapter;

5.10 (2) submits false or misleading material information to the regulatory agency in
5.11 connection with a license, registration, or permit issued by the regulatory agency or the
5.12 application for a license, registration, or permit;

5.13 (3) violates any law, rule, order, stipulation agreement, settlement, compliance agreement,
5.14 license, registration, or permit that regulates the removal, preparation, transportation,
5.15 arrangements for disposition, or final disposition of dead human bodies in Minnesota or
5.16 any other state in the United States;

5.17 (4) is convicted of a crime, including a finding or verdict of guilt, an admission of guilt,
5.18 or a no contest plea in any court in Minnesota or any other jurisdiction in the United States.
5.19 "Conviction," as used in this subdivision, includes a conviction for an offense which, if
5.20 committed in this state, would be deemed a felony or gross misdemeanor without regard to
5.21 its designation elsewhere, or a criminal proceeding where a finding or verdict of guilty is
5.22 made or returned, but the adjudication of guilt is either withheld or not entered;

5.23 (5) is convicted of a crime, including a finding or verdict of guilt, an admission of guilt,
5.24 or a no contest plea in any court in Minnesota or any other jurisdiction in the United States
5.25 that the regulatory agency determines is reasonably related to the removal, preparation,
5.26 transportation, arrangements for disposition or final disposition of dead human bodies, or
5.27 the practice of mortuary science;

5.28 (6) is adjudicated as mentally incompetent, mentally ill, developmentally disabled, or
5.29 mentally ill and dangerous to the public;

5.30 (7) has a conservator or guardian appointed;

5.31 (8) fails to comply with an order issued by the regulatory agency or fails to pay an
5.32 administrative penalty imposed by the regulatory agency;

6.1 (9) owes uncontested delinquent taxes in the amount of \$500 or more to the Minnesota
6.2 Department of Revenue, or any other governmental agency authorized to collect taxes
6.3 anywhere in the United States;

6.4 (10) is in arrears on any court ordered family or child support obligations; or

6.5 (11) engages in any conduct that, in the determination of the regulatory agency, is
6.6 unprofessional as prescribed in section 149A.70, subdivision 7, or renders the person unfit
6.7 to practice mortuary science or to operate a funeral establishment or crematory.

6.8 Subd. 2. **Hearings related to refusal to renew, suspension, or revocation of license,**
6.9 **registration, or permit.** If the regulatory agency proposes to deny renewal, suspend, or
6.10 revoke a license, registration, or permit issued under this chapter, the regulatory agency
6.11 must first notify, in writing, the person against whom the action is proposed to be taken and
6.12 provide an opportunity to request a hearing under the contested case provisions of sections
6.13 14.57 to 14.62. If the subject of the proposed action does not request a hearing by notifying
6.14 the regulatory agency, by mail, within 20 calendar days after the receipt of the notice of
6.15 proposed action, the regulatory agency may proceed with the action without a hearing and
6.16 the action will be the final order of the regulatory agency.

6.17 Subd. 3. **Review of final order.** A judicial review of the final order issued by the
6.18 regulatory agency may be requested in the manner prescribed in sections 14.63 to 14.69.
6.19 Failure to request a hearing pursuant to subdivision 2 shall constitute a waiver of the right
6.20 to further agency or judicial review of the final order.

6.21 Subd. 4. **Limitations or qualifications placed on license, registration, or permit.** The
6.22 regulatory agency may, where the facts support such action, place reasonable limitations
6.23 or qualifications on the right to practice mortuary science ~~or~~, to operate a funeral
6.24 establishment or crematory, or to conduct activities or actions permitted under this chapter.

6.25 Subd. 5. **Restoring license, registration, or permit.** The regulatory agency may, where
6.26 there is sufficient reason, restore a license, registration, or permit that has been revoked,
6.27 reduce a period of suspension, or remove limitations or qualifications.

6.29 **149A.11 PUBLICATION OF DISCIPLINARY ACTIONS.**

6.30 The regulatory agencies shall report all disciplinary measures or actions taken to the
6.31 commissioner. At least annually, the commissioner shall publish and make available to the
6.32 public a description of all disciplinary measures or actions taken by the regulatory agencies.
6.33 The publication shall include, for each disciplinary measure or action taken, the name and

7.1 business address of the licensee, registrant, or intern; the nature of the misconduct; and
7.2 the measure or action taken by the regulatory agency.

7.3 **Sec. 10. [149A.47] TRANSFER CARE SPECIALIST.**

7.4 **Subdivision 1. General.** A transfer care specialist may remove a dead human body from
7.5 the place of death under the direct supervision of a licensed mortician if the transfer care
7.6 specialist is registered with the commissioner in accordance with this section. A transfer
7.7 care specialist is not licensed to engage in the practice of mortuary science and shall not
7.8 engage in the practice of mortuary science except as provided in this section.

7.9 **Subd. 2. Registration.** To be eligible for registration as a transfer care specialist, an
7.10 applicant must submit to the commissioner:

7.11 (1) a complete application on a form provided by the commissioner that includes at a
7.12 minimum:

7.13 (i) the applicant's name, home address and telephone number, business name, and business
7.14 address and telephone number; and

7.15 (ii) the name, license number, business name, and business address and telephone number
7.16 of the supervising licensed mortician;

7.17 (2) proof of completion of a training program that meets the requirements specified in
7.18 subdivision 4; and

7.19 (3) the appropriate fees specified in section 149A.65.

7.20 **Subd. 3. Duties.** A transfer care specialist registered under this section is authorized to
7.21 perform the removal of a dead human body from the place of death in accordance with this
7.22 chapter to a licensed funeral establishment. The transfer care specialist must work under
7.23 the direct supervision of a licensed mortician. The supervising mortician is responsible for
7.24 the work performed by the transfer care specialist. A licensed mortician may supervise up
7.25 to six transfer care specialists at any one time.

7.26 **Subd. 4. Training program.** (a) Each transfer care specialist must complete a training
7.27 program that has been approved by the commissioner. To be approved, a training program
7.28 must be at least seven hours long and must cover, at a minimum, the following:

7.29 (1) ethical care and transportation procedures for a deceased person;

7.30 (2) health and safety concerns to the public and the individual performing the transfer
7.31 of the deceased person; and

8.1 (3) all relevant state and federal laws and regulations related to the transfer and
8.2 transportation of deceased persons.

8.3 (b) A transfer care specialist must complete a training program every five years.

8.4 Subd. 5. **Registration renewal.** (a) A registration issued under this section expires one
8.5 year after the date of issuance and must be renewed to remain valid.

8.6 (b) To renew a registration, the transfer care specialist must submit a completed renewal
8.7 application as provided by the commissioner and the appropriate fees specified in section
8.8 149A.65. Every five years, the renewal application must include proof of completion of a
8.9 training program that meets the requirements in subdivision 4.

8.15 settlements, compliance agreements, licenses, registrations, and permits adopted, or issued

8.18 science.

12.23 employed by the funeral establishment to which the body was taken, the transfer care
12.24 specialist shall retain a copy of the certificate on file at the transfer care specialist's business
12.25 address as registered with the commissioner for a period of three calendar years following
12.26 the date of removal. Following this period, and subject to any other laws requiring retention
12.27 of records, the funeral establishment may then place the records in storage or reduce them
12.28 to microfilm, microfiche, laser disc, or any other method that can produce an accurate
12.29 reproduction of the original record, for retention for a period of ten calendar years from the
12.30 date of the removal of the body. At the end of this period and subject to any other laws
12.31 requiring retention of records, the funeral establishment may destroy the records by shredding,
12.32 incineration, or any other manner that protects the privacy of the individuals identified in

13.2 Subdivision 1. **Generally.** (a) Every dead human body lying within the state, except
13.3 unclaimed bodies delivered for dissection by the medical examiner, those delivered for
13.4 anatomical study pursuant to section 149A.81, subdivision 2, or lawfully carried through
13.5 the state for the purpose of disposition elsewhere; and the remains of any dead human body
13.6 after dissection or anatomical study, shall be decently buried or entombed in a public or
13.7 private cemetery, alkaline hydrolyzed, or cremated within a reasonable time after death.
13.8 Where final disposition of a body will not be accomplished within 72 hours following death
13.9 or release of the body by a competent authority with jurisdiction over the body, the body
13.10 must be properly embalmed, refrigerated, or packed with dry ice. A body may not be kept
13.11 in refrigeration for a period exceeding six calendar days, or packed in dry ice for a period
13.12 that exceeds four calendar days, from the time of death or release of the body from the
13.13 coroner or medical examiner. A body may be kept in refrigeration for up to 30 calendar
13.14 days from the time of death or release of the body from the coroner or medical examiner,
13.15 provided the dignity of the body is maintained and the funeral establishment complies with

14.2 \$219,000 in fiscal year 2023 is appropriated from the state government special revenue
14.3 fund to the commissioner of health for the regulation of transfer care specialists under
14.4 Minnesota Statutes, chapter 149A, and for additional reporting requirements under Minnesota
14.5 Statutes, section 149A.94. The state government special revenue fund base for this
