1.5	Section 1. FIRST CHILDREN'S FINANCE CHILD CARE SITE ASSISTANCE;
1.6	APPROPRIATION.
1.7	Subdivision 1. Appropriation. \$5,000,000 in fiscal year 2021 is appropriated from the
1.8	coronavirus relief federal fund to the commissioner of human services for a grant to First
1.9	Children's Finance to make loans to improve child care or early childhood education sites,
1.10	or loans to plan, design, and construct or expand licensed and legal unlicensed sites to
1.11	increase the availability of child care or early childhood education.
1.12	Subd. 2. Financing program. (a) First Children's Finance shall use the money to:
1.13	(1) establish a revolving loan fund to make loans to existing, expanding, and newly
1.14	licensed and legally unlicensed child care and early childhood education sites;
1.15	(2) establish a fund to guarantee private loans to improve or construct a child care or
1.16	early childhood education site;
