2.3 **STRENGTHENING VOTER REGISTRATION**

2.4 Section 1. Minnesota Statutes 2020, section 13.607, is amended by adding a subdivision  
2.5 to read:

2.6 Subd. 9. **Data derived from driver's license, Minnesota identification card, or**  
2.7 **learner's permit applications.** Data on an application for a driver's license, a Minnesota  
2.8 identification card, or a learner's permit transferred to the secretary of state that are provided  
2.9 by a person whom the secretary of state determines is not eligible to vote are governed by  
2.10 section 201.161.

2.11 Sec. 2. Minnesota Statutes 2020, section 135A.17, subdivision 2, is amended to read:

2.12 Subd. 2. **Residential housing list.** All postsecondary institutions that enroll students  
2.13 accepting ~~state or~~ federal financial aid may prepare a current list of students enrolled in the  
2.14 institution and residing in the institution's housing or within ten miles of the institution's  
2.15 campus. All postsecondary institutions that enroll students accepting state financial aid must  
2.16 prepare a current list of students enrolled in the institution and residing in the institution's  
2.17 housing or within ten miles of the institution's campus. The list shall include each student's  
2.18 current address, unless the student is enrolled in the Safe at Home address confidentiality  
2.19 program as provided in chapter 5B. The list shall be certified and sent to the appropriate  
2.20 county auditor or auditors for use in election day registration as provided under section  
2.21 201.061, subdivision 3. A residential housing list provided under this subdivision may not  
2.22 be used or disseminated by a county auditor or the secretary of state for any other purpose.

2.28 (3) when submitting an absentee ballot, by enclosing a completed registration application  
2.29 as provided in section 203B.04, subdivision 4.

3.1 (b) An individual who is under the age of 18, but who is at least 16 years of age and  
 3.2 otherwise eligible, may submit a voter registration application as provided in section 201.061,  
 3.3 subdivisions 1 and 1b.

3.5 Subd. 2. **Prohibitions; penalty.** No individual shall intentionally:

3.6 (1) cause or attempt to cause the individual's name to be registered in any precinct if the  
 3.7 individual is not eligible to vote, except as permitted by section 201.061, subdivision 1b;

3.8 (2) cause or attempt to cause the individual's name to be registered for the purpose of  
 3.9 voting in more than one precinct;

3.10 (3) misrepresent the individual's identity when attempting to register to vote; or

3.11 (4) aid, abet, counsel, or procure any other individual to violate this subdivision.

3.12 A violation of this subdivision is a felony.

3.13 Sec. 5. Minnesota Statutes 2020, section 201.061, subdivision 1, is amended to read:

3.14 Subdivision 1. **Prior to election day.** (a) At any time except during the 20 days  
 3.15 immediately preceding any regularly scheduled election, an eligible voter or any individual  
 3.16 who will be an eligible voter at the time of the next election may register to vote in the  
 3.17 precinct in which the voter maintains residence by completing a voter registration application  
 3.18 as described in section 201.071, subdivision 1. A completed application may be submitted:

3.19 (1) in person or by mail to the county auditor of that county or to the Secretary of State's  
 3.20 Office; or

3.21 (2) electronically through a secure website that shall be maintained by the secretary of  
 3.22 state for this purpose, if the applicant has an e-mail address and provides the applicant's

4.7 number. The secretary of state must review all unverifiable voter registration applications  
4.8 submitted electronically for evidence of suspicious activity and must forward any such  
4.9 application to an appropriate law enforcement agency for investigation.

4.11 of any other individual, except that the secretary of state may provide features on the secure  
4.12 website established under paragraph (a), clause (2), that allow third parties to connect  
4.13 application programming interfaces that facilitate an individual's submission of voter  
4.14 registration information while interacting with the third party.

4.16 application delivered to the secretary of state, county auditor, or municipal clerk by the  
4.17 United States Postal Service or a commercial carrier.

4.19 read:

4.20 Subd. 1b. **Preregistration.** An individual who is under the age of 18, but who is at least  
4.21 16 years of age and meets all requirements for eligibility in section 201.014, except for age,  
4.22 may submit a voter registration application or be automatically registered under section  
4.23 201.161 at the address in which the voter maintains residence pursuant to subdivision 1.  
4.24 Nothing in this section shall be construed to entitle an individual to appear on a polling  
4.25 place roster or cast a ballot at an election if the individual does not meet all eligibility  
4.26 requirements for voting, including age.

4.27 Sec. 7. Minnesota Statutes 2020, section 201.061, subdivision 3, is amended to read:

4.28 **Subd. 3. Election day registration.** (a) An individual who is eligible to vote may register  
4.29 on election day by appearing in person at the polling place for the precinct in which the  
4.30 individual maintains residence, by completing a registration application, making an oath in  
4.31 the form prescribed by the secretary of state and providing proof of residence. An individual  
4.32 may prove residence for purposes of registering by:

5.1 (1) presenting a driver's license, learner's permit, or Minnesota identification card issued  
5.2 pursuant to section 171.07, or a receipt for one of these documents that contains the voter's  
5.3 valid address in the precinct;

5.4 (2) presenting any document approved by the secretary of state as proper identification;

5.5 (3) having a valid registration in the same precinct;

5.6 (4) presenting a notice of late registration mailed by the county auditor or municipal  
5.7 clerk;

5.8 (5) presenting one of the following:

5.9 (i) a current valid student identification card from a postsecondary educational institution

5.17 facility, sign an oath in the presence of the election judge vouching that the voter or employee

5.19 vouched for on election day may not sign a proof of residence oath vouching for any other  
5.20 individual on that election day. A voter who is registered to vote in the precinct may sign

5.22 an employee of a residential facility described in this clause. The secretary of state shall  
5.23 provide a form for election judges to use in recording the number of individuals for whom  
5.24 a voter signs proof-of-residence oaths on election day. The form must include space for the  
5.25 maximum number of individuals for whom a voter may sign proof-of-residence oaths. For  
5.26 each proof-of-residence oath, the form must include a statement that the individual: (i) is  
5.27 registered to vote in the precinct or is an employee of a residential facility in the precinct,  
5.28 (ii) personally knows that the voter is a resident of the precinct, and (iii) is making the  
5.29 statement on oath. The form must include a space for the voter's printed name, signature,  
5.30 telephone number, and address.

5.31 (b) The oath required by this subdivision and Minnesota Rules, part 8200.9939, must  
5.32 be attached to the voter registration application.

6.1 ~~(b)~~ (c) The operator of a residential facility shall prepare a list of the names of its  
 6.2 employees currently working in the residential facility and the address of the residential  
 6.3 facility. The operator shall certify the list and provide it to the appropriate county auditor  
 6.4 no less than 20 days before each election for use in election day registration.

6.5 ~~(e)~~ (d) "Residential facility" means transitional housing as defined in section 256E.33,  
 6.6 subdivision 1; a supervised living facility licensed by the commissioner of health under  
 6.7 section 144.50, subdivision 6; a nursing home as defined in section 144A.01, subdivision  
 6.8 5; a residence registered with the commissioner of health as a housing with services  
 6.9 establishment as defined in section 144D.01, subdivision 4; a veterans home operated by  
 6.10 the board of directors of the Minnesota Veterans Homes under chapter 198; a residence  
 6.11 licensed by the commissioner of human services to provide a residential program as defined

 6.22 name, address, signature, and picture of the individual; or

6.23 (2) presenting an identification card issued by the tribal government of a tribe recognized

 6.25 name, signature, and picture of the individual and also presenting one of the documents

6.27 (f) An eligible voter who resides on a reservation but does not have a residential address  
 6.28 recognized by the United States Postal Service may register to vote using, as the voter's  
 6.29 residential address, the address of the tribal council headquarters or any other address  
 6.30 approved by the secretary of the tribal council.

6.31 ~~(e)~~ (g) A county, school district, or municipality may require that an election judge  
 6.32 responsible for election day registration initial each completed registration application.

7.1 Sec. 8. Minnesota Statutes 2020, section 201.061, is amended by adding a subdivision to  
7.2 read:

7.3 Subd. 3a. **Additional proofs of residence permitted with photo identification.** (a) An  
7.4 eligible voter may prove residence under this subdivision by presenting one of the photo  
7.5 identification cards listed in paragraph (b) and one of the additional proofs of residence  
7.6 listed in paragraph (c).

7.7 (b) The following documents are acceptable photo identification cards under this  
7.8 subdivision if the documents contain the voter's name and photograph:

7.9 (1) a driver's license, a learner's permit, or identification card, issued by the state of  
7.10 Minnesota or any other state of the United States as defined in Minnesota Statutes, section  
7.11 645.44, subdivision 11;

7.12 (2) a United States passport;

7.13 (3) a United States military or veteran identification card;

7.14 (4) a student identification card issued by a Minnesota secondary or postsecondary  
7.15 educational institution; or

7.16 (5) a tribal identification card issued by the tribal government of a tribe recognized by  
7.17 the Bureau of Indian Affairs, United States Department of the Interior, that contains the  
7.18 individual's signature.

7.19 (c) The following documents are acceptable additional proofs of residence under this  
7.20 subdivision if the documents show the voter's name and current address in the precinct:

7.21 (1) an original bill, including account statements and start-of-service notification, for  
7.22 telephone, television, or Internet provider services, regardless of how those telephone,  
7.23 television, or Internet provider services are delivered; gas, electric, solid waste, water, or  
7.24 sewer services; credit card or banking services; or rent or mortgage payments. The due date  
7.25 on the bill must be within 30 days before or after election day or, for bills without a due  
7.26 date, dated within 30 days before election day. For bills delivered electronically, "original"  
7.27 means a printed copy of the electronic bill or a display of the bill on the voter's portable  
7.28 electronic device;

7.29 (2) a current student fee statement that contains the student's valid address in the precinct;  
7.30 or

7.31 (3) a residential lease or residential rental agreement if the lease or rental agreement is  
7.32 valid through election day.

8.1 Sec. 9. Minnesota Statutes 2020, section 201.061, is amended by adding a subdivision to  
8.2 read:

8.3 Subd. 3b. **Additional proofs of residence permitted for students.** (a) An eligible voter  
8.4 may prove residence by presenting a current valid photo identification issued by a  
8.5 postsecondary educational institution in Minnesota if the voter's name; student identification  
8.6 number, if available; and address within the precinct appear on a current residential housing  
8.7 list under section 135A.17, certified to the county auditor by the postsecondary educational  
8.8 institution.

8.9 (b) This additional proof of residence for students must not be allowed unless the  
8.10 postsecondary educational institution submits to the county auditor no later than 60 days  
8.11 prior to the election a written agreement that the postsecondary educational institution will  
8.12 certify for use at the election accurate updated residential housing lists under section 135A.17.  
8.13 A written agreement is effective for the election and all subsequent elections held in that  
8.14 calendar year, including the November general election.

8.15 (c) The additional proof of residence for students must be allowed on an equal basis for  
8.16 voters who reside in housing meeting the requirements of section 135A.17, if the residential  
8.17 housing lists certified by the postsecondary educational institution meet the requirements  
8.18 of this subdivision.

8.19 (d) An updated residential housing list must be certified to the county auditor no earlier  
8.20 than 20 days prior to each election. The certification must be dated and signed by the chief  
8.21 officer or designee of the postsecondary educational institution and must state that the list  
8.22 is current and accurate and includes only the names of persons residing as of the date of the  
8.23 certification.

8.24 (e) The county auditor shall instruct the election judges of the precinct in procedures for  
8.25 use of the list in conjunction with photo identification. The auditor shall supply a list to the  
8.26 election judges with the election supplies for the precinct.

8.27 (f) The county auditor shall notify all postsecondary educational institutions in the county  
8.28 of the provisions of this subdivision.

8.29 Sec. 10. Minnesota Statutes 2020, section 201.071, subdivision 1, is amended to read:

8.30 Subdivision 1. **Form.** Both paper and electronic voter registration applications must  
8.31 contain the same information unless otherwise provided by law. A voter registration  
8.32 application must contain spaces for the following required information: voter's first name,  
8.33 middle name, and last name; voter's previous name, if any; voter's current address; voter's



9.1 previous address, if any; voter's date of birth; voter's municipality and county of residence;  
 9.2 voter's telephone number, if provided by the voter; date of registration; current and valid  
 9.3 Minnesota driver's license number or Minnesota state identification number, or if the voter  
 9.4 has no current and valid Minnesota driver's license or Minnesota state identification, the  
 9.5 last four digits of the voter's Social Security number; a box to indicate a voter's preference  
 9.6 to join the permanent absentee voter list; and voter's signature. The paper registration  
 9.7 application may include the voter's e-mail address, if provided by the voter. The electronic  
 9.8 voter registration application must include the voter's e-mail address. The registration  
 9.9 application may include the voter's interest in serving as an election judge, if indicated by  
 9.10 the voter. The application must also contain the following certification of voter eligibility:

9.11 "I certify that I:

9.12 (1) ~~will be at least 18 years old on election day~~ am at least 16 years old and understand  
 9.13 that I must be at least 18 years old to be eligible to vote;

9.14 (2) am a citizen of the United States;

9.15 (3) will have resided in Minnesota for 20 days immediately preceding election day;

9.16 (4) maintain residence at the address given on the registration form;

9.17 (5) am not under court-ordered guardianship in which the court order revokes my right  
 9.18 to vote;

9.19 (6) have not been found by a court to be legally incompetent to vote;

9.20 (7) have the right to vote because, if I have been convicted of a felony, my felony sentence  
 9.21 has expired (been completed) or I have been discharged from my sentence; and

9.22 (8) have read and understand the following statement: that giving false information is a  
 9.23 felony punishable by not more than five years imprisonment or a fine of not more than  
 9.24 \$10,000, or both."

9.25 The certification must include boxes for the voter to respond to the following questions:

9.26 "(1) Are you a citizen of the United States?" and

9.27 "(2) ~~Will you be 18 years old on or before election day~~ Are you at least 16 years old and  
 9.28 will you be at least 18 years old on or before the day of the election in which you intend to  
 9.29 vote?"

9.30 And the instruction:

9.31 "If you checked 'no' to either of these questions, do not complete this form."

10.1 The form of the voter registration application and the certification of voter eligibility  
10.2 must be as provided in this subdivision and approved by the secretary of state. Voter  
10.3 registration forms authorized by the National Voter Registration Act must also be accepted  
10.4 as valid. The federal postcard application form must also be accepted as valid if it is not  
10.5 deficient and the voter is eligible to register in Minnesota.

10.6 An individual may use a voter registration application to apply to register to vote in  
10.7 Minnesota or to change information on an existing registration.

10.8 Sec. 11. Minnesota Statutes 2020, section 201.091, subdivision 4, is amended to read:

10.9 Subd. 4. **Public information lists.** The county auditor shall make available for inspection  
10.10 a public information list which must contain the name, address, year of birth, and voting  
10.11 history of each registered voter in the county. Data on applicants submitted pursuant to  
10.12 section 201.061, subdivision 1b, are not part of the public information list until the voter is  
10.13 registered or has voting history. The list must not include the party choice of any voter who  
10.14 voted in a presidential nomination primary. The telephone number must be included on the  
10.15 list if provided by the voter. The public information list may also include information on  
10.16 voting districts. The county auditor may adopt reasonable rules governing access to the list.  
10.17 No individual inspecting the public information list shall tamper with or alter it in any  
10.18 manner. No individual who inspects the public information list or who acquires a list of  
10.19 registered voters prepared from the public information list may use any information contained  
10.20 in the list for purposes unrelated to elections, political activities, or law enforcement. The  
10.21 secretary of state may provide copies of the public information lists and other information  
10.22 from the statewide registration system for uses related to elections, political activities, or  
10.23 in response to a law enforcement inquiry from a public official concerning a failure to  
10.24 comply with any criminal statute or any state or local tax statute.

10.25 Before inspecting the public information list or obtaining a list of voters or other  
10.26 information from the list, the individual shall provide identification to the public official  
10.27 having custody of the public information list and shall state in writing that any information  
10.28 obtained from the list will not be used for purposes unrelated to elections, political activities,  
10.29 or law enforcement. Requests to examine or obtain information from the public information  
10.30 lists or the statewide registration system must be made and processed in the manner provided  
10.31 in the rules of the secretary of state.

10.32 Upon receipt of a statement signed by the voter that withholding the voter's name from  
10.33 the public information list is required for the safety of the voter or the voter's family, the

62.19 Subdivision 1. **Application.** The principles in this section apply to congressional and  
 62.20 legislative districts.

62.21 Subd. 2. **Prohibited information.** No plan shall be drawn to purposefully favor or  
 62.22 disfavor a political party or candidate.

62.23 Subd. 3. **Priority of principles.** A redistricting plan must adhere to the principles in  
 62.24 subdivisions 4 to 12. Where it is not possible to fully comply with the principles contained  
 62.25 below, a plan shall give priority to those principles in the order in which they are listed,  
 62.26 except to the extent that doing so would violate federal or state law.

62.27 Subd. 4. **Population equality.** (a) Congressional districts must be as nearly equal in  
 62.28 population as practicable.

62.29 (b) Legislative districts must be substantially equal in population. The population of a  
 62.30 legislative district must not deviate from the ideal by more than one percent.

63.1 Subd. 5. **Contiguity.** The districts must be contiguous allowing for easy travel throughout  
63.2 the district. Contiguity by water is sufficient if the water is not a serious obstacle to travel  
63.3 within the district. Districts with areas that touch only at a point are not contiguous.

63.4 Subd. 6. **Minority representation.** (a) Each district must be drawn in compliance with  
63.5 all state and federal laws. A district must not be drawn with either the purpose or effect of  
63.6 diluting, denying, or abridging the right of any citizen of the United States to vote on account  
63.7 of race, ethnicity, or membership in a language minority group, whether by themselves or  
63.8 when voting in concert with other people.

63.9 (b) Racial, ethnic, and language minorities must have an equal opportunity to participate  
63.10 in the political process and elect candidates of their choice. Racial, ethnic, and language  
63.11 minorities who constitute less than a voting-age majority of a district must have an

63.13 Subd. 7. **Communities of interest.** District boundaries shall recognize communities of  
63.14 interest. A community of interest is a contiguous population sharing common social and  
63.15 economic interests that should be included within a single district for purposes of the  
63.16 community's effective and fair representation. Communities of interest include but are not  
63.17 limited to geographic areas where there are clearly recognizable similarities of social,  
63.18 cultural, ethnic, economic, or other interests. Examples of shared interests are those common  
63.19 to an urban area, rural area, industrial area, or agricultural area and those common to areas  
63.20 in which the people share similar living standards, have similar work opportunities, or have  
63.21 access to the same media of communication relevant to the election process. Communities  
63.22 of interest shall not include relationships with political parties, incumbents, or political

63.24 Subd. 8. **Political subdivisions.** Counties, cities, and municipalities should be preserved  
63.25 to the greatest extent possible and in compliance with the other principles to preserve rather  
63.26 than divide them among multiple districts.

63.27 Subd. 9. **Incumbents.** The residence of incumbents shall not be taken into consideration  
63.28 in the development or adoption of a proposed plan.

63.29 Subd. 10. **Compactness.** Districts must be compact. Compactness must be measured  
63.30 by using one or more statistical tests.

63.31 Subd. 11. **Partisan symmetry and bias.** A district must not be drawn in a manner that  
63.32 unduly favors or disfavors any political party. Applicable judicial standards and the best  
63.33 available scientific and statistical methods must be used to assess whether a plan unduly  
63.34 favors or disfavors a political party.

64.1 Subd. 12. **Numbering.** (a) Congressional district numbers must begin with district one  
64.2 in the southeast corner of the state and end with the district with the highest number in the

64.5 district 1A in the northwest corner of the state and proceeding across the state from west to

65.32 (1) conduct at least one public hearing in each existing congressional district to solicit

66.13 data used to develop a plan.

66.14 (b) This subdivision does not require disclosure of data or communications protected

66.16 staff regarding confidential bill drafting or other legislative services unless further directed  
66.17 by the committee on rules and legislative administration of the house or the committee on  
66.18 rules and administration of the senate.

**10A.31 DESIGNATION OF INCOME TAX PAYMENTS.**

Subd. 5. **Allocation.** (a) **General account.** In each calendar year the money in the general account must be allocated to candidates as follows:

- (1) 21 percent for the offices of governor and lieutenant governor together;
- (2) 4.2 percent for the office of attorney general;
- (3) 2.4 percent each for the offices of secretary of state and state auditor;
- (4) in each calendar year during the period in which state senators serve a four-year term, 23-1/3 percent for the office of state senator, and 46-2/3 percent for the office of state representative; and
- (5) in each calendar year during the period in which state senators serve a two-year term, 35 percent each for the offices of state senator and state representative.

(b) **Party account.** In each calendar year the money in each party account must be allocated as follows:

- (1) 14 percent for the offices of governor and lieutenant governor together;
- (2) 2.8 percent for the office of attorney general;
- (3) 1.6 percent each for the offices of secretary of state and state auditor;
- (4) in each calendar year during the period in which state senators serve a four-year term, 23-1/3 percent for the office of state senator, and 46-2/3 percent for the office of state representative;
- (5) in each calendar year during the period in which state senators serve a two-year term, 35 percent each for the offices of state senator and state representative; and
- (6) ten percent or \$50,000, whichever is less, for the state committee of a political party; one-third of any amount in excess of that allocated to the state committee of a political party under this clause must be allocated to the office of state senator and two-thirds must be allocated to the office of state representative under clause (4).

Money allocated to each state committee under clause (6) must be deposited in a separate account and must be spent for only those items enumerated in section 10A.275. Money allocated to a state committee under clause (6) must be paid to the committee by the board as it is received in the account on a monthly basis, with payment on the 15th day of the calendar month following the month in which the returns were processed by the Department of Revenue, provided that these distributions would be equal to 90 percent of the amount of money indicated in the Department of Revenue's weekly unedited reports of income tax returns and property tax refund returns processed in the month, as notified by the Department of Revenue to the board. The amounts paid to each state committee are subject to biennial adjustment and settlement at the time of each certification required of the commissioner of revenue under subdivisions 7 and 10. If the total amount of payments received by a state committee for the period reflected on a certification by the Department of Revenue is different from the amount that should have been received during the period according to the certification, each subsequent monthly payment must be increased or decreased to the fullest extent possible until the amount of the overpayment is recovered or the underpayment is distributed.

Subd. 5a. **Party account for legislative candidates.** To ensure that money will be returned to the counties from which it was collected and to ensure that the distribution of money rationally relates to the support for particular parties or for particular candidates within legislative districts, money from the party accounts for legislative candidates must be distributed as provided in this subdivision.

Each candidate for the state senate and state house of representatives whose name is to appear on the ballot in the general election must receive money from the candidate's party account allocated to candidates for the state senate or state house of representatives, whichever applies, according to the following formula:

For each county within the candidate's district, the candidate's share of the dollars designated by taxpayers who resided in that county and credited to the candidate's party account and allocated to that office must be:

- (1) the sum of the votes cast in the last general election in that part of the county in the candidate's district for all candidates of that candidate's party whose names appeared on the ballot statewide and for the state senate and state house of representatives, divided by

(2) the sum of the votes cast in the entire county in the last general election for all candidates of that candidate's party whose names appeared on the ballot statewide and for the state senate and state house of representatives, multiplied by

(3) the amount in the candidate's party account designated by taxpayers who resided in that county and allocated to that office.

The sum of all the county shares calculated in the formula above is the candidate's share of the candidate's party account.

In a year in which an election for the state senate occurs, with respect to votes for candidates for the state senate only, "last general election" means the last general election in which an election for the state senate occurred.

For a party under whose name no candidate's name appeared on the ballot statewide in the last general election, amounts in the party's account must be allocated based on (i) the number of people voting in the last general election in that part of the county in the candidate's district, divided by (ii) the number of the people voting in the entire county in the last general election, multiplied by (iii) the amount in the candidate's party account designated by taxpayers who resided in that county and allocated to that office.

In the first general election after the legislature is redistricted, "the candidate's district" means the newly drawn district and voting data from the last general election must be applied to the area encompassing the newly drawn district, notwithstanding that the area was in a different district in the last general election.

If in a district there was no candidate of a party for the state senate or state house of representatives in the last general election, or if a candidate for the state senate or state house of representatives was unopposed, the vote for that office for that party is the average vote of all the remaining candidates of that party in each county of that district whose votes are included in the sums in clauses (1) and (2). The average vote must be added to the sums in clauses (1) and (2) before the calculation is made for all districts in the county.

**Subd. 6. Distribution of party accounts.** As soon as the board has obtained from the secretary of state the results of the primary election, but no later than one week after certification by the State Canvassing Board of the results of the primary, the board must distribute the available money in each party account, as certified by the commissioner of revenue one week before the state primary, to the candidates of that party who have signed a spending limit agreement under section 10A.322 and filed the affidavit of contributions required by section 10A.323, who were opposed in either the primary election or the general election, and whose names are to appear on the ballot in the general election, according to the allocations set forth in subdivisions 5 and 5a. The public subsidy from the party account may not be paid in an amount greater than the expenditure limit of the candidate or the expenditure limit that would have applied to the candidate if the candidate had not been freed from expenditure limits under section 10A.25, subdivision 10.

**Subd. 6a. Party account money not distributed.** Money from a party account not distributed to candidates for state senator or representative in any election year must be returned to the general fund of the state, except that the subsidy from the party account an unopposed candidate would otherwise have been eligible to receive must be paid to the state committee of the candidate's political party to be deposited in a special account under subdivision 5, paragraph (b), clause (6), and used for only those items permitted under section 10A.275. Money from a party account not distributed to candidates for other offices in an election year must be returned to the party account for reallocation to candidates as provided in subdivision 5, paragraph (b), in the following year.

**Subd. 7. Distribution of general account.** (a) As soon as the board has obtained the results of the primary election from the secretary of state, but no later than one week after certification of the primary results by the State Canvassing Board, the board must distribute the available money in the general account, as certified by the commissioner of revenue one week before the state primary and according to allocations set forth in subdivision 5, in equal amounts to all candidates of a major political party whose names are to appear on the ballot in the general election and who:

- (1) have signed a spending limit agreement under section 10A.322;
- (2) have filed the affidavit of contributions required by section 10A.323; and
- (3) were opposed in either the primary election or the general election.

(b) The public subsidy under this subdivision may not be paid in an amount that would cause the sum of the public subsidy paid from the party account plus the public subsidy paid from the

general account to exceed 50 percent of the expenditure limit for the candidate or 50 percent of the expenditure limit that would have applied to the candidate if the candidate had not been freed from expenditure limits under section 10A.25, subdivision 10. Money from the general account not paid to a candidate because of the 50 percent limit must be distributed equally among all other qualifying candidates for the same office until all have reached the 50 percent limit or the balance in the general account is exhausted.

Subd. 7a. **Withholding of public subsidy.** If a candidate who is eligible for payment of public subsidy under this section has not filed the report of receipts and expenditures required under section 10A.20 before a primary election, any public subsidy for which that candidate is eligible must be withheld by the board until the candidate complies with the filing requirements of section 10A.20 and the board has sufficient time to review or audit the report. If a candidate who is eligible for public subsidy does not file the report due before the primary election under section 10A.20 by the date that the report of receipts and expenditures filed before the general election is due, that candidate shall not be paid public subsidy for that election.

Subd. 7b. **Failure to repay.** A candidate who fails to repay money required by the agreement cannot be paid additional public subsidy funds during the current or future election cycles until the entirety of the unexpended funds and any associated collection fees are either repaid to the board or discharged by court action.

Subd. 10. **December distribution.** In the event that on the date of either certification by the commissioner of revenue as provided in subdivision 6 or 7, less than 98 percent of the tax returns have been processed, the commissioner of revenue must certify to the board by December 1 the amount accumulated in each account since the previous certification. By December 15, the board must distribute to each candidate according to the allocations in subdivisions 5 and 5a the amounts to which the candidates are entitled.

Subd. 11. **Write-in candidate.** For the purposes of this section, a write-in candidate is a candidate only upon complying with sections 10A.322 and 10A.323.

#### **10A.315 SPECIAL ELECTION SUBSIDY.**

(a) Each eligible candidate for a legislative office in a special election must be paid a public subsidy equal to the sum of:

(1) the party account money at the last general election for the candidate's party for the office the candidate is seeking; and

(2) the general account money paid to a candidate for the same office at the last general election.

(b) A candidate who wishes to receive this public subsidy must submit a signed agreement under section 10A.322 to the board and must meet the contribution requirements of section 10A.323. The special election subsidy must be distributed in the same manner as money in the party and general accounts is distributed to legislative candidates in a general election.

(c) The amount necessary to make the payments required by this section is appropriated from the general fund for transfer to the state special elections campaign account for distribution by the board as set forth in this section.

#### **10A.321 ESTIMATES OF MINIMUM AMOUNTS TO BE RECEIVED.**

Subdivision 1. **Calculation and certification of estimates.** The commissioner of revenue must calculate and certify to the board one week before the first day for filing for office in each election year an estimate of the total amount in the state general account of the state elections campaign account and the amount of money each candidate who qualifies, as provided in section 10A.31, subdivisions 6 and 7, may receive from the candidate's party account in the state elections campaign account. This estimate must be based upon the allocations and formulas in section 10A.31, subdivisions 5 and 5a, any necessary vote totals provided by the secretary of state to apply the formulas in section 10A.31, subdivisions 5 and 5a, and the amount of money expected to be available after 100 percent of the tax returns have been processed.

Subd. 2. **Publication, certification, and notification procedures.** Before the first day of filing for office, the board must publish and forward to all filing officers the estimates calculated and certified under subdivision 1 along with a copy of section 10A.25, subdivision 10. Within one week after the last day for filing for office, the secretary of state must certify to the board the name, address, office sought, and party affiliation of each candidate who has filed with that office an affidavit of candidacy or petition to appear on the ballot. The auditor of each county must certify to the board the same information for each candidate who has filed with that county an affidavit of

candidacy or petition to appear on the ballot. Within two weeks after the last day for filing for office, the board must notify all candidates of their estimated minimum amount. The board must include with the notice a form for the agreement provided in section 10A.322 along with a copy of section 10A.25, subdivision 10.

**10A.322 SPENDING LIMIT AGREEMENTS.**

Subd. 4. **Refund receipt forms; penalty.** (a) The board must make available to a political party on request and to any candidate for whom an agreement under this section is effective, a supply of official refund receipt forms that state in boldface type that:

(1) a contributor who is given a receipt form is eligible to claim a refund as provided in section 290.06, subdivision 23; and

(2) if the contribution is to a candidate, that the candidate has signed an agreement to limit campaign expenditures as provided in this section.

The forms must provide duplicate copies of the receipt to be attached to the contributor's claim.

(b) The willful issuance of an official refund receipt form or a facsimile of one to any of the candidate's contributors by a candidate or treasurer of a candidate who did not sign an agreement under this section is subject to a civil penalty of up to \$3,000 imposed by the board.

(c) The willful issuance of an official refund receipt form or a facsimile to an individual not eligible to claim a refund under section 290.06, subdivision 23, is subject to a civil penalty of up to \$3,000 imposed by the board.

(d) A violation of paragraph (b) or (c) is a misdemeanor.

**10A.324 RETURN OF PUBLIC SUBSIDY.**

Subdivision 1. **When return required.** A candidate must return all or a portion of the public subsidy received from the state elections campaign account or the public subsidy received under section 10A.315, under the circumstances in this section or section 10A.257, subdivision 1.

To the extent that the amount of public subsidy received exceeds the aggregate of: (1) actual expenditures made by the principal campaign committee of the candidate; and (2) approved expenditures made on behalf of the candidate, the treasurer of the candidate's principal campaign committee must return an amount equal to the difference to the board. The cost of postage that was not used during an election cycle and payments that created credit balances at vendors at the close of an election cycle are not considered expenditures for purposes of determining the amount to be returned. Expenditures in excess of the candidate's spending limit do not count in determining aggregate expenditures under this paragraph.

Subd. 3. **How return determined.** Whether or not a candidate is required under subdivision 1 to return all or a portion of the public subsidy must be determined from the report required to be filed with the board by that candidate by January 31 of the year following an election. An amount required to be returned must be submitted in the form of a check or money order and must accompany the report filed with the board. The board must deposit the check or money order in the state treasury for credit to the general fund. The amount returned must not exceed the amount of public subsidy received by the candidate.

**13.4967 OTHER TAX DATA CODED ELSEWHERE.**

Subd. 2. **Political contribution refund.** Certain political contribution refund data in the Revenue Department are classified under section 290.06, subdivision 23.

**203B.081 LOCATIONS AND METHODS FOR ABSENTEE VOTING IN PERSON.**

Subd. 3. **Alternative procedure.** (a) The county auditor may make available a ballot counter and ballot box for use by the voters during the seven days before the election. If a ballot counter and ballot box is provided, a voter must be given the option either (1) to vote using the process provided in section 203B.08, subdivision 1, or (2) to vote in the manner provided in this subdivision.

(b) If a voter chooses to vote in the manner provided in this subdivision, the voter must state the voter's name, address, and date of birth to the county auditor or municipal clerk. The voter shall sign a voter's certificate, which must include the voter's name, identification number, and the certification required by section 201.071, subdivision 1. The signature of an individual on the voter's certificate and the issuance of a ballot to the individual is evidence of the intent of the individual to vote at that election.

(c) After signing the voter's certificate, the voter shall be issued a ballot and immediately retire to a voting station or other designated location in the polling place to mark the ballot. The ballot must not be taken from the polling place. If the voter spoils the ballot, the voter may return it to the election official in exchange for a new ballot. After completing the ballot, the voter shall deposit the ballot into the ballot box.

(d) The election official must immediately record that the voter has voted in the manner provided in section 203B.121, subdivision 3.

(e) The election duties required by this subdivision must be performed by the county auditor, municipal clerk, or a deputy of the auditor or clerk.

**290.06 RATES OF TAX; CREDITS.**

Subd. 23. **Refund of contributions to political parties and candidates.** (a) A taxpayer may claim a refund equal to the amount of the taxpayer's contributions made in the calendar year to candidates and to a political party. The maximum refund for an individual must not exceed \$50 and for a married couple, filing jointly, must not exceed \$100. A refund of a contribution is allowed only if the taxpayer files a form required by the commissioner and attaches to the form a copy of an official refund receipt form issued by the candidate or party and signed by the candidate, the treasurer of the candidate's principal campaign committee, or the chair or treasurer of the party unit, after the contribution was received. The receipt forms must be numbered, and the data on the receipt that are not public must be made available to the campaign finance and public disclosure board upon its request. A claim must be filed with the commissioner no sooner than January 1 of the calendar year in which the contribution was made and no later than April 15 of the calendar year following the calendar year in which the contribution was made. A taxpayer may file only one claim per calendar year. Amounts paid by the commissioner after June 15 of the calendar year following the calendar year in which the contribution was made must include interest at the rate specified in section 270C.405.

(b) No refund is allowed under this subdivision for a contribution to a candidate unless the candidate:

- (1) has signed an agreement to limit campaign expenditures as provided in section 10A.322;
- (2) is seeking an office for which voluntary spending limits are specified in section 10A.25; and
- (3) has designated a principal campaign committee.

This subdivision does not limit the campaign expenditures of a candidate who does not sign an agreement but accepts a contribution for which the contributor improperly claims a refund.

(c) For purposes of this subdivision, "political party" means a major political party as defined in section 200.02, subdivision 7, or a minor political party qualifying for inclusion on the income tax or property tax refund form under section 10A.31, subdivision 3a.

A "major party" or "minor party" includes the aggregate of that party's organization within each house of the legislature, the state party organization, and the party organization within congressional districts, counties, legislative districts, municipalities, and precincts.

"Candidate" means a candidate as defined in section 10A.01, subdivision 10, except a candidate for judicial office.

"Contribution" means a gift of money.

(d) The commissioner shall make copies of the form available to the public and candidates upon request.

(e) The following data collected or maintained by the commissioner under this subdivision are private: the identities of individuals claiming a refund, the identities of candidates to whom those individuals have made contributions, and the amount of each contribution.

(f) The commissioner shall report to the campaign finance and public disclosure board by each August 1 a summary showing the total number and aggregate amount of political contribution refunds made on behalf of each candidate and each political party. These data are public.

(g) The amount necessary to pay claims for the refund provided in this section is appropriated from the general fund to the commissioner of revenue.

(h) For a taxpayer who files a claim for refund via the Internet or other electronic means, the commissioner may accept the number on the official receipt as documentation that a contribution was made rather than the actual receipt as required by paragraph (a).
