1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2016, section 103B.101, subdivision 12a, is amended to
1.8	read:
1.9	Subd. 12a. Authority to issue penalty orders. (a) A county or watershed district with
1.10	jurisdiction or The Board of Water and Soil Resources may issue an order requiring violations
1.11	of the water resources riparian protection requirements under sections 103F.415, 103F.421,
1.12	and 103F.48 to be corrected and administratively assessing monetary penalties up to \$500
1.13	for noncompliance commencing on day one of the 11th month after the noncompliance
1.14	notice was issued. The proceeds collected from an administrative penalty order issued under
1.15	this section must be remitted to the county or watershed district with jurisdiction over the
1.16	noncompliant site, or otherwise remitted to the Board of Water and Soil Resources.
1.17	(b) Before exercising this authority, the Board of Water and Soil Resources must adopt
1.18	a plan containing procedures for the issuance of administrative penalty orders by local
1.19	governments and the board as authorized in this subdivision. This plan, and any subsequent
1.20	amendments, will become effective 30 days after being published in the State Register. The
1.21	initial plan must be published in the State Register no later than July 1, 2017.

Sec. 4. Minnesota Statutes 2016, section 103F.48, subdivision 3, is amended to read: 3.1 Subd. 3. Water resources riparian protection requirements on public waters and 32 public drainage systems. (a) Except as provided in paragraph (b), landowners owning 3.3 property adjacent to a water body identified and mapped on a buffer protection map must 3.4 3.5 maintain a buffer to protect the state's water resources as follows: (1) for all public waters that have a shoreland classification, the more restrictive of:

(i) a 50-foot average width, 30-foot minimum width, continuous buffer of perennially 3.7 rooted vegetation; or 3.8

(ii) the state shoreland standards and criteria adopted by the commissioner under section 3.9 103F.211; and 3.10

(2) for public drainage systems established under chapter 103E and public waters that 3.11 do not have a shoreland classification, a 16.5-foot minimum width continuous buffer as 3.12 provided in section 103E.021, subdivision 1. The buffer vegetation shall not impede future 3.13 maintenance of the ditch. 3.14

(b) A landowner owning property adjacent to a water body identified in a buffer protection 3.15 map and whose property is used for cultivation farming may meet the requirements under 3.16 paragraph (a) by adopting an alternative riparian water quality practice, or combination of 3.17 structural, vegetative, and management practices, based on the Natural Resources 3.18 Conservation Service Field Office Technical Guide or other practices approved by the board, 3.19 that provide water quality protection comparable to the buffer protection for the water body 3.20 that the property abuts. Included in these practices are retention ponds and alternative 3 21 measures that prevent overland flow to the water resource. 3 22

(c) The width of a buffer on public waters must be measured from the top or crown of 3.23 the bank. Where there is no defined bank, measurement must be from the edge of the normal 3.24 water level. The width of the buffer on public drainage systems must be measured as provided 3.25 in section 103E.021, subdivision 1. 3.26

3.27 (d) Upon request by a landowner or authorized agent or operator of a landowner, a technical professional employee or contractor of the soil and water conservation district or 3 28 its delegate may issue a validation of compliance with the requirements of this subdivision. 3.29 The soil and water conservation district validation may be appealed to the board as described 3.30 in subdivision 9. 3.31

(e) Buffers or alternative water quality practices required under paragraph (a) or (b) 3.32 must be in place on or before: 3.33
