1.1 A bill for an act
1.2 relating to education; renumbering statutes for intermediate school districts;
1.3 amending Minnesota Statutes 2018, sections 136D.01; 136D.49; repealing
1.4 Minnesota Statutes 2018, section 136D.93.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2018, section 136D.01, is amended to read:

1.7 136D.01 INTERMEDIATE SCHOOL DISTRICT.

1.8 "Intermediate school district" means a district with a cooperative program which has
1.9 been established under Laws 1967, chapter 822, as amended; Laws 1969, chapter 775, as
1.10 amended; and Laws 1969, chapter 1060, as amended this chapter, offering integrated services
1.11 for secondary, postsecondary, and adult students in the areas of vocational education, special
1.12 education, and other authorized services.

1.13 Sec. 2. Minnesota Statutes 2018, section 136D.49, is amended to read:

1.14 136D.49 OTHER MEMBERSHIP AND POWERS.

1.15 In addition to the districts listed in sections 136D.21, 136D.41, 136D.71, and 136D.81,
1.16 the agreement of an intermediate school district established under this chapter may provide
1.17 for the membership of other school districts and cities, counties, and other governmental
1.18 units as defined in section 471.59. In addition to the powers listed in sections 136D.25,
1.19 136D.24, 136D.44, 136D.73, and 136D.84, an intermediate school board may provide the
1.20 services defined in section 123A.21, subdivisions 7 and 8.

3.8 (b) The revisor of statutes shall make necessary cross-reference changes in Minnesota
 3.9 Statutes consistent with the renumbering in this section, and if Minnesota Statutes, chapter
 3.10 136D, is further amended in the 2019 legislative session, shall codify the amendments in a
 3.11 manner consistent with this act. The revisor may make necessary changes to sentence
 3.12 structure to preserve the meaning of the text.

3.13 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.15 Minnesota Statutes 2018, section 136D.93, is repealed.
