1.9	(b) "Health plan company" has the meaning given in section 62Q.01, subdivision 4, but
1.10	also includes a county-based purchasing plan participating in a public program under chapter
1.11	256B or 256L, and in integrated health partnership under section 256B.0755.

2.1	(1) is not routinely made available to enrollees of a health plan company or its contracted
2.2	pharmacy benefit manager through dispensing by a retail pharmacy, regardless if the drug
2.3	is meant to be self-administered;
2.4	(2) must usually be obtained from specialty or mail order pharmacies; and

2.7	Subd. 2. Prompt filling of specialty drug prescriptions. A health plan company or its
2.8	contracted pharmacy benefit manager that requires or provides financial incentives for
2.9	enrollees to use a mail order pharmacy to fill a prescription for a specialty drug must ensure
2.10	through contract and other means that the mail order pharmacy dispenses the prescription
2.11	drug to the enrollee in a timely manner, such that the enrollee receives the filled prescription

2.18	necessary, shall provide the enrollee with an emergency supply of the specialty drug.
