1.5	Section 1. WOLF-LIVESTOCK CONFLICT PREVENTION PROGRAM.
1.6	(a) The commissioner of agriculture may award grants to livestock producers to prevent
1.7	wolf-livestock conflicts. Livestock producers located in Minnesota are eligible to apply for
1.8	reimbursement for the cost of practices to prevent wolf-livestock conflicts. The commissioner
1.9	may establish a cap on the amount of grant money that a recipient is eligible to receive
1.10	annually.
1.11	(b) To be eligible for a grant under this section, a livestock producer must raise livestock
1.12	within Minnesota's wolf range or on property determined by the commissioner to be affected
1.13	by wolf-livestock conflicts.
1.14	(c) A grant applicant must document a cost-share of 20 percent for activities covered
1.15	by a grant under this program. A grant applicant's cost-share amount may be reduced up to
1.16	\$2,000 to cover the time and labor costs of wolf-livestock conflict prevention activities.
