1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. [415.20] MUNICIPAL IDS.
1.6	Subdivision 1. Definitions. (a) The terms defined in this subdivision apply to this section.
1.7	(b) "Municipal ID" means a photographic identification card in physical or electronic
1.8	form created and provided by a municipality to a resident of the municipality that includes
1.9	the individual's name, date of birth, and residential address, and any other identifying
1.10	information as required or authorized by the municipal ordinance.
1.11	(c) "Municipality" means a home rule charter or statutory city.
1.12	(d) "Resident" means a person who resides within the municipality's corporate boundaries
1.13	for a minimum of 30 continuous days immediately prior to application for a municipal ID
1.14	and who submits documentation demonstrating identity and residency as required in this
1.15	section.
1.16	Subd. 2. Ordinance authorized. A municipality may adopt an ordinance to provide for
1.17	municipal IDs. The ordinance must require an applicant for a municipal ID to submit
1.18	documentation of identity and residency using only the documents listed in this section.
1.19	Subd. 3. Issuance. (a) A municipality that has adopted a municipal ID ordinance may
1.20	issue a municipal ID to any resident who satisfies the application requirements in the
1.21	ordinance, which may include payment of any applicable fee.

2.1	(b) A municipal ID expires four years from the date of issuance. An ordinance may
2.2	require surrender of an expired municipal ID or surrender of a municipal ID when the ID
2.3	holder is no longer a resident.
2.4	(c) A municipal ID must be produced in a form to prevent unauthorized replication,
2.5	alteration, or counterfeiting.
2.6	Subd. 4. Requirements for proof of identity and residency. (a) An applicant for a
2.7	municipal ID must demonstrate identity and residency by submitting one or more of the
2.8	documents listed in subdivisions 5 and 6 that, whether solely or combined, provide a
2.9	photograph of the applicant and the applicant's full name, date of birth, and residential
2.10	address within the municipality's corporate boundaries.
2.11	(b) A submitted document must be an original or a copy certified by the issuing agency.
2.12	If the applicant's current legal name is different from the name on an identity document,
2.13	the applicant must submit proof of a lawful change of name. A document that is not in
2.14	English must be accompanied by a certified translation or an affidavit of translation into
2.15	English. A document that is expired may be used to demonstrate identity and residency if
2.16	it is accompanied by at least one other document and the requirements of paragraph (a) are
2.17	<u>met.</u>
2.18	Subd. 5. Proof of identity; documents. The following may be used to demonstrate
2.19	identity:
2.20	(1) driver's license or identification card issued by any state, the District of Columbia,

2.24	(4) United States permanent resident card, commonly known as a "green card";

4.2	Subd. 6. Proof of residency; documents. (a) If the documentation used to demonstrate
4.3	identity under subdivision 5 does not also demonstrate residency within the municipality's
4.4	corporate boundaries, an applicant must submit one of the following:
4.5	(1) utility bill, including a cable, cell phone, gas, or electric bill, dated within the last 30
4.6	days;
4.7	(2) written verification confirming a minimum of 30 days of residency within the last
4.8	30 days issued by a Minnesota licensed homeless shelter;
4.9	(3) written verification issued by a hospital, health clinic, or county social services
4.10	agency confirming a minimum of 30 days of residency within the last 30 days;
4.11	(4) local property tax statement or mortgage payment receipt dated within the last 30

4.13	(5) bank account statement dated within the last 30 days;

4.28	Subd. 8. Previously issued municipal ID. A municipal ID issued before August 1,
4.29	2019, is valid if it complies with the requirements of this section.
