1.6	Section 1. [469.501] STATE GENERAL TAX REFUND.
1.7	Subdivision 1. Definitions. (a) For the purposes of this section, the following terms have
1.8	the meanings given them.
1.9	(b) "Commissioner" means the commissioner of employment and economic development.
1.10	(c) "Employee" and "wages" have the meanings given in section 290.92, subdivision 1.
1.11	(d) "Job creation zone" means an area including one or more contiguous census tracts,
1.12	as determined and measured by the United States Census Bureau, where the unemployment
1.13	rate average for the immediately preceding three years is at least 75 percent higher than the
1.14	statewide average unemployment rate as estimated by the United States Census Bureau
1.15	using data collected in the most recent American Community Survey.
1.16	Subd. 2. Eligible business. (a) An eligible business located within the seven-county

(b) An eligible business located outside the seven-county metropolitan area and in a city 2.1 or township with a population less than 40,000 is an employer that: (1) pays at least 50 2.2 2.3 percent of the business's total wages to employees who reside in any job creation zone not located in either the seven-county metropolitan area or in a city located outside the 2.4 seven-county metropolitan area with a population greater than 40,000; and (2) is a for-profit 2.5 business. 2.6 (c) If a business received a refund under this section in the immediately preceding year, 2.7 but does not qualify for a refund in the current year because the business is located in an 2.8 area that no longer meets the requirements of a job creation zone, as defined in subdivision 2.9 1, the business may apply for a onetime refund in the current year equal to one-half the 2.10 amount of the refund issued to the business in the immediately preceding year. A business 2.11 that relocates outside of a job creation zone is not eligible for a refund under this paragraph. 2.12 Subd. 3. **Refund**; authorized.
