- (c) If the district court determines that a violation of section 181.932 occurred, the court may order any appropriate relief, including but not limited to reinstatement, back pay, restoration of lost service credit, if appropriate, compensatory damages, and the expungement of any adverse records of an employee who was the subject of the alleged acts of misconduct.
- (d) In addition to other remedies and damages provided by this section, if a district court determines that a violation of section 181.932, subdivision 1, clause (7), occurred, the court must require the public employer to pay \$10,000 to the injured employee.
- (e) A public employer who pays damages, costs, disbursements, or fees as a result of a violation of section 181.932 may recover these amounts from one or more of its employees if the public employer demonstrates that the employee's conduct caused the violation of section 181.932 and that the employee knew the conduct violated section 181.932.
