1.2 relating to family law; changing certain custody and parenting time provisions;  
1.3 amending Minnesota Statutes 2016, sections 257.541, subdivisions 2, 3; 518.003,  
1.4 subdivision 3; 518.091, by adding a subdivision; 518.131, subdivisions 1, 7;  
1.5 518.155; 518.156, subdivision 2; 518.167, subdivision 2; 518.17, subdivisions 1,  
1.6 3; 518.1705, subdivisions 3, 5, 9; 518.175, subdivision 1; 518.179, subdivision 1;  
1.7 518.18; proposing coding for new law in Minnesota Statutes, chapter 518.

1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. Minnesota Statutes 2016, section 257.541, subdivision 2, is amended to read:

1.10 Subd. 2. **Father's right to parenting time and custody.** (a) If paternity has been  
1.11 acknowledged under section 257.34 and paternity has been established under sections 257.51  
1.12 to 257.74, the father's rights of parenting time or custody are determined under sections  
1.13 ~~518.17~~ and 518.169 to 518.175.

1.14 (b) If paternity has not been acknowledged under section 257.34 and paternity has been  
1.15 established under sections 257.51 to 257.74, the biological father may petition for rights of  
1.16 parenting time or custody in the paternity proceeding or in a separate proceeding under  
1.17 section 518.156. The rights of parenting time or custody must be determined under sections  
1.18 518.169 to 518.175.

1.19 **EFFECTIVE DATE.** This section is effective for temporary orders and child custody  
1.20 determinations made on or after January 1, 2018.

1.21 Sec. 2. Minnesota Statutes 2016, section 257.541, subdivision 3, is amended to read:

1.22 Subd. 3. **Father's right to parenting time and custody; recognition of paternity.** If  
1.23 paternity has been recognized under section 257.75, the father may petition for rights of

2.1 parenting time or custody in an independent action under section 518.156. The proceeding  
2.2 must be treated as an initial determination of custody ~~under section 518.17~~ and the provisions  
2.3 ~~of chapter 518~~ provisions of sections 518.169 to 518.175 apply with respect to the granting  
2.4 of custody and parenting time. An action to determine custody and parenting time may be  
2.5 commenced pursuant to chapter 518 without an adjudication of parentage. These proceedings  
2.6 may not be combined with any proceeding under chapter 518B.

2.7 **EFFECTIVE DATE.** This section is effective for temporary orders and child custody  
2.8 determinations made on or after January 1, 2018.

2.9 Sec. 3. Minnesota Statutes 2016, section 518.003, subdivision 3, is amended to read:

2.10 Subd. 3. **Custody.** Unless otherwise agreed by the parties:

2.11 (a) "Legal custody" means the right to determine the child's upbringing, including  
2.12 education, health care, and religious training.

2.13 (b) "Joint legal custody" means that both parents have equal rights and responsibilities,  
2.14 including the right to participate in major decisions determining the child's upbringing,  
2.15 including education, health care, and religious training.

2.16 (c) "Physical custody and residence" means the routine daily care and control and the  
2.17 residence of the child.

2.18 (d) "Joint physical custody" means that the routine daily care and control and the residence  
2.19 of the child is ~~structured~~ shared between the parties.

2.20 (e) Wherever used in this chapter, the term "custodial parent" or "custodian" means the  
2.21 person who has the physical custody of the child at any particular time.

2.22 (f) "Custody determination" means a court decision and court orders and instructions  
2.23 providing for the custody of a child, including parenting time, but does not include a decision  
2.24 relating to child support or any other monetary obligation of any person.

2.25 (g) "Custody proceeding" includes proceedings in which a custody determination is one  
2.26 of several issues, such as an action for dissolution, divorce, or separation, and includes  
2.27 proceedings involving children who are in need of protection or services, domestic abuse,  
2.28 and paternity.

3.3 Subd. 3. Custody and parenting time requirements. Every summons must include  
3.4 the notice in this subdivision.

3.5 PARENTS ARE ENTITLED TO A PRESUMPTION OF JOINT LEGAL CUSTODY  
3.6 AND JOINT PHYSICAL CUSTODY WITH EQUAL SHARED PARENTING. THIS  
3.7 MEANS EACH PARENT HAS AT LEAST 45.1 PERCENT PARENTING TIME, UNLESS  
3.8 THE PARENTS AGREE OTHERWISE. CERTAIN EXCEPTIONS AND OTHER

3.13 Sec. 5. Minnesota Statutes 2016, section 518.131, subdivision 1, is amended to read:

3.14 Subdivision 1. **Permissible orders.** In a proceeding brought for custody, dissolution,  
3.15 or legal separation, or for disposition of property, maintenance, or child support following  
3.16 the dissolution of a marriage, either party may, by motion, request from the court and the  
3.17 court may grant a temporary order pending the final disposition of the proceeding to or for:

3.18 (a) Temporary custody and parenting time pursuant to sections 518.169 to 518.175  
3.19 regarding the minor children of the parties;

3.20 (b) Temporary maintenance of either spouse;

3.21 (c) Temporary child support for the children of the parties;

3.22 (d) Temporary costs and reasonable attorney fees;

3.23 (e) Award the temporary use and possession, exclusive or otherwise, of the family home,  
3.24 furniture, household goods, automobiles, and other property of the parties;

3.25 (f) Restrain one or both parties from transferring, encumbering, concealing, or disposing

4.13 ~~518.169~~ to 518.175 (concerning custody and parenting time), and 518.14 (concerning costs

4.22 the court has jurisdiction over the matter pursuant to the provisions of chapter 518D.

4.27 appear and be heard and may file a responsive pleading. The court may, upon a showing of  
4.28 good cause, permit the intervention of other interested parties.

4.29 (b) Every summons must include the notice in this subdivision.

5.11 Subd. 2. **Preparation.** (a) In preparing a report concerning a child, the investigator may  
 5.12 consult any person who may have information about the child and the potential custodial  
 5.13 arrangements except for persons involved in mediation efforts between the parties. Mediation  
 5.14 personnel may disclose to investigators and evaluators information collected during mediation  
 5.15 only if agreed to in writing by all parties. Upon order of the court, the investigator may refer  
 5.16 the child to professional personnel for diagnosis. The investigator may consult with and  
 5.17 obtain information from medical, psychiatric, school personnel, or other expert persons who  
 5.18 have served the child in the past after obtaining the consent of the parents or the child's  
 5.19 custodian or guardian.

5.20 (b) The report submitted by the investigator must:

5.21 (1) state the position of each party;

5.22 (2) consider and evaluate the factors in section ~~518.17, subdivision 1~~ 518.169, subdivision  
 5.23 3;

5.24 (3) include a detailed analysis of all information considered for each factor;

5.25 (4) state the investigator's recommendation and the reason for the recommendation; and

5.26 (5) reference established means for dispute resolution between the parties.

5.27 **EFFECTIVE DATE.** This section is effective for all investigations ordered on or after  
 5.28 January 1, 2018.

5.29 Sec. 10. **[518.169] JOINT CUSTODY AND EQUAL SHARED PARENTING.**

5.30 Subdivision 1. **Public policy.** (a) Recognizing the importance of protections afforded  
 5.31 children by their ability to develop strong parental bonds, and recognizing the fundamental

6.1 right and liberty interest that parents enjoy regarding the care, custody, and companionship  
6.2 of their children, the legislature finds and declares the following with respect to the intent  
6.3 of Minnesota laws relating to families:

6.4 (1) an intact, involved, two-parent home provides the optimal environment through  
6.5 which children grow into productive and responsible adult citizens;

6.6 (2) parents play the primary role in the nurturing and development of their children. Our  
6.7 society, state, and statutes are secondary structures designed to support, not supplant, both  
6.8 parents in their role as the primary shapers of their children;

6.9 (3) mothers and fathers provide unique and invaluable contributions toward the  
6.10 development of their children. Each parent's contributions to the upbringing of their children  
6.11 are indistinguishable and equally necessary to assure children the best opportunity to develop  
6.12 into healthy citizens;

6.13 (4) children should be separated from their parents only under the most compelling and  
6.14 unusual circumstances in order to protect a child from endangerment;

6.15 (5) it is in the best interests of children to have frequent and continuing physical contact  
6.16 with both parents under joint legal and joint physical custody when the parents live separately,  
6.17 including after parental separation or dissolution of marriage. The proper role of the state  
6.18 is to interfere to the least degree in familial relationships with the specific purpose of  
6.19 preserving maximum time allocations with each parent and their children;

6.20 (6) parents may, and should be encouraged to, reach any agreement mutually acceptable  
6.21 to them regarding their parenting time allocations that reflects the individual circumstances  
6.22 of the parents and children. In the event parents cannot reach agreement on a parenting  
6.23 arrangement, it is the specific intent of Minnesota law that parents have a right to a rebuttable  
6.24 presumption of equal time with their children; and

6.25 (7) the judiciary in contested custody proceedings should demonstrate consistent  
6.26 application of the rebuttable presumption in favor of joint legal and joint physical custody  
6.27 in order to minimize the adversarial nature of custody proceedings.

6.28 (b) The purpose of this section is to prevent children from being alienated or  
6.29 disenfranchised from their parents' lives through the unwarranted interference of either  
6.30 parent.

6.31 (c) This section establishes clear legislative policy regarding the relationship of children  
6.32 with each parent when the parents live separately.

7.1 (d) In accordance with the findings in paragraph (a), the legislature declares that public  
7.2 policy is advanced and the best interests of children are promoted through equal and shared  
7.3 parenting and the recognition of both parents' fundamental freedoms to actively participate  
7.4 in the care, custody, and companionship of their children.

7.5 Subd. 2. **Presumption of joint legal and physical custody and shared parenting.** This  
7.6 subdivision applies to temporary and final orders in marriage dissolution, custody  
7.7 determinations, and parenting plans ordered by the court. Upon request of either or both  
7.8 parties, the court shall use a rebuttable presumption that joint legal custody and joint physical  
7.9 custody, with equal shared parenting, is in the best interests of the child. For purposes of  
7.10 this subdivision, "equal" means a minimum parenting time for each parent of 45.1 percent.  
7.11 The percentage of parenting time may be determined by calculating the number of overnights  
7.12 that a child spends with a parent or by using a method other than overnights if the parent  
7.13 has significant time periods on separate days when the child is in the parent's physical  
7.14 custody but does not stay overnight. The parenting time must be spread throughout one  
7.15 calendar year in a way that best meets variable circumstances for the parties, unless both  
7.16 parents agree to a different division of time or schedule.

7.17 Subd. 3. **Overcoming presumption.** If the parents are unable to reach an agreement on  
7.18 joint legal custody and joint physical custody and equal shared parenting, the burden of  
7.19 overcoming the presumption of joint legal custody, joint physical custody, and equal shared  
7.20 parenting rests on the parent challenging the presumption. To overcome the presumption,  
7.21 the court must find that the parent challenging the presumption has established by clear and  
7.22 convincing evidence that:

7.23 (1) the other parent's actions rise to the level of endangering the child due to any of the  
7.24 following:

7.25 (i) abandonment under section 260C.007, subdivision 6, clause (1); 260C.301, subdivision  
7.26 2; or 518.1705, subdivision 6, paragraph (b), clause (3);

7.27 (ii) physical or sexual abuse under section 260C.007, subdivision 6, clause (2);

7.28 (iii) neglect under section 260C.007, subdivision 6, clause (3) or (8);

7.29 (iv) allowing the child to live in injurious or dangerous conditions under section  
7.30 260C.007, subdivision 6, clause (9);

7.31 (v) egregious harm under section 260C.007, subdivision 14;

7.32 (vi) emotional maltreatment under section 260C.007, subdivision 15;

7.33 (vii) great bodily harm under section 609.02, subdivision 8;

8.1 (viii) conviction of child abuse as defined in section 609.185, paragraph (d);

8.2 (ix) child maltreatment under section 626.556; or

8.3 (x) domestic abuse as defined in section 518B.01, except when:

8.4 (A) a parent has petitioned for an order for protection and the petition has been dismissed  
8.5 or denied by a court, or an order for protection was filed by agreement of the parties without  
8.6 a finding of domestic abuse and the agreement and order incorporating the agreement did  
8.7 not provide otherwise, in which case the court must find that no domestic abuse has occurred  
8.8 with respect to matters that were alleged or could have been alleged; or

8.9 (B) a parent knowingly makes false allegations of domestic abuse as defined in section  
8.10 518B.01, subdivision 2. Making a false allegation of abuse is sufficient grounds to challenge  
8.11 the custody and parenting time of the accuser. Allegations raised in the context of custody  
8.12 proceedings that do not display evidence of a previous pattern of abuse deserve heightened  
8.13 scrutiny as to their veracity; or

8.14 (2) the other parent is incapable of self-management or management of personal affairs  
8.15 and would jeopardize the safety of the children due to current habitual and excessive use  
8.16 of alcohol, drugs, or other mind-altering substances and the related actions due to the  
8.17 substance abuse demonstrate endangerment to the well-being of the child.

8.18 Subd. 4. **Consideration of geographic limitations.** This subdivision applies when the  
8.19 presumption has not been overcome, but due to the parents' different geographic locations,  
8.20 a 45.1 percent minimum parenting time for each parent would prevent the parents from  
8.21 keeping the child in one school during a school year. During the pendency of the custody  
8.22 proceeding, the child shall remain in the same school district which the child currently  
8.23 attends or most recently attended, unless the parents agree otherwise, or except in cases  
8.24 under section 518B.01 where the parent or child involved in the proceeding is endangered.  
8.25 If the parents do not agree otherwise, the court shall determine which parent has the majority  
8.26 of parenting time using the best interests of the child factors under section 518.17, subdivision  
8.27 1, provided that a minimum of 25 percent parenting time must be granted to the other parent,  
8.28 making every attempt to exceed this amount and maximize the parental involvement of  
8.29 each parent.

8.30 Subd. 5. **Findings and order.** (a) If the court finds the presumption has been overcome,  
8.31 the court shall make detailed written findings that enumerate and explain which of the factors  
8.32 in this section are applicable and what evidence supported these factors. The court shall  
8.33 restrict physical custody and parenting time with the other parent as to time, place, duration,  
8.34 or supervision and may deny parenting time entirely, as the circumstances warrant.



9.1 (b) If the court finds the presumption was not overcome, the court shall issue a custody  
9.2 order or parenting plan with a minimum 45.1 percent parenting time for each parent, or a  
9.3 different division of time agreed to by the parents, or as provided under subdivision 4, if  
9.4 applicable.

9.5 **EFFECTIVE DATE.** This section is effective for temporary orders and child custody  
9.6 determinations made on or after January 1, 2018.

9.7 Sec. 11. Minnesota Statutes 2016, section 518.17, subdivision 1, is amended to read:

9.8 Subdivision 1. **Best interests of the child.** (a) In evaluating the best interests of the child  
9.9 for purposes of determining issues of custody and parenting time, the court must consider  
9.10 and evaluate all relevant factors, subject to section 518.169, and including:

9.11 (1) a child's physical, emotional, cultural, spiritual, and other needs, and the effect of  
9.12 the proposed arrangements on the child's needs and development;

9.13 (2) any special medical, mental health, or educational needs that the child may have that  
9.14 may require special parenting arrangements or access to recommended services;

9.15 (3) the reasonable preference of the child, if the court deems the child to be of sufficient  
9.16 ability, age, and maturity to express an independent, reliable preference;

9.17 (4) whether domestic abuse, as defined in section 518B.01, has occurred in the parents'  
9.18 or either parent's household or relationship; the nature and context of the domestic abuse;  
9.19 and the implications of the domestic abuse for parenting and for the child's safety, well-being,  
9.20 and developmental needs;

9.21 (5) any physical, mental, or chemical health issue of a parent that affects the child's  
9.22 safety or developmental needs;

9.23 (6) the history and nature of each parent's participation in providing care for the child;

9.24 (7) the willingness and ability of each parent to provide ongoing care for the child; to  
9.25 meet the child's ongoing developmental, emotional, spiritual, and cultural needs; and to  
9.26 maintain consistency and follow through with parenting time;

9.27 (8) the effect on the child's well-being and development of changes to home, school,  
9.28 and community;

9.29 (9) the effect of the proposed arrangements on the ongoing relationships between the  
9.30 child and each parent, siblings, and other significant persons in the child's life;

10.1 (10) the benefit to the child in maximizing parenting time with both parents and the  
10.2 detriment to the child in limiting parenting time with either parent;

10.3 (11) except in cases in which domestic abuse as described in clause (4) has occurred,  
10.4 the disposition of each parent to support the child's relationship with the other parent and  
10.5 to encourage and permit frequent and continuing contact between the child and the other  
10.6 parent; and

10.7 (12) the willingness and ability of parents to cooperate in the rearing of their child; to  
10.8 maximize sharing information and minimize exposure of the child to parental conflict; and  
10.9 to utilize methods for resolving disputes regarding any major decision concerning the life  
10.10 of the child.

10.11 (b) Clauses (1) to (9) govern the application of the best interests of the child factors by  
10.12 the court:

10.13 (1) The court must make detailed findings on each of the factors in paragraph (a) based  
10.14 on the evidence presented and explain how each factor led to its conclusions and to the  
10.15 determination of custody and parenting time. The court may not use one factor to the  
10.16 exclusion of all others, and the court shall consider that the factors may be interrelated.

10.17 (2) The court shall consider that it is in the best interests of the child to promote the  
10.18 child's healthy growth and development through safe, stable, nurturing relationships between  
10.19 a child and both parents.

10.20 (3) The court shall consider both parents as having the capacity to develop and sustain  
10.21 nurturing relationships with their children unless there are substantial reasons to believe  
10.22 otherwise. In assessing whether parents are capable of sustaining nurturing relationships  
10.23 with their children, the court shall recognize that there are many ways that parents can  
10.24 respond to a child's needs with sensitivity and provide the child love and guidance, and  
10.25 these may differ between parents and among cultures.

10.26 (4) The court shall not consider conduct of a party that does not affect the party's  
10.27 relationship with the child.

10.28 (5) Disability alone, as defined in section 363A.03, of a proposed custodian or the child  
10.29 shall not be determinative of the custody of the child.

10.30 (6) The court shall consider evidence of a violation of section 609.507 in determining  
10.31 the best interests of the child.

10.32 (7) There is no presumption for or against joint physical custody, except as provided in  
10.33 clause (9).

11.1 (8) Joint physical custody does not require an absolutely equal division of time.

11.2 (9) The court shall use a rebuttable presumption that upon request of either or both  
11.3 parties, joint legal custody is in the best interests of the child. However, the court shall use  
11.4 a rebuttable presumption that joint legal custody or joint physical custody is not in the best  
11.5 interests of the child if domestic abuse, as defined in section 518B.01, has occurred between  
11.6 the parents. In determining whether the presumption is rebutted, the court shall consider  
11.7 the nature and context of the domestic abuse and the implications of the domestic abuse for  
11.8 parenting and for the child's safety, well-being, and developmental needs. Disagreement  
11.9 alone over whether to grant sole or joint custody does not constitute an inability of parents  
11.10 to cooperate in the rearing of their children as referenced in paragraph (a), clause (12).

11.11 (c) In a proceeding involving the custodial responsibility of a service member's child, a  
11.12 court may not consider only a parent's past deployment or possible future deployment in  
11.13 determining the best interests of the child. For purposes of this paragraph, "custodial  
11.14 responsibility" has the meaning given in section 518E.102, paragraph (f).

11.15 Sec. 12. Minnesota Statutes 2016, section 518.17, subdivision 3, is amended to read:

11.16 Subd. 3. **Custody order.** (a) Subject to section 518.169, upon adjudging the nullity of  
11.17 a marriage, or in a dissolution or separation proceeding, or in a child custody proceeding,  
11.18 the court shall make such further order as it deems just and proper concerning:

11.19 (1) the legal custody of the minor children of the parties which shall be sole or joint;

11.20 (2) their physical custody and residence; and

11.21 (3) their support. In determining custody, the court shall use section 518.169, or if section  
11.22 518.169 is not applicable then consider the best interests of each child and shall not prefer  
11.23 one parent over the other solely on the basis of the sex of the parent.

11.24 (b) The court shall grant the rights listed in subdivision 3a to each of the parties, regardless  
11.25 of custodial designation, unless specific findings are made under section 518.68, subdivision  
11.26 1. The court shall include in the custody order the notice under subdivision 3a.

11.27 (c) The court may waive any of the rights under this section if it finds it is necessary to  
11.28 protect the welfare of a party or child.

11.29 (d) If a court order or law prohibits contact by a party, the notifications and information  
11.30 required to be sent under subdivision 3a, clauses (1), (2), (3), (5), and (6), shall not be made  
11.31 by direct communication of the parties. Third-party communication shall be limited to the  
11.32 specific purposes delineated in this subdivision or subdivision 3a. Nothing in this subdivision
