1.6	Section 1. Minnesota Statutes 2016, section 5.34, is amended to read:
1.7	5.34 ANNUAL RENEWAL FILINGS.

- (a) Any business registered with the secretary of state required to file an annual renewal in order to maintain its active status, good standing, or existence under Minnesota Statutes shall file that renewal, whether online or otherwise, in a format that states:
- (1) the name in Minnesota of the organization for which the renewal is filed; 1.11
- (2) the name of the organization in the jurisdiction in which it is organized, if different; 1.12
- (3) the address of the registered office or designated office and the name of the registered 1.13 agent of the organization for service of process, if any; 1.14
- (4) the jurisdiction in which the organization is organized, if that jurisdiction is not 1.15 Minnesota; 1.16
- (5) the name and business address of the officer or other person exercising the principal 1.17 functions of the president of a nonprofit corporation, manager of a limited liability company, 1.18 or chief executive officer of a corporation or cooperative; 1.19
- (6) the address of the principal executive office of a domestic business corporation or 1.20 of a limited liability company or the principal place of business of a cooperative, if different 1.21 from the registered office address; 1.22
