1.8	Subdivision 1. Appropriation. \$24,000,000 is appropriated from the bond proceeds
1.9	fund to the Board of Regents of the University of Minnesota to predesign, design, renovate,
1.10	furnish, and equip historic Pillsbury Hall on the Minneapolis campus. This appropriation
1.11	is intended to cover two-thirds of the cost of the project. The remaining costs must be paid
1.12	from university sources.
1.13	Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
1.14	proceeds fund, the commissioner of management and budget shall sell and issue bonds of
1.15	the state in an amount up to \$24,000,000 in the manner, upon the terms, and with the effect
