1.5	Section 1. MINNESOTA RECOVERS TASK FORCE SUBCOMMITTEE.
1.6	Subdivision 1. Subcommittee established. The commissioner of public safety shall
1.7	appoint a subcommittee of the Minnesota Recovers Task Force to comprehensively review
1.8	the state's disaster mitigation, response, and recovery system. The subcommittee shall study
1.9	and make recommendations on ways to improve the state's efforts to mitigate, respond, and
1.10	recover from disasters in light of new climate stresses and the reality of many lower-level
1.11	disasters that do not result in a federal or state disaster declaration.
1.12	Subd. 2. Membership. (a) The commissioner shall appoint the members of the
1.13	subcommittee, which must include, at a minimum, representatives of the Departments of
1.14	Public Safety, Human Services, Transportation, Health, Natural Resources, and Human
