1.1 A bill for an act

relating to public safety; establishing procedure for handling sexual assault
examination kits; providing notice to victims; amending Minnesota Statutes 2016,
section 144.6586, subdivision 2; proposing coding for new law in Minnesota
Statutes, chapters 299C; 611A.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 2016, section 144.6586, subdivision 2, is amended to read:

- Subd. 2. **Contents of notice.** The commissioners of health and public safety, in consultation with sexual assault victim advocates and health care professionals, shall develop the notice required by subdivision 1. The notice must inform the victim, at a minimum, of:
- (1) the obligation under section 609.35 of the county where the criminal sexual conduct occurred to pay for the examination performed for the purpose of gathering evidence, that payment is not contingent on the victim reporting the criminal sexual conduct to law enforcement, and that the victim may incur expenses for treatment of injuries; and
- (2) the victim's rights if the crime is reported to law enforcement, including the victim's right to apply for reparations under sections 611A.51 to 611A.68, information on how to apply for reparations, and information on how to obtain an order for protection or a harassment restraining order-; and
- (3) the opportunity under section 611A.27 to obtain status information about an
 unrestricted sexual assault examination kit, as defined in section 299C.106, subdivision 1,
 paragraph (h).
