1.6	Section 1. [168.1294] "START SEEING MOTORCYCLES" PLATES.
1.7	Subdivision 1. Issuance of plates. The commissioner shall issue special "Start Seeing
1.8	Motorcycles" license plates or a single motorcycle plate to an applicant who:
1.9 1.10	(1) is a registered owner of a passenger automobile, noncommercial one-ton pickup truck, motorcycle, or recreational motor vehicle;
1.10	truck, motorcycle, or recreational motor venicle,
1.11	(2) pays a fee of \$10 for each set of plates;
1.12	(3) pays the registration tax as required under section 168.013, along with any other fees
1.13	required by this chapter;
1.14	(4) contributes a minimum of \$10 annually to the motorcycle safety fund, created under
