1.7	(a) A school board must adopt a written policy to address malicious and sadistic conduct
1.8	involving race, gender, religion, sexual harassment, sexual orientation, and sexual exploitation
1.9	by a district or school staff member or student enrolled in a public or charter school against
1.10	another staff member or student that occurs as described in section 121A.031, subdivision
1.11	<u>1.</u>
1.12	(b) The policy shall apply to students, teachers, administrators, and other school
1.13	personnel, and include at a minimum the components under section 121A.031, subdivision
1.14	4, paragraph (a), and disciplinary actions that will be taken for violation of the policy.
