1.5	Section 1. [356.231] STRESS TESTING.
1.6	(a) The board of directors of the Minnesota State Retirement System, the board of trustees
1.7	of the Public Employees Retirement System, the board of trustees of the Teachers Retirement
1.8	Association, and the board of trustees of the St. Paul Teachers Retirement Fund Association
1.9	shall adopt a uniform method to conduct and report annual sensitivity and stress test analyses
1.10	of the pension plans they administer.
1.11	(b) The uniform method adopted shall be a method recommended by an organization
1.12	of actuaries in accordance with generally accepted and nationally recognized actuarial
1.13	standards.
1.14	(c) The stress test analyses shall include:
1.15	(1) projections that consider the effects of long-term conditions and patterns of behavior
1.16	of the investment market to assess the impact on each pension plan in periods when market
1.17	returns are significantly above or below baseline assumed returns;
1.18	(2) projections of assets, liabilities, pension debt, service costs, employee contributions,
1.19	employer contributions, net amortization, benefit payments, payroll, and funded ratio for
1.20	each pension plan for each of the next thirty years based upon the then-current actuarial
1.21	assumptions, including the assumed investment rate of return;

2.1	(3) projections for the items listed in clause (2), assuming that investment returns are
