1.7	Section 1. [196.31] ALTERNATIVE TREATMENT OPTIONS.
1.8	Subdivision 1. Definitions. (a) For purposes of this section, the following terms have

1.10	(b) "Accelerated resolution therapy" means a process that replaces negative images and
1.11	sensations with positive ones, uses specific eye movements in conjunction with controller
1.12	verbalization about details of a prior traumatic experience, and uses metaphors and other
1.13	interventions that assist a patient in recalling less distressing images while retaining the
1.14	facts of an original experience.
1.15	(c) "Acupuncture" has the same meaning as provided in section 147B.01, subdivision

1.17	(d) "Alternative treatment" means a treatment that is not part of the standard of medical
