The commissioner shall establish designated providers to serve as behavioral health homes and provide the services described in subdivision 3 to individuals eligible under subdivision 2. The commissioner shall apply for grants as provided under section 3502 of the Patient Protection and Affordable Care Act to establish behavioral health homes and provide capitated payments to designated providers. For purposes of this section, "designated provider" means a provider, clinical practice or clinical group practice, rural clinic, community health center, community mental health center, or any other entity that is determined by the commissioner to be qualified to be a behavioral health home for eligible individuals. This determination must be based on documentation evidencing that the designated provider has the systems and infrastructure in place to provide behavioral health home services and satisfies the qualification standards

- Subd. 5. **Payments.** The commissioner shall make payments to each designated provider for the provision of establish a single statewide reimbursement rate for behavioral health home services described in subdivision 3 to each eligible individual under subdivision 2 that selects the health home as a provider under this section. In setting this rate, the commissioner must include input from stakeholders, including providers of the services. The statewide reimbursement rate shall be adjusted annually by the Medicare Economic Index.
  - **EFFECTIVE DATE.** This section is effective July 1, 2022.

  - Subd. 8. **Evaluation and continued development.** (a) For continued certification under this section, <u>behavioral</u> health homes must meet process, outcome, and quality standards developed and specified by the commissioner. The commissioner shall collect data from behavioral health homes as necessary to monitor compliance with certification standards.
  - (b) The commissioner may contract with a private entity to evaluate patient and family experiences, health care utilization, and costs.
- (c) The commissioner shall utilize findings from the implementation of behavioral health
  homes to determine populations to serve under subsequent health home models for individuals
  with chronic conditions.
