The bill was read for the first time and referred to the Committee on State Government Finance

1.1 A bill for an act  
1.2 relating to capital investment; appropriating money for security upgrades for the  
1.3 Capitol Complex; authorizing the sale and issuance of state bonds.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. **CAPITOL COMPLEX SECURITY UPGRADES.**

1.6 Subdivision 1. **Appropriation.** \$26,200,000 is appropriated to the commissioner of  
1.7 administration for the purposes of this section.

1.8 Subd. 2. **Capitol complex; physical security upgrades.** \$7,700,000 is appropriated  
1.9 from the general fund for the design, construction, and equipping required to upgrade  
1.10 the physical security elements and systems for the buildings listed below, their attached  
1.11 tunnel systems, and their surrounding grounds, and parking facilities as identified in the  
1.12 2014 Minnesota State Capitol Complex Physical Security Study conducted by Miller  
1.13 Dunwiddie Architecture. Work includes but is not limited to the installation of bollards,  
1.14 blast protection, infrastructure security screen walls, door access controls, emergency call  
1.15 stations, security kiosks, locking devices, and traffic control. This appropriation includes  
1.16 money for work associated with the following buildings: Andersen, Freeman, Retirement  
1.17 Systems, and Transportation. This appropriation is available until the project is completed  
1.18 or abandoned subject to Minnesota Statutes, section 16A.642.

1.19 Subd. 3. **Capitol complex; physical security upgrades.** \$18,500,000 is  
1.20 appropriated from the bond proceeds fund for the design, construction, and equipping  
1.21 required to upgrade the physical security elements and systems for the buildings listed  
1.22 below, their attached tunnel systems, and their surrounding grounds and parking facilities  
1.23 as identified in the 2014 Minnesota State Capitol Complex Physical Security Study

2.1 conducted by Miller Dunwiddie Architecture. Work includes but is not limited to the  
2.2 installation of bollards, blast protection, infrastructure security screen walls, door  
2.3 access controls, emergency call stations, security kiosks, locking devices, and traffic  
2.4 control. This appropriation includes money for work associated with the following  
2.5 buildings: Administration, Centennial, Judicial, Ag/Health Lab, Minnesota History  
2.6 Center, Minnesota History Center Loading Dock, Capitol Complex Power Plant and  
2.7 Shops, Stassen, State Office, and Veterans Service.

2.8 Subd. 4. **Bond sale.** To provide the money appropriated in subdivision 3 from  
2.9 the bond proceeds fund, the commissioner of management and budget shall sell and  
2.10 issue bonds of the state in an amount up to \$18,500,000 in the manner, upon the terms,  
2.11 and with the effect prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and  
2.12 by the Minnesota Constitution, article XI, sections 4 to 7.

2.13 **EFFECTIVE DATE.** This section is effective the day following final enactment.
