1.7	indicated on the application for the initial Tier 1 license under subdivision 1, clause (2), and
1.8	limited to the district or charter school that requested the initial Tier 1 license.
1.9	(b) A Tier 1 license does not bring an individual within the definition of a teacher for
1.10	purposes of section 122A.40, subdivision 1, or 122A.41, subdivision 1, clause (a).
