percentage change in the formula allowance from fiscal year 2019, must be used for: (i) extended time activities under subdivision 2a, paragraph (c); or (ii) Language Essentials for Teachers of Reading and Spelling (LETRS) training. The training must be provided to licensed elementary school teachers who have not already completed LETRS training. A school must provide LETRS training to teachers based on the grade level the teacher instructs, with priority given in the following order: kindergarten, first grade, second grade, and third grade. A school must ensure all licensed teachers in the highest priority group complete LETRS training before using funding under this subdivision to provide LETRS training to a teacher in the next priority group.
