1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2020, section 12.31, subdivision 2, is amended to read:
1.8	Subd. 2. Declaration of peacetime emergency. (a) The governor may declare a
1.9	peacetime emergency. A peacetime declaration of emergency may be declared only when
1.10	an act of nature, a technological failure or malfunction, a terrorist incident, an industrial
1.11	accident, a hazardous materials accident, or a civil disturbance endangers life and property
1.12	and local government resources are inadequate to handle the situation. If the peacetime
1.13	emergency occurs on Indian lands, the governor or state director of emergency management
1.14	shall consult with tribal authorities before the governor makes such a declaration. Nothing
1.15	in this section shall be construed to limit the governor's authority to act without such
1.16	consultation when the situation calls for prompt and timely action. When the governor
1.17	declares a peacetime emergency, the governor must immediately notify the majority and
1.18	minority leaders of the senate and the speaker and majority and minority leaders of the
1.19	house of representatives. A peacetime emergency must not be continued for more than five
1.20	days unless extended by resolution of the Executive Council up to 30 days. An order, or
1.21	proclamation declaring, continuing, or terminating an emergency must be given prompt and

12.32 GOVERNOR'S ORDERS AND RULES, EFFECT.

Orders and rules promulgated by the governor under authority of section 12.21, 2.17 subdivision 3, clause (1), when approved by the Executive Council and filed in the Office 2.18 2.19 of the Secretary of State, have, during a national security emergency, peacetime emergency, or energy supply emergency, the full force and effect of law. Rules and ordinances of any 2.20 agency or political subdivision of the state inconsistent with the provisions of this chapter 2.21 or with any order or rule having the force and effect of law issued under the authority of 2.22 this chapter, is suspended during the period of time and to the extent that the emergency 2.23 exists. This section does not apply to an order or rule terminated by the legislature under 2.24 section 12.31, subdivision 2. 2.25
