1.6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.7 Section 1. Minnesota Statutes 2019 Supplement, section 617.246, subdivision 2, is amended
1.8 to read:

1.9 Subd. 2. Use of minor. (a) It is unlawful for a person to promote, employ, use or permit
1.10 a minor to engage in or assist others to engage minors in posing or modeling alone or with
1.11 others in any sexual performance or pornographic work if the person knows or has reason
1.12 to know that the conduct intended is a sexual performance or a pornographic work.

1.13 Any person who violates this paragraph is guilty of a felony and ~~may be sentenced to~~
1.14 ~~imprisonment for not more than ten years or~~ shall be committed to the commissioner of
1.15 corrections for not less than 15 years, nor more than 25 years, and sentenced to payment of
1.16 a fine of not more than \$20,000, ~~or both.~~

1.17 (b) A person who violates paragraph (a) is guilty of a felony and ~~may be sentenced to~~
1.18 ~~imprisonment for not more than 15 years or~~ shall be committed to the commissioner of
1.19 corrections for not less than 25 years, nor more than 30 years, and sentenced to payment of

2.9 ~~not more than ten years, or~~ shall be committed to the commissioner of corrections for not
2.10 less than ten years, nor more than 20 years, and sentenced to payment of a fine of not more
2.11 than \$20,000, or both.

 3.13 storage system of any other type, containing a pornographic work, knowing or with reason
 3.14 to know its content and character, or attempts to access the same with the intent to view
 3.15 pornographic work, is guilty of a felony and may be sentenced to imprisonment for not
 3.16 more than ~~five~~ ten years ~~or~~ and sentenced to payment of a fine of not more than \$5,000, or
 3.17 ~~both.~~

3.18 (b) A person who violates paragraph (a) is guilty of a felony and may be sentenced to
 3.19 imprisonment for not more than ~~ten~~ 15 years ~~or~~ and sentenced to payment of a fine of not
 3.20 more than \$10,000, or both, if:

3.21 (1) the person has a prior conviction or delinquency adjudication for a sex offense, as
 3.22 defined in section 609.3455, subdivision 1, paragraph (h), or violating this section or section
