BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. [204C.365] FORENSIC AUDITS.

Subdivision 1. Request for a forensic audit; scope. No later than 5:00 p.m. on the second day after the canvass of a state primary or state general election, the chair of either of the state's two largest major political parties may file a request for a forensic audit of the conduct of the election. The chair may express a specific area of focus for the audit, or may request a general forensic audit. A general forensic audit must include, at a minimum, a review of voting machine accuracy, election cybersecurity measures, voter eligibility, and the maintenance of election records required by law. The audit must be conducted by an independent organization with experience conducting elections audits. The independent organization must be chosen by the secretary of state, in consultation with the requesting political party chair.

Subd. 2. Expenses. The cost of a forensic audit must be paid by the political party on whose behalf the audit is requested. The requesting party must file with the secretary of state a bond, cash, or surety in an amount set by the secretary for the payment of forensic audit expenses. The requesting party is responsible for the following expenses: the compensation of the secretary of state, or designees, and any election judge, municipal clerk, county auditor, administrator, or other personnel of a state or local government required to participate in the audit; necessary supplies and travel related to the audit; the compensation
