1.6	Section 1. Minnesota Statutes 2020, section 168.123, is amended to read:
1.7	168.123 VETERANS; SPECIAL PLATES.
1.8	Subdivision 1. General requirements; fees. (a) On payment of a fee in the amount
1.9	specified for special plates under section 168.12, subdivision 5, for each set of two plates,
1.10	or for a single plate in the case of a motorcycle plate, payment of the registration tax required
1.11	by law, and compliance with other applicable laws relating to vehicle registration and
