1.7	An amendment to the Minnesota Constitution is proposed to the people. If the amendment
1.8	is adopted, article V, section 3, will read:
1.9	Sec. 3. The governor shall communicate by message to each session of the legislature
1.10	information touching the state and country. He is commander-in-chief of the military and
1.11	naval forces and may call them out to execute the laws, suppress insurrection and repel
1.12	invasion. He may require the opinion in writing of the principal officer in each of the
1.13	executive departments upon any subject relating to his duties. With the advice and consent
1.14	of the senate he may appoint notaries public and other officers provided by law, provided
1.15	that the consent of the senate is not required if the senate has not acted upon an appointment
1.16	within 60 legislative days of its submission, if submitted more than 90 calendar days prior
1.17	to adjournment sine die of a regular session of the legislature, or within 60 legislative days
1.18	after the next legislature is convened, if submitted fewer than 90 calendar days prior to
1.19	adjournment sine die of a regular session of the legislature. He may appoint commissioners
1.20	to take the acknowledgment of deeds or other instruments in writing to be used in the state.
