2.15 The sums shown in the columns marked "Appropriations" are added to or, if shown in
 2.16 parentheses, subtracted from the appropriations in Laws 2023, chapter 63, article 9, to the
 2.17 agencies and for the purposes specified in this article. The appropriations are from the
 2.18 general fund, or another named fund, and are available for the fiscal years indicated for
 2.19 each purpose. The figures "2024" and "2025" used in this article mean that the addition to
 2.20 or subtraction from the appropriation listed under them is available for the fiscal year ending

18.5 (b) "Affiliate" means a legal entity that controls, is controlled by, or is under common
18.6 control with another legal entity. For purposes of this paragraph, "control" or "controlled"
18.7 means: ownership of or the power to vote more than 50 percent of the outstanding shares

19.14 about or otherwise be linked to an identified or identifiable natural person or a device linked

22.18 Subd. 2. **Exclusions.** (a) This chapter does not apply to the following entities, activities,
22.19 or types of information:

22.21 (2) a federally recognized Indian tribe;

22.22 (3) information that meets the definition of:

22.23 (i) protected health information, as defined by and for purposes of the Health Insurance

24.1 processes, uses, or maintains in the same manner as required under the laws and regulations
24.2 specified in clause (9);

24.3 (7) information used only for public health activities and purposes, as described under
24.4 Code of Federal Regulations, title 45, part 164.512;

24.5 (8) an activity involving the collection, maintenance, disclosure, sale, communication,
24.6 or use of any personal data bearing on a consumer's credit worthiness, credit standing, credit
24.7 capacity, character, general reputation, personal characteristics, or mode of living by a
24.8 consumer reporting agency, as defined in United States Code, title 15, section 1681a(f), by
24.9 a furnisher of information, as set forth in United States Code, title 15, section 1681s-2, who
24.10 provides information for use in a consumer report, as defined in United States Code, title
24.11 15, section 1681a(d), and by a user of a consumer report, as set forth in United States Code,
24.12 title 15, section 1681b, except that information is only excluded under this paragraph to the

25.21 principally engaged in financial activities, as described in United States Code, title 12,

26.1 (b) Controllers that are in compliance with the Children's Online Privacy Protection Act,
26.2 United States Code, title 15, sections 6501 to 6506, and implementing regulations, shall be
26.3 deemed compliant with any obligation to obtain parental consent under this chapter.

26.4 **Sec. 5. [3250.04] RESPONSIBILITY ACCORDING TO ROLE.**

26.5 (a) Controllers and processors are responsible for meeting the respective obligations
26.6 established under this chapter.

26.7 (b) Processors are responsible under this chapter for adhering to the instructions of the
26.8 controller and assisting the controller to meet the controller's obligations under this chapter.
26.9 Assistance under this paragraph shall include the following:

26.10 (1) taking into account the nature of the processing, the processor shall assist the controller
26.11 by appropriate technical and organizational measures, insofar as this is possible, for the
26.12 fulfillment of the controller's obligation to respond to consumer requests to exercise their
26.13 rights pursuant to section 3250.05; and

26.14 (2) taking into account the nature of processing and the information available to the
26.15 processor, the processor shall assist the controller in meeting the controller's obligations in

27.6 of personal data subject to the processing, the duration of the processing, and the obligations
27.7 and rights of both parties. The contract shall include the requirements imposed by this

27.27 a specific processing of data is a fact-based determination that depends upon the context in
27.28 which personal data are to be processed. A person that is not limited in the person's processing
27.29 of personal data pursuant to a controller's instructions, or that fails to adhere to a controller's
27.30 instructions, is a controller and not a processor with respect to a specific processing of data.
27.31 A processor that continues to adhere to a controller's instructions with respect to a specific
27.32 processing of personal data remains a processor. If a processor begins, alone or jointly with

28.1 Sec. 6. **[3250.05] CONSUMER PERSONAL DATA RIGHTS.**

28.2 Subdivision 1. Consumer rights provided. (a) Except as provided in this chapter, a
28.3 controller must comply with a request to exercise the consumer rights provided in this
28.4 subdivision.

28.5 (b) A consumer has the right to confirm whether or not a controller is processing personal
28.6 data concerning the consumer and access the categories of personal data the controller is
28.7 processing.

28.8 (c) A consumer has the right to correct inaccurate personal data concerning the consumer,
28.9 taking into account the nature of the personal data and the purposes of the processing of the
28.10 personal data.

28.11 (d) A consumer has the right to delete personal data concerning the consumer.

28.12 (e) A consumer has the right to obtain personal data concerning the consumer, which
28.13 the consumer previously provided to the controller, in a portable and, to the extent technically
28.14 feasible, readily usable format that allows the consumer to transmit the data to another
28.15 controller without hindrance, where the processing is carried out by automated means.

28.16 (f) A consumer has the right to opt out of the processing of personal data concerning
28.17 the consumer for purposes of targeted advertising, the sale of personal data, or profiling in
28.18 furtherance of automated decisions that produce legal effects concerning a consumer or
28.19 similarly significant effects concerning a consumer.

28.20 (g) If a consumer's personal data is profiled in furtherance of decisions that produce
28.21 legal effects concerning a consumer or similarly significant effects concerning a consumer,
28.22 the consumer has the right to question the result of the profiling, to be informed of the reason
28.23 that the profiling resulted in the decision, and, if feasible, to be informed of what actions
28.24 the consumer might have taken to secure a different decision and the actions that the
28.25 consumer might take to secure a different decision in the future. The consumer has the right
28.26 to review the consumer's personal data used in the profiling. If the decision is determined
28.27 to have been based upon inaccurate personal data, taking into account the nature of the
28.28 personal data and the purposes of the processing of the personal data, the consumer has the
28.29 right to have the data corrected and the profiling decision reevaluated based upon the
28.30 corrected data.

28.31 (h) A consumer has a right to obtain a list of the specific third parties to which the
28.32 controller has disclosed the consumer's personal data. If the controller does not maintain

29.1 the information in a format specific to the consumer, a list of specific third parties to whom
29.2 the controller has disclosed any consumers' personal data may be provided instead.

29.3 Subd. 2. **Exercising consumer rights.** (a) A consumer may exercise the rights set forth
29.4 in this section by submitting a request, at any time, to a controller specifying which rights
29.5 the consumer wishes to exercise.

29.6 (b) In the case of processing personal data concerning a known child, the parent or legal
29.7 guardian of the known child may exercise the rights of this chapter on the child's behalf.

29.8 (c) In the case of processing personal data concerning a consumer legally subject to
29.9 guardianship or conservatorship under sections 524.5-101 to 524.5-502, the guardian or the
29.10 conservator of the consumer may exercise the rights of this chapter on the consumer's behalf.

29.11 (d) A consumer may designate another person as the consumer's authorized agent to
29.12 exercise the consumer's right to opt out of the processing of the consumer's personal data
29.13 for purposes of targeted advertising and sale under subdivision 1, paragraph (f), on the
29.14 consumer's behalf. A consumer may designate an authorized agent by way of, among other
29.15 things, a technology, including but not limited to an Internet link or a browser setting,
29.16 browser extension, or global device setting, indicating the consumer's intent to opt out of
29.17 the processing. A controller shall comply with an opt-out request received from an authorized
29.18 agent if the controller is able to verify, with commercially reasonable effort, the identity of
29.19 the consumer and the authorized agent's authority to act on the consumer's behalf.

29.20 Subd. 3. **Universal opt-out mechanisms.** (a) A controller must allow a consumer to opt
29.21 out of any processing of the consumer's personal data for the purposes of targeted advertising,
29.22 or any sale of the consumer's personal data through an opt-out preference signal sent, with
29.23 the consumer's consent, by a platform, technology, or mechanism to the controller indicating
29.24 the consumer's intent to opt out of the processing or sale. The platform, technology, or

30.2 resident and whether the consumer has made a legitimate request to opt out of any sale of
30.3 the consumer's personal data or targeted advertising. For purposes of this paragraph, the
30.4 use of an Internet protocol address to estimate the consumer's location is sufficient to
30.5 determine the consumer's residence.

30.6 (b) If a consumer's opt-out request is exercised through the platform, technology, or
30.7 mechanism required under paragraph (a), and the request conflicts with the consumer's
30.8 existing controller-specific privacy setting or voluntary participation in a controller's bona
30.9 fide loyalty, rewards, premium features, discounts, or club card program, the controller
30.10 must comply with the consumer's opt-out preference signal but may also notify the consumer
30.11 of the conflict and provide the consumer a choice to confirm the controller-specific privacy
30.12 setting or participation in the controller's program.

30.13 (c) The platform, technology, or mechanism required under paragraph (a) is subject to
30.14 the requirements of subdivision 4.

30.15 (d) A controller that recognizes opt-out preference signals that have been approved by
30.16 other state laws or regulations is in compliance with this subdivision.

30.17 Subd. 4. **Controller response to consumer requests.** (a) Except as provided in this
30.18 chapter, a controller must comply with a request to exercise the rights pursuant to subdivision
30.19 1.

30.20 (b) A controller must provide one or more secure and reliable means for consumers to
30.21 submit a request to exercise the consumer's rights under this section. The means made
30.22 available must take into account the ways in which consumers interact with the controller
30.23 and the need for secure and reliable communication of the requests.

30.24 (c) A controller may not require a consumer to create a new account in order to exercise
30.25 a right, but a controller may require a consumer to use an existing account to exercise the
30.26 consumer's rights under this section.

30.27 (d) A controller must comply with a request to exercise the right in subdivision 1,
30.28 paragraph (f), as soon as feasibly possible, but no later than 45 days of receipt of the request.

30.29 (e) A controller must inform a consumer of any action taken on a request under
30.30 subdivision 1 without undue delay and in any event within 45 days of receipt of the request.
30.31 That period may be extended once by 45 additional days where reasonably necessary, taking
30.32 into account the complexity and number of the requests. The controller must inform the

31.3 (f) If a controller does not take action on a consumer's request, the controller must inform

31.7 (g) Information provided under this section must be provided by the controller free of
31.8 charge up to twice annually to the consumer. Where requests from a consumer are manifestly
31.9 unfounded or excessive, in particular because of the repetitive character of the requests, the
31.10 controller may either charge a reasonable fee to cover the administrative costs of complying
31.11 with the request, or refuse to act on the request. The controller bears the burden of
31.12 demonstrating the manifestly unfounded or excessive character of the request.

31.13 (h) A controller is not required to comply with a request to exercise any of the rights

32.6 (1) retaining a record of the deletion request, retaining the minimum data necessary for

33.2 **DATA.**

33.3 (a) This chapter does not require a controller or processor to do any of the following
33.4 solely for purposes of complying with this chapter:

33.5 (1) reidentify deidentified data;

33.6 (2) maintain data in identifiable form, or collect, obtain, retain, or access any data or
33.7 technology, in order to be capable of associating an authenticated consumer request with
33.8 personal data; or

33.9 (3) comply with an authenticated consumer request to access, correct, delete, or port
33.10 personal data pursuant to section 325O.05, subdivision 1, if all of the following are true:

33.11 (i) the controller is not reasonably capable of associating the request with the personal
33.12 data, or it would be unreasonably burdensome for the controller to associate the request
33.13 with the personal data;

33.14 (ii) the controller does not use the personal data to recognize or respond to the specific
33.15 consumer who is the subject of the personal data, or associate the personal data with other
33.16 personal data about the same specific consumer; and

33.26 oversight to monitor compliance with any contractual commitments to which the
33.27 pseudonymous data or deidentified data are subject, and must take appropriate steps to
33.28 address any breaches of contractual commitments.

33.29 (d) A processor or third party must not attempt to identify the subjects of deidentified
33.30 or pseudonymous data without the express authority of the controller that caused the data
33.31 to be deidentified or pseudonymized.

34.1 (e) A controller, processor, or third party must not attempt to identify the subjects of
34.2 data that has been collected with only pseudonymous identifiers.

34.3 **Sec. 8. [325O.07] RESPONSIBILITIES OF CONTROLLERS.**

34.4 Subdivision 1. **Transparency obligations.** (a) Controllers must provide consumers with
34.5 a reasonably accessible, clear, and meaningful privacy notice that includes:

34.6 (1) the categories of personal data processed by the controller;

34.7 (2) the purposes for which the categories of personal data are processed;

34.8 (3) an explanation of the rights contained in section 325O.05 and how and where
34.9 consumers may exercise those rights, including how a consumer may appeal a controller's
34.10 action with regard to the consumer's request;

34.11 (4) the categories of personal data that the controller sells to or shares with third parties,
34.12 if any;

34.13 (5) the categories of third parties, if any, with whom the controller sells or shares personal
34.14 data;

34.15 (6) the controller's contact information, including an active email address or other online
34.16 mechanism that the consumer may use to contact the controller;

34.17 (7) a description of the controller's retention policies for personal data; and

34.18 (8) the date the privacy notice was last updated.

34.19 (b) If a controller sells personal data to third parties, processes personal data for targeted
34.20 advertising, or engages in profiling in furtherance of decisions that produce legal effects
34.21 concerning a consumer or similarly significant effects concerning a consumer, the controller
34.22 must disclose the processing in the privacy notice and provide access to a clear and
34.23 conspicuous method outside the privacy notice for a consumer to opt out of the sale,
34.24 processing, or profiling in furtherance of decisions that produce legal effects concerning a
34.25 consumer or similarly significant effects concerning a consumer. This method may include
34.26 but is not limited to an Internet hyperlink clearly labeled "Your Opt-Out Rights" or "Your
34.27 Privacy Rights" that directly effectuates the opt-out request or takes consumers to a web
34.28 page where the consumer can make the opt-out request.

34.29 (c) The privacy notice must be made available to the public in each language in which
34.30 the controller provides a product or service that is subject to the privacy notice or carries
34.31 out activities related to the product or service.

35.1 (d) The controller must provide the privacy notice in a manner that is reasonably
35.2 accessible to and usable by individuals with disabilities.

35.3 (e) Whenever a controller makes a material change to the controller's privacy notice or
35.4 practices, the controller must notify consumers affected by the material change with respect
35.5 to any prospectively collected personal data and provide a reasonable opportunity for
35.6 consumers to withdraw consent to any further materially different collection, processing,
35.7 or transfer of previously collected personal data under the changed policy. The controller
35.8 shall take all reasonable electronic measures to provide notification regarding material
35.9 changes to affected consumers, taking into account available technology and the nature of

36.20 Subd. 3. **Nondiscrimination.** (a) A controller shall not process personal data on the

37.8 (2) the sale of personal data to third parties is clearly disclosed in the terms of the

37.10 (3) the third party uses the personal data only for purposes of facilitating a benefit to
37.11 which the consumer is entitled and does not retain or otherwise use or disclose the personal
37.12 data for any other purpose.

37.13 Subd. 4. **Waiver of rights unenforceable.** Any provision of a contract or agreement of
37.14 any kind that purports to waive or limit in any way a consumer's rights under this chapter

37.17 (a) A small business, as defined by the United States Small Business Administration

37.25 (a) A controller must document and maintain a description of the policies and procedures
37.26 the controller has adopted to comply with this chapter. The description must include, where

38.19 (3) the processing of sensitive data;
38.20 (4) any processing activities involving personal data that present a heightened risk of

- 38.24 (i) unfair or deceptive treatment of, or disparate impact on, consumers;

39.13 and procedures required by paragraph (a).

39.14 (f) As part of a civil investigative demand, the attorney general may request, in writing,
39.15 that a controller disclose any data privacy and protection assessment that is relevant to an
39.16 investigation conducted by the attorney general. The controller must make a data privacy
39.17 and protection assessment available to the attorney general upon a request made under this
39.18 paragraph. The attorney general may evaluate the data privacy and protection assessments
39.19 for compliance with this chapter. Data privacy and protection assessments are classified as
39.20 nonpublic data, as defined by section 13.02, subdivision 9. The disclosure of a data privacy
39.21 and protection assessment pursuant to a request from the attorney general under this
39.22 paragraph does not constitute a waiver of the attorney-client privilege or work product
39.23 protection with respect to the assessment and any information contained in the assessment.

39.24 (g) Data privacy and protection assessments or risk assessments conducted by a controller
39.25 for the purpose of compliance with other laws or regulations may qualify under this section
39.26 if the assessments have a similar scope and effect.

39.27 (h) A single data protection assessment may address multiple sets of comparable
39.28 processing operations that include similar activities.

39.29 **Sec. 11. [3250.09] LIMITATIONS AND APPLICABILITY.**

39.30 (a) The obligations imposed on controllers or processors under this chapter do not restrict
39.31 a controller's or a processor's ability to:

40.1 (1) comply with federal, state, or local laws, rules, or regulations, including but not
40.2 limited to data retention requirements in state or federal law notwithstanding a consumer's
40.3 request to delete personal data;

40.4 (2) comply with a civil, criminal, or regulatory inquiry, investigation, subpoena, or
40.5 summons by federal, state, local, or other governmental authorities;

40.6 (3) cooperate with law enforcement agencies concerning conduct or activity that the
40.7 controller or processor reasonably and in good faith believes may violate federal, state, or
40.8 local laws, rules, or regulations;

40.9 (4) investigate, establish, exercise, prepare for, or defend legal claims;

40.10 (5) provide a product or service specifically requested by a consumer; perform a contract
40.11 to which the consumer is a party, including fulfilling the terms of a written warranty; or

40.13 (6) take immediate steps to protect an interest that is essential for the life or physical
40.14 safety of the consumer or of another natural person, and where the processing cannot be
40.15 manifestly based on another legal basis;

40.16 (7) prevent, detect, protect against, or respond to security incidents, identity theft, fraud,
40.17 harassment, malicious or deceptive activities, or any illegal activity; preserve the integrity
40.18 or security of systems; or investigate, report, or prosecute those responsible for any such
40.19 action;

40.20 (8) assist another controller, processor, or third party with any of the obligations under
40.21 this paragraph;

40.22 (9) engage in public or peer-reviewed scientific, historical, or statistical research in the
40.23 public interest that adheres to all other applicable ethics and privacy laws and is approved,
40.24 monitored, and governed by an institutional review board, human subjects research ethics
40.25 review board, or a similar independent oversight entity that has determined:

40.26 (i) the research is likely to provide substantial benefits that do not exclusively accrue to

41.16 (c) The obligations imposed on controllers or processors under this chapter do not apply
41.17 where compliance by the controller or processor with this chapter would violate an
41.18 evidentiary privilege under Minnesota law and do not prevent a controller or processor from

42.18 Sec. 12. **[3250.10] ATTORNEY GENERAL ENFORCEMENT.**

42.19 (a) In the event that a controller or processor violates this chapter, the attorney general,
42.20 prior to filing an enforcement action under paragraph (b), must provide the controller or
42.21 processor with a warning letter identifying the specific provisions of this chapter the attorney
42.22 general alleges have been or are being violated. If, after 30 days of issuance of the warning
42.23 letter, the attorney general believes the controller or processor has failed to cure any alleged
42.24 violation, the attorney general may bring an enforcement action under paragraph (b). This

43.7 (b) If any provision of this chapter or the chapter's application to any person or
43.8 circumstance is held invalid, the remainder of the chapter or the application of the provision
43.9 to other persons or circumstances is not affected.

43.10 **Sec. 14. EFFECTIVE DATE.**

43.11 This article is effective July 31, 2025, except that postsecondary institutions regulated
43.12 by the Office of Higher Education are not required to comply with this article until July 31,

147.7 by the laws of that state, and determined by the Midcontinent Independent System Operator

154.19 (b) On July 1, 2017, the public utility that owns the Prairie Island nuclear generating
154.20 plant must transfer all funds in the renewable development account previously established
154.21 under this subdivision and managed by the public utility to the renewable development
154.22 account established in paragraph (a). Funds awarded to grantees in previous grant cycles
154.23 that have not yet been expended and unencumbered funds required to be paid in calendar
154.24 year 2017 under paragraphs (f) and (g), and sections 116C.7792 and 216C.41, are not subject

(c) The commission shall make a final decision on an application for a site permit for an LWECS within 180 days after acceptance of a complete application by the commission. The commission may extend this deadline for cause.

(d) The commission may place conditions in a permit and may deny, modify, suspend, or revoke a permit.

(e) The commission must require as a condition of permit issuance, including issuance of a modified permit for a repowering project, as defined in section 216B.243, subdivision 8, paragraph (b), that the recipient of a site permit to construct an LWECS with a nameplate capacity above 25,000 kilowatts, including all of the permit recipient's construction contractors and subcontractors on the project: (1) pay no less than the prevailing wage rate, as defined in section 177.42; and (2) be subject to the requirements and enforcement provisions under sections 177.27, 177.30, 177.32, 177.41 to 177.435, and 177.45.

1506.0010 AUTHORITY.

Parts 1506.0010 to 1506.0040 are prescribed under Minnesota Statutes, section 3.7371, by the commissioner of agriculture to implement procedures to compensate agricultural crop owners for crops that are damaged or destroyed by elk. The procedures in parts 1506.0010 to 1506.0040 are in addition to those in Minnesota Statutes, section 3.7371.

1506.0015 DEFINITIONS.

Subpart 1. **Applicability.** The definitions in this part apply to parts 1506.0010 to 1506.0040.

Subp. 2. **Claim form.** "Claim form" means a form provided by the commissioner, to be completed by the crop owner and the county extension agent or federal crop adjuster, containing information upon which payment for a loss must be based.

Subp. 3. **Commissioner.** "Commissioner" means the commissioner of agriculture or the commissioner's authorized agent.

Subp. 4. **Crop owner.** "Crop owner" means an individual, firm, corporation, copartnership, or association with an interest in crops damaged or destroyed by elk.

Subp. 5. **County extension agent.** "County extension agent" means the University of Minnesota Agricultural Extension Service's county extension agent for the county in which the crop owner resides.

Subp. 6. **Federal crop adjuster.** "Federal crop adjuster" means a crop insurance adjuster having a contract with the Federal Crop Insurance Corporation.

Subp. 7. **Market price.** "Market price" means the commodity price published daily by the Minneapolis Grain Exchange in the daily record of prices and receipts.

Subp. 8. **Target price.** "Target price" means the federal commodity price available from the Agricultural Stabilization and Conservation Service office.

1506.0020 REPORTING.

The crop owner shall notify either the federal crop adjuster or the county extension agent of suspected crop loss or damage within 24 hours of the discovery of a loss. The crop owner shall also complete the appropriate part of the claim form which must be available at the county extension office. The crop owner shall provide all information required to investigate the loss or damage to the federal crop adjuster or the county extension agent. A telephone call or personal contact constitutes notification.

1506.0025 INVESTIGATION AND CROP VALUATION.

Subpart 1. **Whether damaged by elk.** The federal crop adjuster or the county extension agent shall investigate the loss in a timely manner and shall make a finding in writing on the appropriate part of the claim form regarding whether the crop was destroyed or damaged by elk. The finding must be based on physical and circumstantial evidence including:

- A. the condition of the crop;
- B. elk tracks;
- C. the area of the state where the loss occurred;
- D. sightings of elk in the area; and
- E. any other circumstances considered pertinent by the federal crop adjuster or the county extension agent.

The absence of affirmative evidence may be grounds for denial of a claim.

Subp. 2. **Extent of damage.** The federal crop adjuster or the county extension agent shall make a written finding on the claim form of the extent of damage or the amount of crop destroyed. The crop owner may choose to have the federal crop adjuster or county extension agent use the method in item A or B to complete the claim form and determine the amount of crop loss.

A. To submit the claim form at the time the suspected elk damage is discovered, the federal crop adjuster or county extension agent must determine the potential yield, per acre, for the field and record this information on the form in the column labeled "normal yield" and the average yield, per acre, expected from the damaged acres and record this information on the form in the column labeled "average yield expected from damaged acres."

B. To submit the claim form at the time the crop is harvested:

(1) the crop owner shall report the loss to the federal crop adjuster or county extension agent within 24 hours of discovery, and the loss must be investigated by the federal crop adjuster or county extension agent in a timely manner;

(2) the crop owner and federal crop adjuster or county extension agent shall complete the claim form at the time of the investigation, entering the percent of crop loss from damage in the column labeled "normal yield" and leaving the column labeled "average yield expected from damaged acres" blank; and

(3) when the crop is harvested the federal crop adjuster or county extension agent shall enter the actual yield of the damaged field in the column labeled "average yield expected from damaged acres," enter the date in the same column, and submit the form to the commissioner.

1506.0030 COMPLETION AND SIGNING OF CLAIM FORM.

A completed claim form must be signed by the owner and county extension agent or the federal crop adjuster and submitted by the crop owner to the commissioner for review and payment. The commissioner shall return an incomplete claim form to the crop owner, indicating the information necessary for proper completion.

1506.0035 INSURANCE COVERAGE.

If insurance coverage exists on the crop, the commissioner shall withhold payment under parts 1506.0010 to 1506.0040 until the insurance claim has been paid and evidence of payment has been submitted to the commissioner, at which time that insurance payment must be deducted from the determined value. Payment must not be made for claims of less than \$100 per claim or more than \$20,000 in a calendar year.

1506.0040 PAYMENT.

After procedures in parts 1506.0020 to 1506.0035 are completed, the commissioner shall make payment to the crop owners.

7850.2400 CITIZEN ADVISORY TASK FORCE.

Subpart 1. **Authority.** The commission has the authority to appoint a citizen advisory task force. The commission shall determine whether to appoint such a task force as early in the process as possible. The commission shall establish the size of the task force and appoint its members in accordance with Minnesota Statutes, section 216E.08. The commission shall advise of the appointment of the task force at the next monthly commission meeting.

Subp. 2. **Commission decision.** If the commission decides not to appoint a citizen advisory task force and a person would like such a task force appointed, the person may request that the commission create a citizen advisory task force and appoint its members. Upon receipt of such a request, the commission shall place the matter on the agenda for the next regular monthly commission meeting.

APPENDIX
Repealed Minnesota Rules: H4975-2

Subp. 3. **Task force responsibilities.** Upon appointment of a citizen advisory task force, the commission shall specify in writing the charge to the task force. The charge shall include the identification of additional sites or routes or particular impacts to be evaluated in the environmental impact statement. The commission may establish additional charges, including a request that the task force express a preference for a specific site or route if it has one.

Subp. 4. **Termination of task force.** The task force expires upon completion of its charge, designation by the commission of alternative sites or routes to be included in the environmental impact statement, or the specific date identified by the commission in the charge, whichever occurs first.

7850.3600 CITIZEN ADVISORY TASK FORCE.

Part 7850.2400, regarding the appointment of a citizen advisory task force, applies to projects being considered under the alternative permitting process.
