Subdivision 1. Authority. This section is intended to fulfill the requirement under

Minnesota Statutes, section 3.192, that a bill creating, renewing, or continuing a tax

expenditure provide a purpose for the tax expenditure and a standard or goal against which

its effectiveness is measured.

Subd. 2. Credit providing equity and opportunity in education tax credit. The provisions of section 3, providing a tax credit to expand educational choice, are intended to give financial assistance to low-income and middle-income families who seek better educational opportunities for their children. The standard against which the effectiveness of the credit is to be measured is the total number of eligible students who receive opportunity scholarships and better educational opportunities as a result of donations from corporations and individuals that qualify for the tax credit.

Sec. 4. 9
