1.1 A bill for an act
1.2 relating to workers' compensation; adopting recommendations of the 2020 Workers'
1.3 Compensation Advisory Council; amending Minnesota Statutes 2018, sections
1.4 79A.02, subdivision 4; 79A.04, subdivision 2; 79A.06, subdivision 5; 79A.22,
1.5 subdivision 13; 79A.24, subdivision 2; 176.011, subdivision 15, as amended;
1.6 176.102, subdivision 10; 176.111, subdivision 22; 176.135, subdivision 1; 176.185,
1.7 by adding a subdivision; 176.223; Minnesota Statutes 2019 Supplement, sections
1.8 176.181, subdivision 2; 176.231, subdivisions 5, 6, 9, 9a; 176.2611, subdivision
1.9 5; 176.2612, subdivisions 1, 3; 176.275, subdivision 2; 176.285, subdivision 1;
1.10 repealing Minnesota Statutes 2018, section 176.181, subdivision 6.

1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 Section 1. Minnesota Statutes 2018, section 79A.02, subdivision 4, is amended to read:

1.13 Subd. 4. Recommendations to commissioner regarding revocation. After each fifth
1.14 anniversary from the date each individual and group self-insurer becomes certified to
1.15 self-insure, the committee shall review all relevant financial data filed with the Department
1.16 of Commerce that is otherwise available to the public and make a recommendation to the
1.17 commissioner about whether each self-insurer's certificate should be revoked. For group
1.18 self-insurers who have been in existence for five years or more and have been granted
1.19 renewal authority, a level of funding in the common claims fund must be maintained at not
1.20 less than the greater of either: (1) one year's claim losses paid in the most recent year; or
1.21 (2) one-third of the security deposit posted with the Department of Commerce according
1.22 to section 79A.04, subdivision 2. This provision supersedes any requirements under section
1.23 79A.03, subdivision 10, and Minnesota Rules, part 2780.5000.

2.1 Sec. 2. Minnesota Statutes 2018, section 79A.04, subdivision 2, is amended to read:

2.2 Subd. 2. **Minimum deposit.** The minimum deposit is 110 percent of the private
2.3 self-insurer's estimated future liability. The deposit may be used to secure payment of all
2.4 administrative and legal costs, and unpaid assessments required by section 79A.12,
2.5 subdivision 2, relating to or arising from its or other employers' self-insuring. As used in
2.6 this section, "private self-insurer" includes both current and former members of the
2.7 self-insurers' security fund; and "private self-insurers' estimated future liability" means the
2.8 private self-insurers' total of estimated future liability as determined by an Associate or
2.9 Fellow of the Casualty Actuarial Society every year for group member private self-insurers
2.10 and, for a nongroup member private self-insurer's authority to self-insure, every year for
2.11 the first five years. After the first five years, the nongroup member's total shall be as
2.12 determined by an Associate or Fellow of the Casualty Actuarial Society at least every two
2.13 years, and each such actuarial study shall include a projection of future losses during the
2.14 period until the next scheduled actuarial study, less payments anticipated to be made during
2.15 that time.

2.16 All data and information furnished by a private self-insurer to an Associate or Fellow
2.17 of the Casualty Actuarial Society for purposes of determining private self-insurers' estimated
2.18 future liability must be certified by an officer of the private self-insurer to be true and correct
2.19 with respect to payroll and paid losses, and must be certified, upon information and belief,
2.20 to be true and correct with respect to reserves. The certification must be made by sworn
2.21 affidavit. In addition to any other remedies provided by law, the certification of false data
2.22 or information pursuant to this subdivision may result in a fine imposed by the commissioner
2.23 of commerce on the private self-insurer up to the amount of \$5,000, and termination of the
2.24 private self-insurers' authority to self-insure. The determination of private self-insurers'
2.25 estimated future liability by an Associate or Fellow of the Casualty Actuarial Society shall
2.26 be conducted in accordance with standards and principles for establishing loss and loss
2.27 adjustment expense reserves by the Actuarial Standards Board, an affiliate of the American
2.28 Academy of Actuaries. The commissioner may reject an actuarial report that does not meet
2.29 the standards and principles of the Actuarial Standards Board, and may further disqualify
2.30 the actuary who prepared the report from submitting any future actuarial reports pursuant
2.31 to this chapter. Within 30 days after the actuary has been served by the commissioner with
2.32 a notice of disqualification, an actuary who is aggrieved by the disqualification may request
2.33 a hearing to be conducted in accordance with chapter 14. Based on a review of the actuarial
2.34 report, the commissioner of commerce may require an increase in the minimum security
2.35 deposit in an amount the commissioner considers sufficient.

3.1 In addition, the Minnesota self-insurers' security fund may, at its sole discretion and
3.2 cost, undertake an independent actuarial review or an actuarial study of a private self-insurer's
3.3 estimated future liability as defined in this subdivision. The review or study must be
3.4 conducted by an associate or fellow of the Casualty Actuarial Society. The actuary has the
3.5 right to receive and review data and information of the self-insurer necessary for the actuary
3.6 to complete its review or study. A copy of this report must be filed with the commissioner
3.7 and a copy must be furnished to the self-insurer.

3.8 Estimated future liability is determined by first taking the total amount of the self-insured's
3.9 future liability of workers' compensation claims and then deducting the total amount which
3.10 is estimated to be returned to the self-insurer from any specific excess insurance coverage,
3.11 aggregate excess insurance coverage, and any supplementary benefits or second injury
3.12 benefits which are estimated to be reimbursed by the special compensation fund. However,
3.13 in the determination of estimated future liability, the actuary for the self-insurer shall not
3.14 take a credit for any excess insurance or reinsurance which is provided by a captive insurance
3.15 company which is wholly owned by the self-insurer. The opinion may discount liabilities
3.16 to present value at a rate up to the lesser of four percent per annum, or the average of the
3.17 applicable federal midterm rates, based on annual compounding, as published by the United
3.18 States Secretary of the Treasury under United States Code, title 26, section 1274(d), for the
3.19 12 months preceding the valuation date of the report. Supplementary benefits or second
3.20 injury benefits will not be reimbursed by the special compensation fund unless the special
3.21 compensation fund assessment pursuant to section 176.129 is paid and the reports required
3.22 thereunder are filed with the special compensation fund. In the case of surety bonds, bonds
3.23 shall secure administrative and legal costs in addition to the liability for payment of
3.24 compensation reflected on the face of the bond. In no event shall the security be less than
3.25 the last retention limit selected by the self-insurer with the Workers' Compensation
3.26 Reinsurance Association, provided that the commissioner may allow former members to
3.27 post less than the Workers' Compensation Reinsurance Association retention level if that
3.28 amount is adequate to secure payment of the self-insurers' estimated future liability, as
3.29 defined in this subdivision, including payment of claims, administrative and legal costs,
3.30 and unpaid assessments required by section 79A.12, subdivision 2. The posting or depositing
3.31 of security pursuant to this section shall release all previously posted or deposited security
3.32 from any obligations under the posting or depositing and any surety bond so released shall
3.33 be returned to the surety. Any other security shall be returned to the depositor or the person
3.34 posting the bond.

4.1 As a condition for the granting or renewing of a certificate to self-insure, the
4.2 commissioner may require a private self-insurer to furnish any additional security the
4.3 commissioner considers sufficient to insure payment of all claims under chapter 176.

4.4 **EFFECTIVE DATE.** This section is effective January 1, 2021, and applies to actuarial
4.5 opinions with a valuation date on or after that date.

4.6 Sec. 3. Minnesota Statutes 2018, section 79A.06, subdivision 5, is amended to read:

4.7 Subd. 5. **Private employers who have ceased to be self-insured.** (a) Private employers
4.8 who have ceased to be private self-insurers shall discharge their continuing obligations to
4.9 secure the payment of compensation which is accrued during the period of self-insurance,
4.10 for purposes of Laws 1988, chapter 674, sections 1 to 21, by compliance with all of the
4.11 following obligations of current certificate holders:

4.12 (1) Filing reports with the commissioner to carry out the requirements of this chapter;

4.13 (2) Depositing and maintaining a security deposit for accrued liability for the payment
4.14 of any compensation which may become due, pursuant to chapter 176. However, if a private
4.15 employer who has ceased to be a private self-insurer purchases an insurance policy from
4.16 an insurer authorized to transact workers' compensation insurance in this state which provides
4.17 coverage of all claims for compensation arising out of injuries occurring during the entire
4.18 period the employer was self-insured, whether or not reported during that period, the policy
4.19 will:

4.20 (i) discharge the obligation of the employer to maintain a security deposit for the payment
4.21 of the claims covered under the policy;

4.22 (ii) discharge any obligation which the self-insurers' security fund has or may have for
4.23 payment of all claims for compensation arising out of injuries occurring during the period
4.24 the employer was self-insured, whether or not reported during that period; and

4.25 (iii) discharge the obligations of the employer to pay any future assessments to the
4.26 self-insurers' security fund; provided, however, that a member that terminates its
4.27 self-insurance authority on or after August 1, 2010, shall be liable for an assessment under
4.28 paragraph (b). The actuarial opinion shall not take into consideration any transfer of the
4.29 member's liabilities to an insurance policy if the member obtains a replacement policy as
4.30 described in this subdivision within one year of the date of terminating its self-insurance.

4.31 A private employer who has ceased to be a private self-insurer may instead buy an
4.32 insurance policy described above, except that it covers only a portion of the period of time
4.33 during which the private employer was self-insured; purchase of such a policy discharges

5.1 any obligation that the self-insurers' security fund has or may have for payment of all claims
5.2 for compensation arising out of injuries occurring during the period for which the policy
5.3 provides coverage, whether or not reported during that period.

5.4 A policy described in this clause may not be issued by an insurer unless it has previously
5.5 been approved as to the insurer, form, and substance by the commissioner; and

5.6 (3) Paying within 30 days all assessments of which notice is sent by the security fund,
5.7 for a period of seven years from the last day its certificate of self-insurance was in effect.
5.8 Thereafter, the private employer who has ceased to be a private self-insurer may either: (i)
5.9 continue to pay within 30 days all assessments of which notice is sent by the security fund
5.10 until it has no incurred liabilities for the payment of compensation arising out of injuries
5.11 during the period of self-insurance; or (ii) pay the security fund a cash payment equal to
5.12 four percent of the net present value of all remaining incurred liabilities for the payment of
5.13 compensation under sections 176.101 and 176.111 as certified by a member of the casualty
5.14 actuarial society. Assessments shall be based on the benefits paid by the employer during
5.15 the calendar year immediately preceding the calendar year in which the employer's right to
5.16 self-insure is terminated or withdrawn.

5.17 (b) With respect to a self-insurer who terminates its self-insurance authority after April
5.18 1, 1998, that member shall obtain and file with the commissioner an actuarial opinion of
5.19 its outstanding liabilities as determined by an associate or fellow of the Casualty Actuarial
5.20 Society within 120 days of the date of its termination. If the actuarial opinion is not timely
5.21 filed, the self-insurers' security fund may, at its discretion, engage the services of an actuary
5.22 for this purpose. The expense of this actuarial opinion must be assessed against and be the
5.23 obligation of the self-insurer. The commissioner may issue a certificate of default against
5.24 the self-insurer for failure to pay this assessment to the self-insurers' security fund as provided
5.25 by section 79A.04, subdivision 9. ~~The opinion may discount liabilities up to four percent~~
5.26 ~~per annum to net present value~~ actuarial opinion must not apply a present value discount in
5.27 computing future liabilities. Within 60 days after notification of approval of the actuarial
5.28 opinion by the commissioner, the exiting member shall pay to the security fund an amount
5.29 determined as follows: a percentage will be determined by dividing the security fund's
5.30 members' deficit as determined by the most recent audited financial statement of the security
5.31 fund by the total actuarial liability of all members of the security fund as calculated by the
5.32 commissioner within 30 days of the exit date of the member. This quotient will then be
5.33 multiplied by that exiting member's total future liability as contained in the exiting member's
5.34 actuarial opinion. If the payment is not made within 30 days of the notification, interest on

6.1 it at the rate prescribed by section 549.09 must be paid by the former member to the security
6.2 fund until the principal amount is paid in full.

6.3 (c) A former member who terminated its self-insurance authority before April 1, 1998,
6.4 who has paid assessments to the self-insurers' security fund for seven years, and whose
6.5 annualized assessment is \$15,000 or less, may buy out of its outstanding liabilities to the
6.6 self-insurers' security fund by an amount calculated as follows: 1.35 multiplied by the
6.7 indemnity case reserves at the time of the calculation, multiplied by the then current
6.8 self-insurers' security fund annualized assessment rate.

6.9 (d) A former member who terminated its self-insurance authority before April 1, 1998,
6.10 and who is paying assessments within the first seven years after ceasing to be self-insured
6.11 under paragraph (a), clause (3), may elect to buy out its outstanding liabilities to the
6.12 self-insurers' security fund by obtaining and filing with the commissioner an actuarial
6.13 opinion of its outstanding liabilities as determined by an associate or fellow of the Casualty
6.14 Actuarial Society. The opinion must separate liability for indemnity benefits from liability
6.15 for medical benefits, ~~and must discount each up to four percent per annum to net present~~
6.16 ~~value~~. Within 30 days after notification of approval of the actuarial opinion by the
6.17 commissioner, the member shall pay to the security fund an amount equal to 120 percent
6.18 of that discounted outstanding indemnity liability, multiplied by the greater of the average
6.19 annualized assessment rate since inception of the security fund or the annual rate at the time
6.20 of the most recent assessment.

6.21 (e) A former member who has paid the security fund according to paragraphs (b) to (d)
6.22 and subsequently receives authority from the commissioner to again self-insure shall be
6.23 assessed under section 79A.12, subdivision 2, only on indemnity benefits paid on injuries
6.24 that occurred after the former member received authority to self-insure again; provided that
6.25 the member furnishes verified data regarding those benefits to the security fund.

6.26 (f) In addition to proceedings to establish liabilities and penalties otherwise provided, a
6.27 failure to comply may be the subject of a proceeding before the commissioner. An appeal
6.28 from the commissioner's determination may be taken pursuant to the contested case
6.29 procedures of chapter 14 within 30 days of the commissioner's written determination.

6.30 Any current or past member of the self-insurers' security fund is subject to service of
6.31 process on any claim arising out of chapter 176 or this chapter in the manner provided by
6.32 section 5.25, or as otherwise provided by law. The issuance of a certificate to self-insure to
6.33 the private self-insured employer shall be deemed to be the agreement that any process

7.1 which is served in accordance with this section shall be of the same legal force and effect
7.2 as if served personally within this state.

7.4 Subd. 13. **Common claims fund; five-year exception.** For commercial group
7.5 self-insurers who have been in existence for five years or more, a level of funding in the
7.6 common claims fund must be maintained at not less than the greater of either:

7.7 (1) one year's claim losses paid in the most recent year; or

7.8 (2) one-third of the security deposit posted with the Department of Commerce according
7.9 to section 79A.24, subdivision 2.

7.10 ~~This provision supersedes any requirements under subdivisions 11 and 12 and Minnesota~~
7.11 ~~Rules, part 2780.5000.~~

7.12 Sec. 5. Minnesota Statutes 2018, section 79A.24, subdivision 2, is amended to read:

7.13 Subd. 2. **Minimum deposit.** The minimum deposit is 125 percent of the commercial
7.14 self-insurance group's estimated future liability for the payment of compensation as
7.15 determined by an actuary. If the group has been in existence for three years, this minimum
7.16 deposit shall be 110 percent of the commercial self-insurance group's estimated future
7.17 liability for the payment of workers' compensation as determined by an actuary. Each
7.18 actuarial study shall include a projection of future losses during a one-year period until the
7.19 next scheduled actuarial study, less payments anticipated to be made during that time. The
7.20 opinion may discount liabilities to present value at a rate up to the lesser of four percent per
7.21 annum, or the average of the applicable federal midterm rates, based on annual compounding,
7.22 as published by the United States Secretary of the Treasury under United States Code, title
7.23 26, section 1274(d), for the 12 months preceding the valuation date of the report. Deduction
7.24 should be made for the total amount which is estimated to be returned to the commercial
7.25 self-insurance group from any specific excess insurance coverage, aggregate excess insurance
7.26 coverage, and any supplementary benefits which are estimated to be reimbursed by the
7.27 special compensation fund. Supplementary benefits will not be reimbursed by the special
7.28 compensation fund unless the special compensation fund assessment pursuant to section
7.29 176.129 is paid and the required reports are filed with the special compensation fund. In
7.30 the case of surety bonds, bonds shall secure administrative and legal costs in addition to the
7.31 liability for payment of compensation reflected on the face of the bond. In no event shall
7.32 the security be less than the group's selected retention limit of the Workers' Compensation
7.33 Reinsurance Association. The posting or depositing of security under this section shall

8.1 release all previously posted or deposited security from any obligations under the posting
8.2 or depositing and any surety bond so released shall be returned to the surety. Any other
8.3 security shall be returned to the depositor or the person posting the bond.

8.4 **EFFECTIVE DATE.** This section is effective January 1, 2021, and applies to actuarial
8.5 opinions with a valuation date on or after that date.

8.6 Sec. 6. Minnesota Statutes 2018, section 176.011, subdivision 15, as amended by Laws
8.7 2020, chapter 72, section 1, is amended to read:

8.8 Subd. 15. **Occupational disease.** (a) "Occupational disease" means a mental impairment
8.9 as defined in paragraph (d) or physical disease arising out of and in the course of employment
8.10 peculiar to the occupation in which the employee is engaged and due to causes in excess of
8.11 the hazards ordinary of employment and shall include undulant fever. Physical stimulus
8.12 resulting in mental injury and mental stimulus resulting in physical injury shall remain
8.13 compensable. Mental impairment is not considered a disease if it results from a disciplinary
8.14 action, work evaluation, job transfer, layoff, demotion, promotion, termination, retirement,
8.15 or similar action taken in good faith by the employer. Ordinary diseases of life to which the
8.16 general public is equally exposed outside of employment are not compensable, except where
8.17 the diseases follow as an incident of an occupational disease, or where the exposure peculiar
8.18 to the occupation makes the disease an occupational disease hazard. A disease arises out of
8.19 the employment only if there be a direct causal connection between the conditions under
8.20 which the work is performed and if the occupational disease follows as a natural incident
8.21 of the work as a result of the exposure occasioned by the nature of the employment. An
8.22 employer is not liable for compensation for any occupational disease which cannot be traced
8.23 to the employment as a direct and proximate cause and is not recognized as a hazard
8.24 characteristic of and peculiar to the trade, occupation, process, or employment or which
8.25 results from a hazard to which the worker would have been equally exposed outside of the
8.26 employment.

8.27 (b) If immediately preceding the date of disablement or death, an employee was employed
8.28 on active duty with an organized fire or police department of any municipality, as a member
8.29 of the Minnesota State Patrol, conservation officer service, state crime bureau, as a forest
8.30 officer by the Department of Natural Resources, state correctional officer or security
8.31 counselor employed by the state or a political subdivision at a corrections, detention, or
8.32 secure treatment facility, or sheriff or full-time deputy sheriff of any county, and the disease
8.33 is that of myocarditis, coronary sclerosis, pneumonia or its sequel, and at the time of
8.34 employment such employee was given a thorough physical examination by a licensed doctor

9.1 of medicine, and a written report thereof has been made and filed with such organized fire
9.2 or police department, with the Minnesota State Patrol, conservation officer service, state
9.3 crime bureau, Department of Natural Resources, Department of Corrections, or sheriff's
9.4 department of any county, which examination and report negated any evidence of
9.5 myocarditis, coronary sclerosis, pneumonia or its sequel, the disease is presumptively an
9.6 occupational disease and shall be presumed to have been due to the nature of employment.
9.7 If immediately preceding the date of disablement or death, any individual who by nature
9.8 of their position provides emergency medical care, or an employee who was employed as
9.9 a licensed police officer under section 626.84, subdivision 1; firefighter; paramedic; state
9.10 correctional officer or security counselor employed by the state or a political subdivision
9.11 at a corrections, detention, or secure treatment facility; emergency medical technician; or
9.12 licensed nurse providing emergency medical care; and who contracts an infectious or
9.13 communicable disease to which the employee was exposed in the course of employment
9.14 outside of a hospital, then the disease is presumptively an occupational disease and shall
9.15 be presumed to have been due to the nature of employment and the presumption may be
9.16 rebutted by substantial factors brought by the employer or insurer. Any substantial factors
9.17 which shall be used to rebut this presumption and which are known to the employer or
9.18 insurer at the time of the denial of liability shall be communicated to the employee on the
9.19 denial of liability.

9.20 (c) A firefighter on active duty with an organized fire department who is unable to
9.21 perform duties in the department by reason of a disabling cancer of a type caused by exposure
9.22 to heat, radiation, or a known or suspected carcinogen, as defined by the International
9.23 Agency for Research on Cancer, and the carcinogen is reasonably linked to the disabling
9.24 cancer, is presumed to have an occupational disease under paragraph (a). If a firefighter
9.25 who enters the service after August 1, 1988, is examined by a physician prior to being hired
9.26 and the examination discloses the existence of a cancer of a type described in this paragraph,
9.27 the firefighter is not entitled to the presumption unless a subsequent medical determination
9.28 is made that the firefighter no longer has the cancer.

9.29 (d) For the purposes of this chapter, "mental impairment" means a diagnosis of
9.30 post-traumatic stress disorder by a licensed psychiatrist or psychologist. For the purposes
9.31 of this chapter, "post-traumatic stress disorder" means the condition as described in the most
9.32 recently published edition of the Diagnostic and Statistical Manual of Mental Disorders by
9.33 the American Psychiatric Association. For purposes of section 79.34, subdivision 2, one or
9.34 more compensable mental impairment claims arising out of a single event or occurrence
9.35 shall constitute a single loss occurrence.

10.1 (e) If, preceding the date of disablement or death, an employee who was employed on
10.2 active duty as: a licensed police officer; a firefighter; a paramedic; an emergency medical
10.3 technician; a licensed nurse employed to provide emergency medical services outside of a
10.4 medical facility; a public safety dispatcher; ~~an~~ a correctional officer or security counselor
10.5 employed by the state or a political subdivision at a corrections, detention, or secure treatment
10.6 facility; a sheriff or full-time deputy sheriff of any county; or a member of the Minnesota
10.7 State Patrol is diagnosed with a mental impairment as defined in paragraph (d), and had not
10.8 been diagnosed with the mental impairment previously, then the mental impairment is
10.9 presumptively an occupational disease and shall be presumed to have been due to the nature
10.10 of employment. This presumption may be rebutted by substantial factors brought by the
10.11 employer or insurer. Any substantial factors that are used to rebut this presumption and that
10.12 are known to the employer or insurer at the time of the denial of liability shall be
10.13 communicated to the employee on the denial of liability. The mental impairment is not
10.14 considered an occupational disease if it results from a disciplinary action, work evaluation,
10.15 job transfer, layoff, demotion, promotion, termination, retirement, or similar action taken
10.16 in good faith by the employer.

10.17 (f) Notwithstanding paragraph (a) and the rebuttable presumption for infectious or
10.18 communicable diseases in paragraph (b), an employee who contracts COVID-19 is presumed
10.19 to have an occupational disease arising out of and in the course of employment if the
10.20 employee satisfies the requirements of clauses (1) and (2).

10.21 (1) The employee was employed as a licensed peace officer under section 626.84,
10.22 subdivision 1; firefighter; paramedic; nurse or health care worker, correctional officer, or
10.23 security counselor employed by the state or a political subdivision at a corrections, detention,
10.24 or secure treatment facility; emergency medical technician; a health care provider, nurse,
10.25 or assistive employee employed in a health care, home care, or long-term care setting, with
10.26 direct COVID-19 patient care or ancillary work in COVID-19 patient units; and workers
10.27 required to provide child care to first responders and health care workers under Executive
10.28 Order 20-02 and Executive Order 20-19.

10.29 (2) The employee's contraction of COVID-19 must be confirmed by a positive laboratory
10.30 test or, if a laboratory test was not available for the employee, as diagnosed and documented
10.31 by the employee's licensed physician, licensed physician's assistant, or licensed advanced
10.32 practice registered nurse (APRN), based on the employee's symptoms. A copy of the positive
10.33 laboratory test or the written documentation of the physician's, physician assistant's, or
10.34 APRN's diagnosis shall be provided to the employer or insurer.

Subd. 6. **Financial statements.** No employer shall be required to provide financial statements certified by an "independent certified public accountant" or "certified public accountant" as a condition of approval for group self-insurance.
