- (d) For individuals with two qualifying children, the credit equals <u>11 14</u> percent of the first <u>\$19,600 \$19,000</u> of earned income. The credit is reduced by <u>10.5 10.75</u> percent of earned income or adjusted gross income, whichever is greater, in excess of the phaseout threshold, but in no case is the credit less than zero.
- (e) For individuals with three or more qualifying children, the credit equals 12.5 15 percent of the first \$20,000 of earned income. The credit is reduced by 10.5 11.5 percent of earned income or adjusted gross income, whichever is greater, in excess of the phaseout threshold, but in no case is the credit less than zero.
