BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **[80E.041] WARRANTY OBLIGATIONS TO DEALERS.**

Subdivision 1. **Requirements.** Each new motor vehicle manufacturer shall specify in writing to each of its new motor vehicle dealers licensed in this state the dealer's obligations for preparation, delivery, and warranty service on its products. The manufacturer shall compensate the new motor vehicle dealer for warranty service parts and labor required of the new motor vehicle dealer by the manufacturer. Compensation for parts used in warranty service must include the motor vehicle dealer's actual cost of the part plus a reasonable percentage markup or be calculated as described in subdivision 2 at the election of the dealer. Compensation for labor used in warranty service must be reasonable and may at the election of the dealer be determined as described in subdivision 4. This section applies to all warranty repair service performed by the dealer for the manufacturer or with the approval of the manufacturer and for which the dealer is entitled to compensation or reimbursement from the manufacturer.

Subd. 2. **Retail rate for parts.** (a) The dealer may establish a percentage markup to be applied to the cost of warranty parts by submitting 100 sequential nonwarranty customer-paid service repair orders to the manufacturer which contain warranty-like repairs, or 90 consecutive days of nonwarranty customer-paid service repair orders which contain

2.1 warranty-like repairs, whichever is less, covering repairs made no more than 180 days before
2.2 the submission.

2.3 (b) A dealer's retail rate for parts shall be calculated by determining the dealer's total
2.4 parts sales in the submitted service repair orders under paragraph (a) and dividing that
2.5 amount by the dealer's total cost to purchase the parts, subtracting one from that amount,
2.6 and then multiplying by 100. A manufacturer may disapprove a dealer's retail rate if:

2.7 (1) the disapproval is provided to the dealer in writing;

2.8 (2) the disapproval is sent to the dealer within 30 days of the submission of the retail
2.9 rate by the dealer to the manufacturer;

2.10 (3) the disapproval includes a reasonable substantiation that the retail rate submission
2.11 is inaccurate, incomplete, or unreasonable in light of a comparison to the retail rate charged
2.12 by other similarly situated franchised motor vehicle dealers in a comparable geographic
2.13 area in the state offering the same line-make of vehicles; and

2.14 (4) the manufacturer proposes an adjustment of the retail rate.

2.15 (c) If a manufacturer fails to approve or disapprove the retail rate within this time period,
2.16 the retail rate is approved. If a manufacturer disapproves a dealer's retail rate, and the dealer
2.17 does not agree to the manufacturer's proposed adjustment, the parties shall use the
2.18 manufacturer's internal dispute resolution procedure, if any, within a reasonable time after
2.19 the dealer notifies the manufacturer of their failure to agree. If the manufacturer's internal
2.20 dispute resolution procedure is unsuccessful, or if the procedure is not implemented within
2.21 a reasonable time after the dealer notifies the manufacturer of their failure to agree, the
2.22 dealer may use the civil remedies available under section 80E.17. A dealer must file a civil
2.23 suit under section 80E.17, as permitted by this subdivision, within 60 days of receiving the
2.24 manufacturer's proposed adjustment to the retail rate, or the conclusion of the manufacturer's
2.25 internal dispute resolution procedure, whichever is later.

2.26 (d) Charges for the following do not qualify as warranty-like repairs and are excluded
2.27 from the calculations under this subdivision and subdivision 4:

2.28 (1) repairs including parts and labor for manufacturer or distributor special events,
2.29 specials, or promotional discounts for retail customer repairs;

2.30 (2) parts sold at wholesale;

2.31 (3) engine assemblies and transmission assemblies if the new motor vehicle dealer agrees
2.32 to be compensated for those assemblies with a handling charge instead of a retail parts
2.33 markup;

3.1 (4) parts and labor to perform routine maintenance generally performed at predetermined
3.2 intervals to keep a vehicle operating properly and not covered under any retail customer
3.3 warranty, such as fluids, filters, and belts not provided in the course of repairs;

3.4 (5) nuts, bolts, fasteners, and similar items that do not have an individual part number;

3.5 (6) tires and labor to install or repair;

3.6 (7) parts and labor to perform vehicle reconditioning; and

3.7 (8) accessories.

3.8 Subd. 3. **Parts at no cost or reduced cost.** If a manufacturer furnishes a new part to a
3.9 dealer at no cost or at a reduced cost for use in performing repairs under this section, the
3.10 manufacturer shall compensate the dealer the amount paid for the part, if any, plus an amount
3.11 equal to the dealer's established percentage markup multiplied by the fair wholesale value
3.12 of the part. The fair wholesale value of the part is the maximum of:

3.13 (1) the amount the dealer paid for the part or a substantially identical part if already
3.14 owned by the dealer;

3.15 (2) the cost of the part shown in a current manufacturer's established price schedule; and

3.16 (3) the cost of a substantially identical part shown in a current manufacturer's established
3.17 price schedule.

3.18 Subd. 4. **Retail rate for labor.** (a) Compensation for warranty labor must equal the
3.19 dealer's effective nonwarranty labor rate multiplied by the time allowances recognized by
3.20 the manufacturer to compensate its dealers for warranty work. The effective nonwarranty
3.21 labor rate is determined by dividing the total customer labor charges for qualifying
3.22 nonwarranty repairs in the repair orders submitted under subdivision 2 by the total number
3.23 of labor hours that generated those sales. Compensation for warranty labor must include
3.24 reasonable diagnostic time for repairs performed under this section.

3.25 (b) A manufacturer may disapprove a dealer's effective nonwarranty labor rate if:

3.26 (1) the disapproval is provided to the dealer in writing;

3.27 (2) the disapproval is sent to the dealer within 30 days of the submission of the effective
3.28 nonwarranty labor rate by the dealer to the manufacturer;

3.29 (3) the disapproval includes a reasonable substantiation that the effective nonwarranty
3.30 labor rate submission is inaccurate, incomplete, or unreasonable in light of a comparison
3.31 to the retail rate charged by other similarly situated franchised motor vehicle dealers in a
3.32 comparable geographic area in the state offering the same line-make vehicles; and

4.1 (4) the manufacturer proposes an adjustment of the effective nonwarranty labor rate.

4.2 (c) If a manufacturer fails to approve or disapprove the rate within this time period, the
4.3 rate is approved. If a manufacturer disapproves a dealer's effective nonwarranty labor rate,
4.4 and the dealer does not agree to the manufacturer's proposed adjustment, the parties shall
4.5 use the manufacturer's internal dispute resolution procedure, if any, within a reasonable
4.6 time after the dealer notifies the manufacturer of their failure to agree. If the manufacturer's
4.7 internal dispute resolution procedure is unsuccessful, or if the procedure is not implemented
4.8 within a reasonable time after the dealer notifies the manufacturer of their failure to agree,
4.9 the dealer may use the civil remedies available under section 80E.17. A dealer must file a
4.10 civil suit under section 80E.17, as permitted by this subdivision, within 60 days of receiving
4.11 the manufacturer's proposed adjustment to the effective nonwarranty labor rate, or the
4.12 conclusion of the manufacturer's internal dispute resolution procedure, whichever is later.

4.13 Subd. 5. **Time for establishing rate.** A dealer shall not be permitted to establish a retail
4.14 rate for parts or labor more than once per year.

4.15 Subd. 6. **Requirements for cost recovery.** (a) Except as provided under paragraph (b),
4.16 a manufacturer shall not otherwise recover its costs under this section from dealers within
4.17 this state, including but not limited to a surcharge imposed on a dealer, solely intended to
4.18 recover the cost of reimbursing a dealer for parts and labor pursuant to this section.

4.19 (b) A manufacturer may recover its cost for reimbursing a dealer for parts and labor
4.20 pursuant to this section if:

4.21 (1) the manufacturer provides written notice at least 60 days in advance of the
4.22 implementation of cost recovery;

4.23 (2) the notice includes substantiation of the reasonableness of the cost recovery to be
4.24 implemented, including by reference to a comparison to the retail rate charged by other
4.25 similarly situated franchised motor vehicle dealers in a comparable geographic area in the
4.26 state offering the same line-make of vehicles.

4.27 If the dealer does not agree to the amount of the manufacturer's cost recovery, the parties
4.28 shall use the manufacturer's internal dispute resolution procedure, if any, within a reasonable
4.29 time after the dealer notifies the manufacturer of its failure to agree. If the dealer is not
4.30 satisfied with the result of the manufacturer's internal dispute resolution procedure or if,
4.31 due to the manufacturer, the procedure is not initiated within a reasonable time after the
4.32 dealer notifies the manufacturer of its failure to agree, the dealer may file a civil suit under
4.33 section 80E.17, as permitted by this subdivision, within 60 days of receiving the notice that

5.1 cost recovery will be implemented, or the conclusion of the manufacturer's internal dispute
5.2 resolution procedure, whichever is later.

5.3 (c) Cost recovery must not be implemented by a manufacturer pending conclusion of
5.4 the process set forth under paragraph (b) in the case of dealer disagreement with the amount
5.5 of cost recovery. If cost recovery is allowed at the conclusion of such process, it may be
5.6 implemented retroactively from the date provided in the notice given under paragraph (b),
5.7 clause (1).

5.8 (d) As an alternative to the dispute resolution process in paragraph (b), or during the
5.9 pendency of the dispute resolution process in paragraph (b), the dealer may reduce its retail
5.10 rate and request that the manufacturer recalculate the amount of cost recovery or abandon
5.11 the implementation of cost recovery.

5.12 (e) Nothing in this subdivision prohibits a manufacturer from increasing prices for
5.13 vehicles or parts in the normal course of business.

5.14 Subd. 7. **Fewer than five dealers in state.** If a manufacturer has fewer than five dealers
5.15 in the state offering the same line-make of vehicle, the comparisons set forth in subdivision
5.16 2, paragraph (b), clause (3); subdivision 4, paragraph (b), clause (3); and subdivision 6,
5.17 paragraph (b), clause (2), may be made by reference to similarly situated franchised motor
5.18 vehicle dealers in a comparable geographic area in the United States offering the same
5.19 line-make of vehicle.

5.20 Subd. 8. **Payment of claims.** (a) All claims made by new motor vehicle dealers under
5.21 this section for labor and parts must be paid within 30 days of their approval. Claims must
5.22 be either approved or disapproved within 30 days after they are submitted to the manufacturer
5.23 in the manner and on the forms it prescribes. Any claims not specifically disapproved in
5.24 writing within 30 days after the manufacturer receives them are deemed to be approved and
5.25 payment must follow within 30 days, provided, however, that the manufacturer retains the
5.26 right to audit the claims for a period of one year and to charge back any amounts paid on
5.27 claims not reasonably substantiated or fraudulent claims. The manufacturer has the burden
5.28 of proving that a claim is not reasonably substantiated or fraudulent.

5.29 (b) The audit and charge back provisions of this subdivision also apply to all other
5.30 incentive and reimbursement programs that are subject to audit by the manufacturer.

5.31 (c) A manufacturer shall not deny a claim submitted under this section or charge back
5.32 a claim or payment based solely on the dealer's incidental failure to comply with a claim
5.33 processing procedure, a clerical error, or other administrative technicality, provided that
5.34 the failure does not call into question the legitimacy of the claim. The manufacturer shall

6.1 allow the dealer to resubmit the claim according to reasonable guidelines not later than 30
6.2 days after the dealer receives notice of the initial claim denial or charge back.

6.3 Subd. 9. **Product liability; limitation.** As between the dealer and the manufacturer, the
6.4 obligations imposed by this section constitute the dealer's only responsibility for product
6.5 liability based in whole or in part on strict liability in tort.

6.6 Subd. 10. **Definitions.** For purposes of this section, the term "manufacturer" includes
6.7 "distributor" and includes manufacturers and distributors of motor vehicle engines. Dealer
6.8 includes dealers of new motor vehicles and motor vehicle engines.

6.9 Subd. 11. **Violations.** It is a violation of this section for any new motor vehicle
6.10 manufacturer to fail to perform any warranty obligations that it undertakes under the motor
6.11 vehicle manufacturer's warranty.

6.12 Sec. 2. **[80E.045] RECALL REPAIRS; MANUFACTURER AND DEALER**
6.13 **OBLIGATIONS.**

6.14 Subdivision 1. **Requirements.** (a) A manufacturer shall compensate its new motor
6.15 vehicle dealers for all labor and parts required to perform recall repairs. Compensation for
6.16 recall repairs must be reasonable and be consistent with section 80E.041. If parts or a remedy
6.17 are not reasonably available to perform a recall service or repair on a vehicle held for sale
6.18 by a dealer authorized to sell new motor vehicles of the same line-make within 30 days of
6.19 the manufacturer issuing the initial notice of recall to the new motor vehicle dealer and the
6.20 manufacturer has issued a stop-sale or do-not-drive order on the vehicle, the manufacturer
6.21 shall compensate the dealer at a prorated rate of at least 1.25 percent of the value of the
6.22 vehicle per month beginning on the later of either the date that is 30 days after the date on
6.23 which the stop-sale or do-not-drive order was provided to the dealer, or the date the vehicle
6.24 was taken into the dealer's used vehicle inventory, until the earlier of either of the following:

6.25 (1) the date the recall or remedy parts are made available; or

6.26 (2) the date the dealer sells, trades, or otherwise disposes of the affected used motor
6.27 vehicle.

6.28 (b) A stop-sale or do-not-drive order means a notification issued by a vehicle
6.29 manufacturer to its franchised dealerships stating that certain used vehicles in inventory
6.30 shall not be sold or leased at retail or wholesale due to a federal safety recall for a defect or
6.31 a noncompliance or a federal emissions recall.

7.1 Subd. 2. Value of vehicle. The value of a used vehicle is the average trade-in value for
7.2 used vehicles as indicated in an independent third-party guide for the year, make, and model
7.3 of the recalled vehicle.

7.4 Subd. 3. Application. This section applies only to:

7.5 (1) used vehicles subject to safety or emissions recalls pursuant to and recalled in
7.6 accordance with federal law and regulations adopted thereunder and where a stop-sale or
7.7 do-not-drive order has been issued and repair parts or remedy remain unavailable for 30
7.8 days or longer; and

7.9 (2) new motor vehicle dealers holding affected used vehicles for sale that are a line-make
7.10 that the dealer is franchised to sell or which the dealer is authorized to perform recall repairs,
7.11 and which:

7.12 (i) are in inventory at the time the "stop-sale" order was issued; or

7.13 (ii) were taken in the used vehicle inventory of the dealer as a consumer trade-in incident
7.14 to the purchase of a new or certified preowned used vehicle from the dealer after the stop-sale
7.15 or do-not-drive order was issued.

7.16 Subd. 4. Violations. Subject to the audit provisions of section 80E.041, it is a violation
7.17 of this section for a manufacturer to reduce the amount of compensation otherwise owed
7.18 to an individual new motor vehicle dealer, whether through a charge back, removal of the
7.19 individual dealer from an incentive program, reduction in amount owed under an incentive
7.20 program, or any other means, solely because the new motor vehicle dealer has submitted a
7.21 claim for reimbursement under this section.

7.22 Subd. 5. Payment of claims. (a) All reimbursement claims made by new motor vehicle
7.23 dealers pursuant to this section for recall remedies or repairs or for compensation where no
7.24 part or repair is reasonably available and the vehicle is subject to a stop-sale or do-not-drive
7.25 order must be subject to the same limitations and requirements as a warranty reimbursement
7.26 claim made under section 80E.041. Claims must be either approved or disapproved within
7.27 30 days after they are submitted to the manufacturer in the manner and on the forms the
7.28 manufacturer reasonably prescribes. All claims shall be paid within 90 days of approval of
7.29 the claim by the manufacturer. Any claim not specifically disapproved in writing within 30
7.30 days after the manufacturer receives them shall be deemed to be approved.

7.31 (b) As an alternative to paragraph (a), a manufacturer may compensate its franchised
7.32 dealers under a national recall compensation program provided the compensation under the

8.1 program is equal to or greater than that provided under subdivision 1, or the manufacturer
8.2 and dealer otherwise agree.

8.3 Subd. 6. **Inventory.** A manufacturer may direct the manner and method in which a new
8.4 motor vehicle dealer must demonstrate the inventory status of an affected used motor vehicle
8.5 to determine eligibility for compensation under this section, provided that the manner and
8.6 method may not be unduly burdensome and may not require information that is unduly
8.7 burdensome to provide.

8.8 Subd. 7. **Total compensation.** Nothing in this section shall require a manufacturer to
8.9 provide total compensation to a new motor vehicle dealer which would exceed the total
8.10 average trade-in value of the affected used motor vehicle.

8.11 Subd. 8. **Exclusive remedy.** Any remedy provided to a new motor vehicle dealer under
8.12 this section is exclusive and may not be combined with any other state or federal remedy.

8.13 Sec. 3. Minnesota Statutes 2016, section 80E.11, subdivision 7, is amended to read:

8.14 Subd. 7. **Succession agreements.** ~~Notwithstanding the foregoing,~~ A new motor vehicle
8.15 dealer may apply to a manufacturer, distributor, or factory branch to designate a proposed
8.16 dealer operator as a successor dealer to be established in the event of the death or incapacity
8.17 of the new motor vehicle dealer. A manufacturer, distributor, or factory branch may not
8.18 deny the proposed successor unless the proposed change would result in executive
8.19 management control by a person who is not of good moral character or who does not meet
8.20 the franchisor's existing reasonable capital standards or does not meet the franchisor's
8.21 uniformly applied minimum business experience standards to be a franchised new motor
8.22 vehicle dealer. If a manufacturer, distributor, or factory branch determines to deny a dealer's
8.23 application to name a successor, such denial must be in writing, must offer an explanation
8.24 of the grounds for the denial addressing the criteria contained in this subdivision, and must
8.25 be delivered to the new motor vehicle dealer within 90 days after the manufacturer,
8.26 distributor, or factory branch receives the completed application or documents customarily
8.27 used by the manufacturer, distributor, or factory branch for dealer actions described in this
8.28 subdivision. If a denial that meets the requirements of this subdivision is not sent within
8.29 the 90-day period, the manufacturer, distributor, or factory branch shall be deemed to have
8.30 given its consent to the proposed successor. In the event the new motor vehicle dealer and
8.31 franchisor have duly executed an agreement concerning succession rights prior to the dealer's
8.32 death, the agreement shall be observed, even if it designates an individual other than the
8.33 surviving spouse or heirs of the franchised motor vehicle dealer. ~~Notwithstanding the~~
8.34 foregoing, the franchisor shall not be required to accept a successor approved or deemed

9.1 approved under this section if the franchisor can demonstrate that the proposed successor,
9.2 at the time of the succession, would result in executive management control by a person
9.3 who is not of good moral character, or who does not meet the franchisor's existing reasonable
9.4 capital standards, or does not meet the franchisor's uniformly applied minimum business
9.5 experience standards to be a franchised new motor vehicle dealer.

9.6 Sec. 4. Minnesota Statutes 2016, section 80E.13, is amended to read:

9.7 **80E.13 UNFAIR PRACTICES BY MANUFACTURERS, DISTRIBUTORS,**
9.8 **FACTORY BRANCHES.**

9.9 It is unlawful and an unfair practice for a manufacturer, distributor, or factory branch
9.10 to engage in any of the following practices:

9.11 (a) delay, refuse, or fail to deliver new motor vehicles or new motor vehicle parts or
9.12 accessories in reasonable time and in reasonable quantity relative to the new motor vehicle
9.13 dealer's facilities and sales potential in the dealer's relevant market area, after having accepted
9.14 an order from a new motor vehicle dealer having a franchise for the retail sale of any new
9.15 motor vehicle sold or distributed by the manufacturer or distributor, if the new motor vehicle
9.16 or new motor vehicle parts or accessories are publicly advertised as being available for
9.17 delivery or actually being delivered. This clause is not violated, however, if the failure is
9.18 caused by acts or causes beyond the control of the manufacturer;

9.19 (b) refuse to disclose to any new motor vehicle dealer handling the same line make, the
9.20 manner and mode of distribution of that line make within the relevant market area;

9.21 (c) obtain money, goods, service, or any other benefit from any other person with whom
9.22 the dealer does business, on account of, or in relation to, the transaction between the dealer
9.23 and the other person, other than for compensation for services rendered, unless the benefit
9.24 is promptly accounted for, and transmitted to, the new motor vehicle dealer;

9.25 (d) increase prices of new motor vehicles which the new motor vehicle dealer had ordered
9.26 for private retail consumers prior to the dealer's receiving the written official price increase
9.27 notification. A sales contract signed by a private retail consumer shall constitute evidence
9.28 of each order if the vehicle is in fact delivered to that customer. In the event of manufacturer
9.29 price reductions, the amount of any reduction received by a dealer shall be passed on to the
9.30 private retail consumer by the dealer if the retail price was negotiated on the basis of the
9.31 previous higher price to the dealer;

9.32 (e) offer any refunds or other types of inducements to any new motor vehicle dealer for
9.33 the purchase of new motor vehicles of a certain line make without making the same offer

10.1 to all other new motor vehicle dealers in the same line make within geographic areas
10.2 reasonably determined by the manufacturer;

10.3 (f) release to any outside party, except under subpoena or in an administrative or judicial
10.4 proceeding involving the manufacturer or dealer, any business, financial, or personal
10.5 information which may be provided by the dealer to the manufacturer, without the express
10.6 written consent of the dealer or unless pertinent to judicial or governmental administrative
10.7 proceedings or to arbitration proceedings of any kind;

10.8 (g) deny any new motor vehicle dealer the right of free association with any other new
10.9 motor vehicle dealer for any lawful purpose;

10.10 (h) unfairly discriminate among its new motor vehicle dealers with respect to warranty
10.11 reimbursement or authority granted its new vehicle dealers to make warranty adjustments
10.12 with retail customers;

10.13 (i) compete with a new motor vehicle dealer in the same line make operating under an
10.14 agreement or franchise from the same manufacturer, distributor, or factory branch. A
10.15 manufacturer, distributor, or factory branch is considered to be competing when it has an
10.16 ownership interest, other than a passive interest held for investment purposes, in a dealership
10.17 of its line make located within the state. A manufacturer, distributor, or factory branch shall
10.18 not, however, be deemed to be competing when operating a dealership, either temporarily
10.19 or for a reasonable period, which is for sale to any qualified independent person at a fair
10.20 and reasonable price, or when involved in a bona fide relationship in which an independent
10.21 person has made a significant investment subject to loss in the dealership and can reasonably
10.22 expect to acquire full ownership and full management and operational control of the
10.23 dealership within a reasonable time on reasonable terms and conditions;

10.24 (j) prevent a new motor vehicle dealer from transferring or assigning a new motor vehicle
10.25 dealership to a qualified transferee. There shall be no transfer, assignment of the franchise,
10.26 or major change in the executive management of the dealership, except as is otherwise
10.27 provided in sections 80E.01 to 80E.17, without consent of the manufacturer, which shall
10.28 not be withheld without good cause. In determining whether good cause exists for
10.29 withholding consent to a transfer or assignment, the manufacturer, distributor, factory
10.30 branch, or importer has the burden of proving that the transferee is a person who is not of
10.31 good moral character or does not meet the franchisor's existing and reasonable capital

11.7 (1) the franchise agreement permits the manufacturer, distributor, factory branch, or
11.8 importer to exercise a right of first refusal to acquire the franchisee's assets or ownership
11.9 in the event of a proposed sale or transfer;

11.10 (2) the proposed transfer of the dealership or its assets is of more than 50 percent of the
11.11 ownership or assets;

11.12 (3) the manufacturer, distributor, factory branch, or importer notifies the dealer in writing
11.13 within 60 days of its receipt of the complete written proposal for the proposed sale or transfer
11.14 on forms generally utilized by the manufacturer, distributor, factory branch, or importer for
11.15 such purposes and containing the information required therein and all documents and
11.16 agreements relating to the proposed sale or transfer;

11.17 (4) the exercise of the right of first refusal will result in the dealer and dealer's owners
11.18 receiving the same or greater consideration with equivalent terms of sale as is provided in
11.19 the documents and agreements submitted to the manufacturer, distributor, factory branch,

11.21 (5) the proposed change of 50 percent or more of the ownership or of the dealership
11.22 assets does not involve the transfer or sale of assets or the transfer or issuance of stock by
11.23 the dealer or one or more dealer owners to a family member, including a spouse, child,
11.24 stepchild, grandchild, spouse of a child or grandchild, brother, sister, or parent of the dealer
11.25 owner; to a manager who has been employed in the dealership for at least four years and is
11.26 otherwise qualified as a dealer operator; or to a partnership or corporation owned and
11.27 controlled by one or more of such persons; and

11.28 (6) the manufacturer, distributor, factory branch, or importer agrees to pay the reasonable
11.29 expenses, including reasonable attorney fees, which do not exceed the usual customary and
11.30 reasonable fees charged for similar work done for other clients incurred by the proposed
11.31 new owner and transferee before the manufacturer, distributor, factory branch, or importer

12.19 arbitrary and is due to a lack of manufacturing capacity, a strike, labor difficulty, or other

12.21 (n) require a dealer to pay an extra fee, or remodel, renovate, or recondition the dealer's
12.22 existing facilities, or purchase unreasonable advertising displays, training, tools, or other

14.21 approved by the manufacturer, distributor, or factory branch, including any such

80E.04 WARRANTY OBLIGATIONS TO DEALERS.

Subdivision 1. **Requirements.** Each new motor vehicle manufacturer shall specify in writing to each of its new motor vehicle dealers licensed in this state the dealer's obligations for preparation, delivery, and warranty service on its products. The manufacturer shall also compensate the new motor vehicle dealer for warranty service and parts required of the dealer by the manufacturer, and shall provide the dealer the schedule of compensation to be paid the dealer for parts, work, and service in connection with warranty services, and the time allowance for the performance of the work and service. This section applies to all repair services performed by the dealer for the manufacturer or with the approval of the manufacturer and for which the dealer receives compensation or reimbursement from the manufacturer.

Subd. 2. **Reasonable compensation for services.** In no event shall the schedule of compensation fail to include reasonable compensation for diagnostic work, as well as repair service, parts, and labor. Time allowances for the diagnosis and performance of warranty work and service shall be reasonable and adequate for the work to be performed. The hourly labor rate paid to and the reimbursement for parts purchased by a dealer for warranty services shall not be less than the rate charged by the dealer for like service to nonwarranty customers for nonwarranty service and repairs.

Subd. 3. **Violations.** It is a violation of this section for any new motor vehicle manufacturer to fail to: (a) perform any warranty obligations that it undertakes under the motor vehicle manufacturer's warranty; (b) include in written notices of factory recalls to new motor vehicle owners and dealers the expected date by which necessary parts and equipment will be available to dealers for the correction of the defects; or (c) to compensate any of the motor vehicle dealers licensed in this state for repairs effected by a recall.

Subd. 4. **Payment of claims.** All claims made by new motor vehicle dealers pursuant to this section for labor and parts shall be paid within 30 days of their approval. Claims shall be either approved or disapproved within 30 days after they are submitted to the manufacturer in the manner and on the forms it prescribes, and any claims not specifically disapproved in writing within 30 days after the manufacturer receives them shall be construed to be approved and payment must follow within 30 days; provided, however, that the manufacturer retains the right to audit the claims for a period of one year and to charge back any amounts paid on claims not reasonably substantiated or fraudulent claims. The audit and charge back provisions of this subdivision also apply to all other incentive and reimbursement programs that are subject to audit by the manufacturer.

Subd. 5. **Product liability; limitation.** As between the dealer and the manufacturer, the obligations imposed by this section shall constitute the dealer's only responsibility for product liability based in whole or in part on strict liability in tort.

Subd. 6. **Definitions.** For purposes of this section, the terms "manufacturer" and "dealer" include manufacturers and distributors of motor vehicle engines and their dealers.
