1.9	(a) The commissioner of management and budget shall coordinate the development of
1.10	a disparity impact note for any proposed legislation upon request of the chair or ranking
1.11	minority member of any standing committee if it appears enactment could significantly
1.12	increase or decrease disparities. Upon receipt of a request to prepare a disparity impact note,
1.13	the commissioner must notify the authors of the proposed legislation that the request has
1.14	been made. The commissioner may require the commissioner of an administrative state
1.15	agency to supply in a timely manner any information necessary to complete the disparity
1.16	impact note. The disparity impact note must be completed no later than ten days after the
1.17	initial request and must be made available to the public upon request. The commissioner
1.18	shall make a reasonable estimate of whether the proposed legislation will increase or decrease
1.19	disparities and identify any data gaps that impair the commissioner's ability to assess the
1.20	proposed legislation's impact. Upon completion of the disparity impact note, the
