1.6	Subdivision 1. Appropriation. \$40,400,000 is appropriated from the bond proceeds
1.7	fund to the commissioner of transportation for purposes of the port development assistance
1.8	program under Minnesota Statutes, chapter 457A. Any improvements made with the proceeds
1.9	of these grants must be publicly owned.
1.10	Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
