1.9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.10 Section 1. Minnesota Statutes 2019 Supplement, section 245A.05, is amended to read:

1.11 **245A.05 DENIAL OF APPLICATION.**

1.12 (a) The commissioner may deny a license if an applicant or controlling individual:

1.13 (1) fails to submit a substantially complete application after receiving notice from the

1.14 commissioner under section 245A.04, subdivision 1;

1.15 (2) fails to comply with applicable laws or rules;

1.16 (3) knowingly withholds relevant information from or gives false or misleading

1.17 information to the commissioner in connection with an application for a license or during

1.18 an investigation;

1.19 (4) has a disqualification that has not been set aside under section 245C.22 and no

1.20 variance has been granted;

1.21 (5) has an individual living in the household who received a background study under

1.22 section 245C.03, subdivision 1, paragraph (a), clause (2), who has a disqualification that

1.23 has not been set aside under section 245C.22, and no variance has been granted;

2.1 (6) is associated with an individual who received a background study under section
 2.2 245C.03, subdivision 1, paragraph (a), clause (6), who may have unsupervised access to
 2.3 children or vulnerable adults, and who has a disqualification that has not been set aside
 2.4 under section 245C.22, and no variance has been granted;

2.5 (7) fails to comply with section 245A.04, subdivision 1, paragraph (f) or (g);

2.6 (8) fails to demonstrate competent knowledge as required by section 245A.04, subdivision
 2.7 6;

2.8 (9) has a history of noncompliance as a license holder or controlling individual with
 2.9 applicable laws or rules, including but not limited to this chapter and chapters 119B and
 2.10 245C; ~~or~~

2.11 (10) is prohibited from holding a license according to section 245.095; or

2.12 (11) for family child foster care, has nondisqualifying background study information,
 2.13 as described in section 245C.05, subdivision 4, that reflects on the individual's ability to
 2.14 safely provide care to foster children.

2.15 (b) An applicant whose application has been denied by the commissioner must be given
 2.16 notice of the denial, which must state the reasons for the denial in plain language. Notice
 2.17 must be given by certified mail or personal service. The notice must state the reasons the
 2.18 application was denied and must inform the applicant of the right to a contested case hearing
 2.19 under chapter 14 and Minnesota Rules, parts 1400.8505 to 1400.8612. The applicant may
 2.20 appeal the denial by notifying the commissioner in writing by certified mail or personal
 2.21 service. If mailed, the appeal must be postmarked and sent to the commissioner within 20
 2.22 calendar days after the applicant received the notice of denial. If an appeal request is made
 2.23 by personal service, it must be received by the commissioner within 20 calendar days after
 2.24 the applicant received the notice of denial. Section 245A.08 applies to hearings held to
 2.25 appeal the commissioner's denial of an application.

2.26 **EFFECTIVE DATE.** This section is effective July 1, 2021.

2.27 Sec. 2. Minnesota Statutes 2019 Supplement, section 245A.07, subdivision 1, is amended
 2.28 to read:

2.29 Subdivision 1. **Sanctions; appeals; license.** (a) In addition to making a license conditional
 2.30 under section 245A.06, the commissioner may suspend or revoke the license, impose a fine,
 2.31 or secure an injunction against the continuing operation of the program of a license holder
 2.32 who does not comply with applicable law or rule, or who has nondisqualifying background
 2.33 study information, as described in section 245C.05, subdivision 4, that reflects on the license

3.1 holder's ability to safely provide care to foster children. When applying sanctions authorized
 3.2 under this section, the commissioner shall consider the nature, chronicity, or severity of the
 3.3 violation of law or rule and the effect of the violation on the health, safety, or rights of
 3.4 persons served by the program.

3.5 (b) If a license holder appeals the suspension or revocation of a license and the license
 3.6 holder continues to operate the program pending a final order on the appeal, the commissioner
 3.7 shall issue the license holder a temporary provisional license. Unless otherwise specified
 3.8 by the commissioner, variances in effect on the date of the license sanction under appeal
 3.9 continue under the temporary provisional license. If a license holder fails to comply with
 3.10 applicable law or rule while operating under a temporary provisional license, the
 3.11 commissioner may impose additional sanctions under this section and section 245A.06, and
 3.12 may terminate any prior variance. If a temporary provisional license is set to expire, a new
 3.13 temporary provisional license shall be issued to the license holder upon payment of any fee
 3.14 required under section 245A.10. The temporary provisional license shall expire on the date
 3.15 the final order is issued. If the license holder prevails on the appeal, a new nonprovisional
 3.16 license shall be issued for the remainder of the current license period.

3.17 (c) If a license holder is under investigation and the license issued under this chapter is
 3.18 due to expire before completion of the investigation, the program shall be issued a new
 3.19 license upon completion of the reapplication requirements and payment of any applicable
 3.20 license fee. Upon completion of the investigation, a licensing sanction may be imposed
 3.21 against the new license under this section, section 245A.06, or 245A.08.

3.22 (d) Failure to reapply or closure of a license issued under this chapter by the license
 3.23 holder prior to the completion of any investigation shall not preclude the commissioner
 3.24 from issuing a licensing sanction under this section or section 245A.06 at the conclusion
 3.25 of the investigation.

3.26 **EFFECTIVE DATE.** This section is effective July 1, 2021.

 3.28 read:

3.29 **Subd. 9. Licensed family child foster care.** (a) Before recommending to deny a license
 3.30 under section 245A.05 or revoke a license under section 245A.07 for nondisqualifying
 3.31 background study information received under section 245C.05, subdivision 4, paragraph
 3.32 (a), clause (3), for licensed family child foster care a county agency or private agency that
 3.33 has been designated or licensed by the commissioner must review the following:

- 4.1 (1) the type of offense;
- 4.2 (2) the number of offenses;
- 4.3 (3) the nature of the offenses;
- 4.4 (4) the age of the individual at the time of the offense;
- 4.5 (5) the length of time that has elapsed since the last offense;
- 4.6 (6) the relationship of the offenses and the capacity to care for a child;
- 4.7 (7) evidence of rehabilitation;
- 4.8 (8) information or knowledge from community members regarding the individual's
 4.9 capacity to provide foster care;
- 4.10 (9) a statement from the study subject;
- 4.11 (10) a statement from the license holder; and
- 4.12 (11) other aggravating and mitigating factors.

4.13 (b) When licensing a relative to provide family child foster care, the commissioner shall
 4.14 also consider the importance of maintaining the child's relationship with relatives as an
 4.15 additional significant factor in determining whether an application will be denied.

4.16 (c) The county or private licensing agency must send a summary of the review completed
 4.17 according to paragraph (a), on a form developed by the commissioner, to the commissioner
 4.18 and include any recommendation for licensing action.

 4.25 foster residence settings that meet the licensing requirements of Minnesota Rules, parts
 4.26 2960.3200 to 2960.3230.

4.27 **EFFECTIVE DATE.** This section is effective July 1, 2021.

5.1 Sec. 5. Minnesota Statutes 2018, section 245C.05, subdivision 2c, is amended to read:

5.2 Subd. 2c. **Privacy notice to background study subject.** (a) Prior to initiating each
5.3 background study, the entity initiating the study must provide the commissioner's privacy
5.4 notice to the background study subject required under section 13.04, subdivision 2. The
5.5 notice must be available through the commissioner's electronic NETStudy and NETStudy
5.6 2.0 systems and shall include the information in paragraphs (b) and (c).

5.7 (b) The background study subject shall be informed that any previous background studies
5.8 that received a set-aside will be reviewed, and without further contact with the background
5.9 study subject, the commissioner may notify the agency that initiated the subsequent
5.10 background study:

5.11 (1) that the individual has a disqualification that has been set aside for the program or
5.12 agency that initiated the study;

5.13 (2) the reason for the disqualification; and

5.14 (3) that information about the decision to set aside the disqualification will be available
5.15 to the license holder upon request without the consent of the background study subject.

5.16 (c) The background study subject must also be informed that:

5.17 (1) the subject's fingerprints collected for purposes of completing the background study
5.18 under this chapter must not be retained by the Department of Public Safety, Bureau of
5.19 Criminal Apprehension, or by the commissioner. The Federal Bureau of Investigation will
5.20 ~~only retain fingerprints of subjects with a criminal history~~ not retain background study
5.21 subjects' fingerprints;

5.22 (2) effective upon implementation of NETStudy 2.0, the subject's photographic image
5.23 will be retained by the commissioner, and if the subject has provided the subject's Social
5.24 Security number for purposes of the background study, the photographic image will be
5.25 available to prospective employers and agencies initiating background studies under this
5.26 chapter to verify the identity of the subject of the background study;

5.27 (3) the commissioner's authorized fingerprint collection vendor shall, for purposes of
5.28 verifying the identity of the background study subject, be able to view the identifying
5.29 information entered into NETStudy 2.0 by the entity that initiated the background study,
5.30 but shall not retain the subject's fingerprints, photograph, or information from NETStudy
5.31 2.0. The authorized fingerprint collection vendor shall retain no more than the subject's
5.32 name and the date and time the subject's fingerprints were recorded and sent, only as
5.33 necessary for auditing and billing activities;

6.1 (4) the commissioner shall provide the subject notice, as required in section 245C.17,
6.2 subdivision 1, paragraph (a), when an entity initiates a background study on the individual;

6.3 (5) the subject may request in writing a report listing the entities that initiated a
6.4 background study on the individual as provided in section 245C.17, subdivision 1, paragraph
6.5 (b);

6.6 (6) the subject may request in writing that information used to complete the individual's
6.7 background study in NETStudy 2.0 be destroyed if the requirements of section 245C.051,
6.8 paragraph (a), are met; and

6.9 (7) notwithstanding clause (6), the commissioner shall destroy:

6.10 (i) the subject's photograph after a period of two years when the requirements of section
6.11 245C.051, paragraph (c), are met; and

6.12 (ii) any data collected on a subject under this chapter after a period of two years following
6.13 the individual's death as provided in section 245C.051, paragraph (d).

6.14 Sec. 6. Minnesota Statutes 2018, section 245C.05, subdivision 2d, is amended to read:

6.15 Subd. 2d. **Fingerprint data notification.** The commissioner of human services shall
6.16 notify all background study subjects under this chapter that the Department of Human
6.17 Services, Department of Public Safety, and the Bureau of Criminal Apprehension do not
6.18 retain fingerprint data after a background study is completed, and that the Federal Bureau
6.19 of Investigation ~~only retains the fingerprints of subjects who have a criminal history~~ not
6.20 retain background study subjects' fingerprints.

6.21 Sec. 7. Minnesota Statutes 2019 Supplement, section 245C.05, subdivision 4, is amended
6.22 to read:

6.23 Subd. 4. **Electronic transmission.** (a) For background studies conducted by the
6.24 Department of Human Services, the commissioner shall implement a secure system for the
6.25 electronic transmission of:

6.26 (1) background study information to the commissioner;

6.27 (2) background study results to the license holder;

6.28 (3) background study results and relevant underlying investigative information to county
6.29 and private agencies for background studies conducted by the commissioner for child foster
6.30 care, including a summary of nondisqualifying results, except as prohibited by law; and

7.1 (4) background study results to county agencies for background studies conducted by
7.2 the commissioner for adult foster care and family adult day services and, upon
7.3 implementation of NETStudy 2.0, family child care and legal nonlicensed child care
7.4 authorized under chapter 119B.

7.5 (b) Unless the commissioner has granted a hardship variance under paragraph (c), a
7.6 license holder or an applicant must use the electronic transmission system known as

7.9 (c) A license holder or applicant whose program is located in an area in which high-speed
7.10 Internet is inaccessible may request the commissioner to grant a variance to the electronic
7.11 transmission requirement.

7.12 (d) Section 245C.08, subdivision 3, paragraph (c), applies to results transmitted under
7.13 this subdivision.

7.14 **EFFECTIVE DATE.** This section is effective July 1, 2021.

7.17 Subd. 3. **Arrest and investigative information.** (a) For any background study completed
7.18 under this section, if the commissioner has reasonable cause to believe the information is
7.19 pertinent to the disqualification of an individual, the commissioner also may review arrest
7.20 and investigative information from:

7.21 (1) the Bureau of Criminal Apprehension;

7.22 (2) the commissioners of health and human services;

7.23 (3) a county attorney;

7.24 (4) a county sheriff;

7.25 (5) a county agency;

7.26 (6) a local chief of police;

7.27 (7) other states;

7.28 (8) the courts;

7.29 (9) the Federal Bureau of Investigation;

7.30 (10) the National Criminal Records Repository; and

8.1 (11) criminal records from other states.

8.2 (b) Except when specifically required by law, the commissioner is not required to conduct
8.3 more than one review of a subject's records from the Federal Bureau of Investigation if a
8.4 review of the subject's criminal history with the Federal Bureau of Investigation has already
8.5 been completed by the commissioner and there has been no break in the subject's affiliation
8.6 with the entity that initiated the background study.

8.7 (c) If the commissioner conducts a national criminal history record check when required
8.8 by law and uses the information from the national criminal history record check to make a
8.9 disqualification determination, the data obtained is private data and cannot be shared with
8.10 ~~county agencies, private agencies, or prospective employers of the background study subject.~~

8.11 (d) If the commissioner conducts a national criminal history record check when required
8.12 by law and uses the information from the national criminal history record check to make a
8.13 disqualification determination, the license holder or entity that submitted the study is not
8.14 required to obtain a copy of the background study subject's disqualification letter under
8.15 section 245C.17, subdivision 3.

8.16 **EFFECTIVE DATE.** This section is effective July 1, 2020.

8.17 Sec. 9. Minnesota Statutes 2018, section 245C.14, subdivision 1, is amended to read:

8.18 Subdivision 1. **Disqualification from direct contact.** (a) The commissioner shall
8.19 disqualify an individual who is the subject of a background study from any position allowing
8.20 direct contact with persons receiving services from the license holder or entity identified in
8.21 section 245C.03, upon receipt of information showing, or when a background study
8.22 completed under this chapter shows any of the following:

8.23 (1) a conviction of, admission to, or Alford plea to one or more crimes listed in section
8.24 245C.15, regardless of whether the conviction or admission is a felony, gross misdemeanor,
8.25 or misdemeanor level crime;

8.26 (2) a preponderance of the evidence indicates the individual has committed an act or
8.27 acts that meet the definition of any of the crimes listed in section 245C.15, regardless of
8.28 whether the preponderance of the evidence is for a felony, gross misdemeanor, or
8.29 misdemeanor level crime; or

8.30 (3) an investigation results in an administrative determination listed under section

 9.2 245C.03, subdivisions 1 and 2, may be retained in a position involving direct contact with
 9.3 persons served by a program or entity identified in section 245C.03, unless the commissioner

9.5 (1) the individual may remain in direct contact during the period in which the individual
 9.6 may request reconsideration as provided in section 245C.21, subdivision 2;

9.7 (2) the commissioner has set aside the individual's disqualification for that program or
 9.8 entity identified in section 245C.03, as provided in section 245C.22, subdivision 4; or

9.9 (3) the license holder has been granted a variance for the disqualified individual under
 9.10 section 245C.30.

9.11 (c) Notwithstanding paragraph (a), for the purposes of a background study affiliated
 9.12 with a licensed family child foster care provider, the commissioner shall disqualify an
 9.13 individual who is the subject of a background study from any position allowing direct contact
 9.14 with persons receiving services from the license holder or entity identified in section 245C.03,
 9.15 upon receipt of information showing, or when a background study completed under this
 9.16 chapter shows reason for disqualification under section 245C.15, subdivision 6.

 11.28 maltreatment of a minor under section 626.556, a vulnerable adult under section 626.557,
 11.29 or serious or recurring maltreatment in any other state, the elements of which are substantially
 11.30 similar to the elements of maltreatment under section 626.556 or 626.557 and meet the
 11.31 definition of serious maltreatment or recurring maltreatment;
