Minnesota Statutes 2020, section 115B.17, subdivision 13, is amended to read: 1.7 Subd. 13. Priorities; rules. (a) By November 1, 1983, the Pollution Control Agency 1.8 shall establish a temporary list of priorities among releases or threatened releases for the 1.9 purpose of taking remedial action and, to the extent practicable consistent with the urgency 1.10 of the action, for taking removal action under this section. The temporary list, with any 1.11 necessary modifications, shall remain in effect until the Pollution Control Agency adopts 1.12 rules establishing state criteria for determining priorities among releases and threatened 1.13 releases. The Pollution Control Agency shall adopt the rules by July 1, 1984. Sec. 2. Minnesota Statutes 2020, section 115B.406, subdivision 1, is amended to read: 2.4 Subdivision 1. Legislative findings. The legislature recognizes the need to protect the 2.5 public health and welfare and the environment at priority qualified facilities.
