BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

## Section 1. [3.161] LEGISLATIVE SETTLEMENT ACCOUNTABILITY.

Subdivision 1. Nondisclosure agreements prohibited. A nondisclosure agreement must not be imposed on a party alleging misconduct as a condition of an award or settlement by any employee or legislative member of the house of representatives, senate, or Legislative Coordinating Commission if the award or settlement results from an allegation of sexual harassment or sexual assault. A party alleging misconduct must receive a nondisclosure agreement if requested by the party alleging misconduct as part of a settlement or award. An agreement or a portion of an agreement that violates this subdivision is void and unenforceable.

Subd. 2. Reports on settlements. (a) By January 15, 2020, and annually thereafter, the secretary of the senate, the chief clerk of the house of representatives, and the executive director of the Legislative Coordinating Commission shall submit to the chair and ranking minority member of the Legislative Coordinating Commission, and make available to the public on the legislature's website, a report on all payments made with public funds for the previous calendar year for awards and settlements in connection with an allegation of employee or employer misconduct by any person employed in or serving as a member of the senate, house of representatives, or joint offices of the legislature.
