1.7	Section 1. Minnesota Statutes 2008, section 299N.02, subdivision 3, is amended to

1.9	Subd. 3. Powers and duties. (a) The board shall:
1.10	(1) review fire service training needs and make recommendations on training to
1.11	Minnesota fire service organizations;
1.12	(2) establish standards for educational programs for the fire service and develop
1.13	procedures for continuing oversight of the programs; and
1.14	(3) establish qualifications for fire service training instructors in programs
1.15	established under clause (2); and
1.16	(4) license full-time firefighters and volunteer firefighters under this chapter.
1.17	(b) The board may:
1.18	(1) hire or contract for technical or professional services according to section 15.061;
1.19	(2) pay expenses necessary to carry out its duties;

2.5	Subdivision 1. Scope. The terms used in sections 299N.04 and 299N.05 have the
2.6	meanings given them in this section.
2.7	Subd. 2. Board. "Board" means the Board of Firefighter Training and Education
2.8	established under section 299N.02.
2.9	Subd. 3. Chief firefighting officer. "Chief firefighting officer" means the highest
2.10	ranking employee or appointed official of a fire department.
2.11	Subd. 4. Fire department. "Fire department" has the meaning given it in section
2.12	299F.092, subdivision 6. For purposes of sections 299N.04 and 299N.05, fire department
2.13	also includes a division of a state agency, regularly charged with the responsibility of

2.17	Subd. 5. Licensed firefighter. "Licensed firefighter" means a full-time firefighter,
2.18	to include a fire department employee, member, supervisor, or appointed official, who is
2.19	licensed by the board and who is charged with the prevention or suppression of fires within
2.20	the boundaries of the state. Licensed firefighter may also include a volunteer firefighter.
2.21	Subd. 6. Full-time firefighter. A "full-time firefighter" means a person who is
2.22	employed and charged with the prevention or suppression of fires within the boundaries of
2.23	the state on a full-time, salaried basis. Full-time firefighter does not include a volunteer,
2.24	part-time or paid, on-call firefighter.
2.25	Subd. 7. Volunteer firefighter. A "volunteer firefighter" means a person who is
2.26	charged with the prevention or suppression of fires within the boundaries of the state
2.27	on a volunteer, part-time or paid, on-call basis. Volunteer firefighter does not include a
2.28	full-time firefighter.
2.29	Sec. 3. [299N.04] FIREFIGHTER CERTIFICATION.
2.30	Subdivision 1. Certification examination; requirements. (a) The board must
2.31	appoint an organization that is accredited by the International Fire Service Accreditation
2.32	Congress to prepare and administer firefighter certification examinations. Firefighter
2.33	certification examinations shall be designed to ensure competency in at least the following

3.4	(b) To receive a certificate, an individual must demonstrate competency in fire
3.5	prevention and fire suppression.
3.6	(c) Nothing in this section shall be construed to prohibit any requirement imposed
3.7	by a local fire department for more comprehensive training.
3.8	Subd. 2. Eligibility for certification examination. Except as provided in
3.9	subdivision 3, any person may take the firefighter certification examination who has
3.10	successfully completed the following:
3.11	(1)(i) a firefighter course from a postsecondary educational institution, an accredited
3.12	institution of higher learning, or another entity that teaches a course that has been approved
3.13	by the board; or (ii) an apprenticeship or cadet program maintained by a fire department
3.14	employing the person that has been approved by the board; and
3.15	(2) a skills-oriented basic training course.
3.16	Subd. 3. Certain baccalaureate or associate degree holders eligible to take
3.17	certification examination. A person with a baccalaureate degree, or with an associate
3.18	degree in applied fire science technology, from an accredited college or university who
3.19	has successfully completed the skills-oriented basic training course under subdivision 2,
3.20	clause (2), is eligible to take the firefighter certification examination notwithstanding the
3.21	requirements of subdivision 2, clause (1).
3.22	Sec. 4. [299N.05] LICENSE REQUIRED.
3.23	Subdivision 1. Licensure requirement. A full-time firefighter employed on or after
3.24	July 1, 2011, by a fire department is not eligible for permanent employment without
3.25	being licensed as a firefighter by the board.
3.26	Subd. 2. Optional licensing. A volunteer firefighter may receive or apply for
3.27	licensure under this section and section 299N.04 under the same terms as full-time
3.28	firefighters.
3.29	Subd. 3. Prior appointment. A full-time firefighter or a volunteer firefighter who
3.30	has received a permanent appointment with a fire department prior to July 1, 2011, shall
3.31	be licensed by the board at the request of the firefighter upon providing the board with a
3.32	statement signed by the chief firefighting officer of the fire department that employs the
3.33	<u>full-time</u> or volunteer firefighter.
3.34	Subd. 4. Newly employed firefighters. Any full-time firefighter employed by a fire
3.35	department on or after July 1, 2011, must obtain a license from the board. To obtain a

4.1	license, an individual not covered by subdivision 3 must provide the board with a statement
4.2	signed by the chief firefighting officer of the fire department that employs the full-time
4.3	firefighter that the individual has met the certification requirements of section 299N.04.
4.4	Subd. 5. Issuance of license. The board shall license any individual who meets
4.5	the requirements of subdivision 3 or 4. A license is valid for three years from the date of
4.6	issuance, and the fee for the license is \$75.
4.7	Subd. 6. License renewal. A license shall be renewed so long as the firefighter and
4.8	the chief firefighting officer provide evidence to the board that the licensed firefighter has
4.9	had at least 72 hours of firefighting training in the previous three-year period. The fee for
4.10	renewing a firefighter license is \$75, and the license is valid for an additional three years.
4.11	Subd. 7. Duties of chief firefighting officer. It shall be the duty of every chief
4.12	firefighting officer to ensure that all full-time firefighters have a license from the board
4.13	beginning July 1, 2011. Each full-time firefighter, volunteer firefighter, and chief
4.14	firefighting officer may apply for licensure after January 1, 2011.
4.15	Subd. 8. Revocation; suspension; denial. The board may revoke, suspend, or
4.16	deny a license issued or applied for under this section to a firefighter or applicant if the
4.17	firefighter or applicant has been convicted of a felony recognized by the board as a crime
4.18	that would disqualify the licensee from participating in the profession of firefighting.
4.19	Subd. 9. Fees. Fees collected under this section must be deposited in the state
4.20	treasury and credited to a special account and are appropriated to the board to pay costs
4.21	incurred under sections 299N.04 to 299N.05.
