- Subd. 9. **Burial fees.** (a) The commissioner of veterans affairs shall establish a fee schedule, which may be adjusted from time to time, for the interment of eligible spouses and dependent children. The fees shall cover as nearly as practicable the actual costs of interment, excluding the value of the plot.
- (b) Upon application, the commissioner may waive or reduce the <u>burial</u> fee in the ease <u>of for</u> an indigent eligible person. The commissioner shall develop a policy, eligibility standards, and application form for requests to waive or reduce the burial fee to indigent <u>eligible applicants</u>.
- 8.16 (c) No plot or interment fees may be charged for the burial of service members who die 8.17 on active duty or eligible veterans, as defined in United States Code, title 38, section 101, 8.18 paragraph (2).
