1.5 lodging establishments; requiring the Department of Health to use rules and
1.6 guidelines from the federal government to implement the minimum data set for
1.7 resident reimbursement classification; establishing fees; amending Minnesota
1.8 Statutes 2008, sections 148.512, subdivision 13; 148.5193, subdivision 6a;
1.9 148.5194, subdivisions 2, 3, 7; 148.6402, subdivisions 13, 22a; 148.6405;
1.10 148.6440, subdivision 2; 151.01, subdivision 27; 157.16, subdivisions 2, 4;
1.11 proposing coding for new law in Minnesota Statutes, chapter 145; repealing
1.12 Minnesota Rules, parts 4610.0420; 4610.0500, subparts 1, 2, 3, 5; 4610.0600,
1.13 subparts 1, 3, 4; 4610.0650.

1.14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.15 Section 1. **[145.58] PEDIATRIC VACCINE ADMINISTRATION.**

1.16 The commissioner of health shall enroll a licensed pharmacy or individual
1.17 pharmacist as a program-registered provider in the Pediatric Vaccine Administration
1.18 Program under section 13631 of the federal Omnibus Budget Reconciliation Act of 1993,
1.19 Public Law 103-66, based on the program's infrastructure capacity to enroll the additional
1.20 pharmacy providers in the program.

1.21 Sec. 2. Minnesota Statutes 2008, section 148.512, subdivision 13, is amended to read:

1.22 Subd. 13. **Practice of speech-language pathology.** The "practice of
1.23 speech-language pathology" means:

1.24 (1) identification, assessment, and interpretation, diagnosis, habilitation,
1.25 rehabilitation, treatment and prevention of disorders of speech, articulation, fluency, voice,
1.26 and language;

- 2.1 (2) identification, assessment, and interpretation, diagnosis, habilitation, and
2.2 rehabilitation of disorders of oral-pharyngeal function and related disorders;
- 2.3 (3) identification, assessment, and interpretation, diagnosis, habilitation, and

- 2.5 (4) assessing, selecting, and developing augmentative and alternative communication
2.6 systems and providing training in their use;
- 2.7 (5) aural habilitation and rehabilitation and related counseling for hearing impaired

- 2.9 (6) enhancing speech-language proficiency and communication effectiveness;

2.11 the purposes of speech-language evaluation or for the identification of possible hearing
2.12 disorders; or
- 2.13 (8) supervision of the functions in clauses (1) to (7).

2.15 and surgery, or osteopathic medicine and surgery, or medical diagnosis that is commonly

3.2 (a) The commissioner may audit a percentage of the continuing education reports based on
3.3 random selection. A licensee shall maintain all documentation required by this section
3.4 for two years after the last day of the biennial licensure period in which the contact
3.5 hours were earned.

3.6 (b) All renewal applications that are received after the expiration date may be subject
3.7 to a continuing education report audit.

3.8 (c) Any licensee against whom a complaint is filed may be subject to a continuing
3.9 education report audit.

3.10 (d) The licensee shall make the following information available to the commissioner
3.11 for auditing purposes:

3.12 (1) a copy of the completed continuing education report form for the continuing
3.13 education reporting period that is the subject of the audit including all supporting
3.14 documentation required by subdivision 5;

3.15 (2) a description of the continuing education activity prepared by the presenter or
3.16 sponsor that includes the course title or subject matter, date, place, number of program
3.17 contact hours, presenters, and sponsors;

3.18 (3) documentation of self-study programs by materials prepared by the presenter

3.20 and the number of hours required to complete the program;

3.21 (4) documentation of university, college, or vocational school courses by a course
3.22 syllabus, listing in a course bulletin, or equivalent documentation that includes the course
3.23 title, instructor's name, course dates, number of contact hours, and course content,
3.24 objectives, or goals; and

3.28 course date, and licensee's name;

3.34 successfully completed the program; or

3.35 (iv) verification of attendance at a university, college, or vocational course by an
3.36 official transcript.

6.15 provide to the commissioner documentation verifying that the occupational therapist
6.16 has met the educational and clinical requirements described in subdivisions 3 to 5,
6.17 depending on the modality or modalities to be used. Both theoretical training and clinical
6.18 application objectives must be met for each modality used. Documentation must include
6.19 the name and address of the individual or organization sponsoring the activity; the
6.20 name and address of the facility at which the activity was presented; and a copy of the
6.21 course, workshop, or seminar description, including learning objectives and standards
6.22 for meeting the objectives. In the case of clinical application objectives, teaching
6.23 methods must be documented, including actual supervised practice. Documentation must
6.24 include a transcript or certificate showing successful completion of the coursework.
6.25 Coursework completed more than two years prior to date of application must be retaken.
6.26 An occupational therapist who is a certified hand therapist shall document satisfaction
6.27 of the requirements in subdivisions 3 to 5 by submitting to the commissioner a copy of
6.28 a certificate issued by the Hand Therapy Certification Commission. Practitioners are
6.29 prohibited from using physical agent modalities under supervision or independently until
6.30 granted approval as provided in subdivision 7, except under the provisions in paragraph
6.31 (b).

6.32 (b) If a practitioner has successfully completed a specific course previously reviewed
6.33 and approved by the commissioner as provided for in subdivision 7, and has submitted the
6.34 written documentation required in paragraph (a) within 30 calendar days from the course

7.7 a manufacturer or packager of nonprescription drugs or commercially packaged legend
7.8 drugs and devices);

7.11 (4) participation in drug and therapeutic device selection; drug administration for

8.1 Subd. 2. **License renewal.** Initial and renewal licenses for all food and beverage
8.2 service establishments, hotels, motels, lodging establishments, public pools, and resorts
8.3 shall be issued ~~for the calendar year for which application is made and shall expire on~~
8.4 ~~December 31 of such year~~ on an annual basis. Any person who operates a place of
8.5 business after the expiration date of a license or without having submitted an application
8.6 and paid the fee shall be deemed to have violated the provisions of this chapter and shall
8.7 be subject to enforcement action, as provided in the Health Enforcement Consolidation
8.8 Act, sections 144.989 to 144.993. In addition, a penalty of \$50 shall be added to the total
8.9 of the license fee for any food and beverage service establishment operating without a
8.10 license as a mobile food unit, a seasonal temporary or seasonal permanent food stand, or a
8.11 special event food stand, and a penalty of \$100 shall be added to the total of the license fee

8.16 Subd. 4. **Posting requirements.** Every food and beverage service establishment,
8.17 hotel, motel, lodging establishment, public pool, or resort must have the license posted
8.18 in a conspicuous place at the establishment. Mobile food units, food carts, and seasonal
8.19 temporary food stands shall be issued decals with the initial license and each calendar year
8.20 with license renewals. The current license year decal must be placed on the unit or stand
8.21 in a location determined by the commissioner. Decals are not transferable.

8.22 Sec. 14. **MINIMUM DATA SET, VERSION 3.0.**

8.23 The commissioner of health shall implement the minimum data set, version 3.0
8.24 (MDS 3.0) for the resident reimbursement classification in Minnesota Statutes, section
8.25 144.0724, using the rules and guidelines when they are published by the United States
8.26 Department of Health and Human Services, Centers for Medicare and Medicaid Services.
8.27 Implementation of MDS 3.0 must correspond to the implementation times specified in the
8.28 federal requirements. The commissioners of health and human services shall establish
8.29 procedures for the transition from resource utilization groups (RUGs) to MDS 3.0 for
8.30 resident reimbursement classification.

8.32 The revisor of statutes shall renumber Minnesota Statutes, section 43A.312, as
8.33 section 62J.63 and make any cross-reference changes in Minnesota Statutes.
