BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

## Section 1. RURAL FINANCE AUTHORITY.

Subdivision 1. **Appropriation.** \$35,000,000 is appropriated from the bond proceeds 1.6 fund to the Rural Finance Authority for the purposes set forth in the Minnesota Constitution, 1.7 article XI, section 5, paragraph (h), to purchase participation interests in or to make direct 1.8 agricultural loans to farmers under Minnesota Statutes, chapter 41B. This appropriation is 1.9 from the bond proceeds account in the rural finance administration fund and is for the 1.10 beginning farmer program under Minnesota Statutes, section 41B.039; the loan restructuring 1.11 program under Minnesota Statutes, section 41B.04; the seller-sponsored program under 1.12 Minnesota Statutes, section 41B.042; the agricultural improvement loan program under 1.13 Minnesota Statutes, section 41B.043; and the livestock expansion loan program under 1.14 Minnesota Statutes, section 41B.045. All debt service on bond proceeds used to finance 1.15 this appropriation must be repaid by the Rural Finance Authority under Minnesota Statutes, 1.16 section 16A.643. Loan participations must be priced to provide full interest and principal 1.17 coverage and a reserve for potential losses.
