1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2020, section 245.735, subdivision 3, is amended to read:
1.8	Subd. 3. Certified community behavioral health clinics. (a) The commissioner shall
1.9	establish a state certification process for certified community behavioral health clinics
1.10	(CCBHCs) that satisfy all federal requirements necessary for CCBHCs certified under this
1.11	section to be eligible for reimbursement under medical assistance, without service area
1.12	limits based on geographic area or region. The commissioner shall consult with CCBHC
1.13	stakeholders before establishing and implementing changes in the certification process and
1.14	requirements. Entities that choose to be CCBHCs must:
1.15	(1) comply with the CCBHC criteria published by the United States Department of
1.16	Health and Human Services;
1.17	(1) comply with state licensing requirements and other requirements issued by the
1.18	commissioner;
1.19	(2) employ or contract for clinic staff who have backgrounds in diverse disciplines,
1.20	including licensed mental health professionals and licensed alcohol and drug counselors,
1.21	and staff who are culturally and linguistically trained to meet the needs of the population
1.22	the clinic serves;

2.1 (3) ensure that clinic services are available and accessible to individuals and families of
2.2 all ages and genders and that crisis management services are available 24 hours per day;

- 2.3 (4) establish fees for clinic services for individuals who are not enrolled in medical
 2.4 assistance using a sliding fee scale that ensures that services to patients are not denied or
 2.5 limited due to an individual's inability to pay for services;
- 2.6 (5) comply with quality assurance reporting requirements and other reporting
 2.7 requirements, including any required reporting of encounter data, clinical outcomes data,
 2.8 and quality data;

(6) provide crisis mental health and substance use services, withdrawal management 2.9 services, emergency crisis intervention services, and stabilization services, in accordance 2.10 with existing mobile crisis services; screening, assessment, and diagnosis services, including 2.11 risk assessments and level of care determinations; person- and family-centered treatment 2.12 planning; outpatient mental health and substance use services; targeted case management; 2.13 psychiatric rehabilitation services; peer support and counselor services and family support 2.14 services; and intensive community-based mental health services, including mental health 2.15 services for members of the armed forces and veterans; CCBHCs must directly provide 2.16 the majority of these services to enrollees, but may coordinate some services with another 2.17 entity through a collaboration or agreement, pursuant to paragraph (b); 2.18

- 2.19 (7) provide coordination of care across settings and providers to ensure seamless
 2.20 transitions for individuals being served across the full spectrum of health services, including
 2.21 acute, chronic, and behavioral needs. Care coordination may be accomplished through
 2.22 partnerships or formal contracts with:
- 2.23 (i) counties, health plans, pharmacists, pharmacies, rural health clinics, federally qualified
 2.24 health centers, inpatient psychiatric facilities, substance use and detoxification facilities, or
 2.25 community-based mental health providers; and

(ii) other community services, supports, and providers, including schools, child welfare
agencies, juvenile and criminal justice agencies, Indian health services clinics, tribally
licensed health care and mental health facilities, urban Indian health clinics, Department of
Veterans Affairs medical centers, outpatient clinics, drop-in centers, acute care hospitals,
and hospital outpatient clinics;

4.5 (c) Notwithstanding any other law that requires a county contract or other form of county approval for certain services listed in paragraph (a), clause (6), a clinic that otherwise meets 4.6 CCBHC requirements may receive the prospective payment under section 256B.0625, 4.7 subdivision 5m, for those services without a county contract or county approval. As part of 4.8 the certification process in paragraph (a), the commissioner shall require a letter of support 4.9 4.10 from the CCBHC's host county confirming that the CCBHC and the county or counties it serves have an ongoing relationship to facilitate access and continuity of care, especially 4.11 for individuals who are uninsured or who may go on and off medical assistance. 4 12

(d) When the standards listed in paragraph (a) or other applicable standards conflict or 4.13 address similar issues in duplicative or incompatible ways, the commissioner may grant 4.14 variances to state requirements if the variances do not conflict with federal requirements 4.15 for services reimbursed under medical assistance. If standards overlap, the commissioner 4.16 may substitute all or a part of a licensure or certification that is substantially the same as 4.17 another licensure or certification. The commissioner shall consult with stakeholders, as 4.18 described in subdivision 4, before granting variances under this provision. For the CCBHC 4.19 that is certified but not approved for prospective payment under section 256B.0625, 4.20 subdivision 5m, the commissioner may grant a variance under this paragraph if the variance 4.21 does not increase the state share of costs. 4.22

(e) The commissioner shall issue a list of required evidence-based practices to be 4.23 delivered by CCBHCs, and may also provide a list of recommended evidence-based practices. 4.24 The commissioner may update the list to reflect advances in outcomes research and medical 4.25 4.26 services for persons living with mental illnesses or substance use disorders. The commissioner shall take into consideration the adequacy of evidence to support the efficacy of the practice, 4.27 the quality of workforce available, and the current availability of the practice in the state. 4.28 At least 30 days before issuing the initial list and any revisions, the commissioner shall 4.29 provide stakeholders with an opportunity to comment. 4.30

4.31 (f) The commissioner may grant a variance to allow an applicant for CCBHC certification
4.32 to demonstrate compliance with standards in paragraph (a) if the CCBHC will contract with

CCBHCs must provide data on costs and visits to the state annually using the CCBHC cost report established by the commissioner; and 7.17 (9) a CCBHC may request a rate adjustment for changes in the CCBHC's scope of 7.18 services when such changes are expected to result in an adjustment to the CCBHC payment 7.19 rate by 2.5 percent or more. The CCBHC must provide the commissioner with information 7.20 regarding the changes in the scope of services, including the estimated cost of providing 7.21 the new or modified services and any projected increase or decrease in the number of visits 7.22 resulting from the change. Rate adjustments for changes in scope shall occur no more 7.23

7.24 <u>frequently than once per year in between rebasing periods per CCBHC and are effective on</u>

(8) the commissioner shall seek federal approval for a CCBHC rate methodology that
allows for rate modifications based on changes in scope for an individual CCBHC, including
for changes to the type, intensity, or duration of services. Upon federal approval, a CCBHC
may submit a change of scope request to the commissioner if the change in scope would
result in a change of 2.5 percent or more in the prospective payment system rate currently
received by the CCBHC. CCBHC change of scope requests must be according to a format
and timeline to be determined by the commissioner in consultation with CCBHCs.

(d) Managed care plans and county-based purchasing plans shall reimburse CCBHC
providers at the prospective payment rate. The commissioner shall monitor the effect of

this requirement on the rate of access to the services delivered by CCBHC providers. If, for 8.1 any contract year, federal approval is not received for this paragraph, the commissioner 8.2 8.3 must adjust the capitation rates paid to managed care plans and county-based purchasing plans for that contract year to reflect the removal of this provision. The commissioner 8.21 shall notify CCBHC providers of their performance on the required measures and the 8.22 incentive payment amount within 12 months following the measurement year. 8.23 (f) All claims to managed care plans for CCBHC services as provided under this section 8.24 shall be submitted directly to, and paid by, the commissioner on the dates specified no later 8.25 8.26 than January 1 of the following calendar year, if: (1) one or more managed care plans does not comply with the federal requirement for 8.27 payment of clean claims to CCBHCs, as defined in Code of Federal Regulations, title 42, 8.28 section 447.45(b), and the managed care plan does not resolve the payment issue within 30 8.29 days of noncompliance; and 8.30 (2) the total amount of clean claims not paid in accordance with federal requirements 8.31 by one or more managed care plans is 50 percent of, or greater than, the total CCBHC claims 8.32 eligible for payment by managed care. 8.33

APPENDIX Repealed Minnesota Statutes: S1572-1

245.735 EXCELLENCE IN MENTAL HEALTH DEMONSTRATION PROJECT.

Subdivision 1. Excellence in Mental Health demonstration project. The commissioner shall develop and execute projects to reform the mental health system by participating in the Excellence in Mental Health demonstration project.

Subd. 2. Federal proposal. The commissioner shall develop and submit to the United States Department of Health and Human Services a proposal for the Excellence in Mental Health demonstration project. The proposal shall include any necessary state plan amendments, waivers, requests for new funding, realignment of existing funding, and other authority necessary to implement the projects specified in subdivision 3.

Subd. 4. **Public participation.** In developing and implementing CCBHCs under subdivision 3, the commissioner shall consult, collaborate, and partner with stakeholders, including but not limited to mental health providers, substance use disorder treatment providers, advocacy organizations, licensed mental health professionals, counties, tribes, hospitals, other health care providers, and Minnesota public health care program enrollees who receive mental health services and their families.
