1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. [148.645] OCCUPATIONAL THERAPY LICENSURE COMPACT.
1.6	ARTICLE 1. PURPOSE
1.7	The purpose of this compact is to facilitate interstate practice of occupational therapy
1.8	with the goal of improving public access to occupational therapy services. The practice of
1.9	occupational therapy occurs in the state where the patient or client is located at the time of
1.10	the patient or client encounter. The compact preserves the regulatory authority of states to
1.11	protect public health and safety through the current system of state licensure.
1.12	This compact is designed to achieve the following objectives:
1.13	(A) increase public access to occupational therapy services by providing for the mutual
1.14	recognition of other member state licenses;
1.15	(B) enhance the states' ability to protect the public's health and safety;
1.16	(C) encourage the cooperation of member states in regulating multistate occupational
1.17	therapy practice;
1.18	(D) support spouses of relocating military members;
1.19	(E) enhance the exchange of licensure, investigative, and disciplinary information
1.20	between member states;

(F) allow a remote state to hold a provider of services with a compact privilege in that 2.1 state accountable to that state's practice standards; and 2.2 (G) facilitate the use of telehealth technology in order to increase access to occupational 2.3 therapy services. 2.4 **ARTICLE 2. - (C) For purposes of taking adverse action, the home state shall give the same priority and effect to reported conduct received from a member state as it would if the conduct had occurred within the home state. In so doing, the home state shall apply its own state laws to determine appropriate action.
- (D) The home state shall complete any pending investigations of an occupational therapist or occupational therapy assistant who changes their primary state of residence during the course of the investigations. The home state, where the investigations were initiated, shall also have the authority to take appropriate action and shall promptly report the conclusions of the investigations to the compact commission data system. The occupational therapy compact commission data system administrator shall promptly notify the new home state of any adverse actions.
- (E) A member state, if otherwise permitted by state law, may recover from the affected occupational therapist or occupational therapy assistant the costs of investigations and disposition of cases resulting from any adverse action taken against that occupational therapist or occupational therapy assistant.
- (F) A member state may take adverse action based on the factual findings of the remote state, provided that the member state follows its own procedures for taking the adverse action.

(F) Financing of the Commission: 14.17 (1) The commission shall pay, or provide for the payment of, the reasonable expenses 14.18 of its establishment, organization, and ongoing activities. 14.19 (2) The commission may accept any and all appropriate revenue sources, donations, and 14.20 grants of money, equipment, supplies, materials, and services. 14.21 (3) The commission may levy on and collect an annual assessment from each member 14.22 state or impose fees on other parties to cover the cost of the operations and activities of the 14.23 commission and its staff, which must be in a total amount sufficient to cover its annual 14.24 budget as approved by the commission each year for which revenue is not provided by other 14.25 sources. The aggregate annual assessment amount shall be allocated based upon a formula 14.26 to be determined by the commission, which shall promulgate a rule binding upon all member 14.27 14.28 states. 14.29 (4) The commission shall not incur obligations of any kind prior to securing the funds adequate to meet the same; nor shall the commission pledge the credit of any of the member 14.30 states, except by and with the authority of the member state. 14.31

However, all receipts and disbursements of funds handled by the commission shall be audited yearly by a certified or licensed public accountant, and the report of the audit shall be included in and become part of the annual report of the commission.

- (1) The members, officers, executive director, employees, and representatives of the commission shall be immune from suit and liability, either personally or in their official capacity, for any claim for damage to or loss of property or personal injury or other civil liability caused by or arising out of any actual or alleged act, error, or omission that occurred, or that the person against whom the claim is made had a reasonable basis for believing occurred within the scope of commission employment, duties, or responsibilities; provided that nothing in this paragraph shall be construed to protect any such person from suit or liability for any damage, loss, injury, or liability caused by the intentional or willful or wanton misconduct of that person.
- (2) The commission shall defend any member, officer, executive director, employee, or representative of the commission in any civil action seeking to impose liability arising out of any actual or alleged act, error, or omission that occurred within the scope of commission employment, duties, or responsibilities, or that the person against whom the claim is made had a reasonable basis for believing occurred within the scope of commission employment, duties, or responsibilities; provided that nothing herein shall be construed to prohibit that person from retaining their own counsel; and provided further, that the actual or alleged act, error, or omission did not result from that person's intentional or willful or wanton misconduct.
- (3) The commission shall indemnify and hold harmless any member, officer, executive director, employee, or representative of the commission for the amount of any settlement or judgment obtained against that person arising out of any actual or alleged act, error, or omission that occurred within the scope of commission employment, duties, or responsibilities, or that such person had a reasonable basis for believing occurred within the scope of commission employment, duties, or responsibilities; provided that the actual or alleged act, error, or omission did not result from the intentional or willful or wanton misconduct of that person.

ARTICLE 9. DATA SYSTEM

(N) The commission or an authorized committee of the commission may direct revisions to a previously adopted rule or amendment for purposes of correcting typographical errors, errors in format, errors in consistency, or grammatical errors. Public notice of any revisions shall be posted on the website of the commission. The revision shall be subject to challenge by any person for a period of 30 days after posting. The revision may be challenged only on grounds that the revision results in a material change to a rule. A challenge shall be made in writing and delivered to the chair of the commission prior to the end of the notice period. If no challenge is made, the revision will take effect without further action. If the revision is challenged, the revision may not take effect without the approval of the commission.

ARTICLE 11. OVERSIGHT, DISPUTE RESOLUTION, AND ENFORCEMENT

- (A) Oversight:
- (1) The executive, legislative, and judicial branches of state government in each member state shall enforce this compact and take all actions necessary and appropriate to effectuate the compact's purposes and intent. The provisions of this compact and the rules promulgated hereunder shall have standing as statutory law.
- (2) All courts shall take judicial notice of the compact and the rules in any judicial or administrative proceeding in a member state pertaining to the subject matter of this compact which may affect the powers, responsibilities, or actions of the commission.
- (3) The commission shall be entitled to receive service of process in any such proceeding, and shall have standing to intervene in such a proceeding for all purposes. Failure to provide service of process to the commission shall render a judgment or order void as to the commission, this compact, or promulgated rules.
 - (B) Default, Technical Assistance, and Termination:
- (1) If the commission determines that a member state has defaulted in the performance of its obligations or responsibilities under this compact or the promulgated rules, the commission shall:
- (i) provide written notice to the defaulting state and other member states of the nature
 of the default, the proposed means of curing the default, or any other action to be taken by
 the commission; and
- 19.31 (ii) provide remedial training and specific technical assistance regarding the default.

(2) If a state in default fails to cure the default, the defaulting state may be terminated 20.1 from the compact upon an affirmative vote of a majority of the member states, and all rights, 20.2 20.3 privileges, and benefits conferred by this compact may be terminated on the effective date of termination. A cure of the default does not relieve the offending state of obligations or 20.4 liabilities incurred during the period of default. 20.5 (3) Termination of membership in the compact shall be imposed only after all other 20.6 means of securing compliance have been exhausted. (3) The remedies herein shall not be the exclusive remedies of the commission. The commission may pursue any other remedies available under federal or state law.

ARTICLE 12. DATE OF IMPLEMENTATION OF THE INTERSTATE COMMISSION FOR OCCUPATIONAL THERAPY PRACTICE AND ASSOCIATED RULES, WITHDRAWAL, AND AMENDMENT

- (A) The compact shall come into effect on the date on which the compact statute is enacted into law in the tenth member state. The provisions, which become effective at that time, shall be limited to the powers granted to the commission relating to assembly and the promulgation of rules. Thereafter, the commission shall meet and exercise rulemaking powers necessary to the implementation and administration of the compact.
- (B) Any state that joins the compact subsequent to the commission's initial adoption of the rules shall be subject to the rules as they exist on the date on which the compact becomes law in that state. Any rule that has been previously adopted by the commission shall have the full force and effect of law on the day the compact becomes law in that state.
- 21.17 (C) Any member state may withdraw from this compact by enacting a statute repealing the same:
 - (1) A member state's withdrawal shall not take effect until six months after enactment of the repealing statute.
 - (2) Withdrawal shall not affect the continuing requirement of the withdrawing state's occupational therapy licensing board to comply with the investigative and adverse action reporting requirements of this act prior to the effective date of withdrawal.
 - (D) Nothing contained in this compact shall be construed to invalidate or prevent any occupational therapy licensure agreement or other cooperative arrangement between a member state and a nonmember state that does not conflict with the provisions of this compact.
 - (E) This compact may be amended by the member states. No amendment to this compact shall become effective and binding upon any member state until it is enacted into the laws of all member states.

ARTICLE 13. CONSTRUCTION AND SEVERABILITY

This compact shall be liberally construed so as to effectuate the purposes thereof. The provisions of this compact shall be severable and if any phrase, clause, sentence, or provision of this compact is declared to be contrary to the constitution of any member state or of the United States or the applicability thereof to any government, agency, person, or circumstance is held invalid, the validity of the remainder of this compact and the applicability thereof to any government, agency, person, or circumstance shall not be affected thereby. If this compact shall be held contrary to the constitution of any member state, the compact shall remain in full force and effect as to the remaining member states and in full force and effect as to the member state affected as to all severable matters.

ARTICLE 14. BINDING EFFECT OF COMPACT AND OTHER LAWS

- 22.11 (A) A licensee providing occupational therapy in a remote state under the compact privilege shall function within the laws and regulations of the remote state.
- 22.13 (B) Nothing herein prevents the enforcement of any other law of a member state that is
 22.14 not inconsistent with the compact.
- 22.15 (C) Any laws in a member state in conflict with the compact are superseded to the extent of the conflict.
- 22.17 (D) Any lawful actions of the commission, including all rules and bylaws promulgated
 22.18 by the commission, are binding upon the member states.
- (E) All agreements between the commission and the member states are binding in accordance with their terms.
- (F) In the event any provision of the compact exceeds the constitutional limits imposed on the legislature of any member state, the provision shall be ineffective to the extent of the conflict with the constitutional provision in question in that member state.
