1.1 A bill for an act

1.2 relating to courts; permitting the Department of Public Safety to share data with

1.3 the courts; specifying surveillance technology data requirements; amending

1.4 Minnesota Statutes 2016, sections 13.69, subdivision 1; 13.82, subdivision 31.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2016, section 13.69, subdivision 1, is amended to read:

1.7 Subdivision 1. **Classifications.** (a) The following government data of the Department

1.8 of Public Safety are private data:

1.9 (1) medical data on driving instructors, licensed drivers, and applicants for parking

1.10 certificates and special license plates issued to physically disabled persons;

1.11 (2) other data on holders of a disability certificate under section 169.345, except that (i)

1.12 data that are not medical data may be released to law enforcement agencies, and (ii) data

1.13 necessary for enforcement of sections 169.345 and 169.346 may be released to parking

1.14 enforcement employees or parking enforcement agents of statutory or home rule charter

1.15 cities and towns;

1.16 (3) Social Security numbers in driver's license and motor vehicle registration records,

1.17 except that Social Security numbers must be provided to the Department of Revenue for

1.18 purposes of tax administration, the Department of Labor and Industry for purposes of

1.19 workers' compensation administration and enforcement, the judicial branch for purposes of

1.20 debt collection, and the Department of Natural Resources for purposes of license application

1.21 administration; and

1.22 (4) data on persons listed as standby or temporary custodians under section 171.07,

1.23 subdivision 11, except that the data must be released to:

2.1 (i) law enforcement agencies for the purpose of verifying that an individual is a designated  
2.2 caregiver; or

2.3 (ii) law enforcement agencies who state that the license holder is unable to communicate  
2.4 at that time and that the information is necessary for notifying the designated caregiver of  
2.5 the need to care for a child of the license holder.

2.6 The department may release the Social Security number only as provided in clause (3)  
2.7 and must not sell or otherwise provide individual Social Security numbers or lists of Social  
2.8 Security numbers for any other purpose.

2.9 (b) The following government data of the Department of Public Safety are confidential  
2.10 data: data concerning an individual's driving ability when that data is received from a member  
2.11 of the individual's family.

2.12 Sec. 2. Minnesota Statutes 2016, section 13.82, subdivision 31, is amended to read:

2.13 Subd. 31. **Use of surveillance technology.** Notwithstanding subdivision 25 and section  
2.14 13.37, subdivision 2, the existence and description of the types and capabilities of all  
2.15 technology maintained by a law enforcement agency that may be used to electronically  
2.16 capture an audio, video, photographic, or other record of the activities of the general public,  
2.17 or of an individual or group of individuals, for purposes of conducting an investigation,  
2.18 responding to an incident or request for service, monitoring or maintaining public order and  
2.19 safety, or engaging in any other law enforcement function authorized by law is public data.
