Subd. 5. Probationary period. (a) The first three consecutive years of a teacher's first
teaching experience in Minnesota in a single district is deemed to be a probationary period

of employment, and, the probationary period in each district in which the teacher is thereafter 3.1 employed shall be one year. The school board must adopt a plan for written evaluation of 3.2 teachers during the probationary period that is consistent with subdivision 8. Evaluation 3.3 must occur at least three times periodically throughout each school year for a teacher 3.4 performing services during that school year; the first evaluation must occur within the first 3.5 90 days of teaching service. Days devoted to parent-teacher conferences, teachers' workshops, 3.6 and other staff development opportunities and days on which a teacher is absent from school 3.7 must not be included in determining the number of school days on which a teacher performs 3.8 services. Except as otherwise provided in paragraph (b), during the probationary period any 3.9 annual contract with any teacher may or may not be renewed as the school board shall see 3.10 fit. The school board may, after a hearing 3.16 held upon due notice, discharge a teacher during the probationary period for cause, effective 3.17 immediately, under section 122A.44. 3.18

(b) A board must discharge a probationary teacher, effective immediately, upon receipt 3.19 of notice under section 122A.20, subdivision 1, paragraph (b), that the teacher's license has 3.20 been revoked due to a conviction for child abuse or sexual abuse. 3.21

### 10.4 **572B.17 WITNESSES; SUBPOENAS; DEPOSITIONS; DISCOVERY.**

(a) An arbitrator may issue a subpoena for the attendance of a witness and for the
production of records and other evidence at any hearing and may administer oaths. A
subpoena must be served in the manner for service of subpoenas in a civil action and, upon
motion to the court by a party to the arbitration proceeding or the arbitrator, enforced in the
manner for enforcement of subpoenas in a civil action.

(b) On request of a party to or a witness in an arbitration proceeding, an arbitrator may
permit a deposition of any witness to provide testimony at the arbitration hearing, including
a witness who cannot be subpoenaed for or is unable to attend a hearing, to be taken under
conditions determined by the arbitrator for use as evidence in order to make the proceeding
fair, expeditious, and cost-effective.

10.15 (c) An arbitrator may permit such discovery as the arbitrator decides is appropriate in
10.16 the circumstances, taking into account the needs of the parties to the arbitration proceeding
10.17 and other affected persons and the desirability of making the proceeding fair, expeditious,

(d) If an arbitrator permits discovery under subsection (c), the arbitrator may order a
party to the arbitration proceeding to comply with the arbitrator's discovery-related orders,

of records and other evidence at a discovery proceeding, and may take action against a party
to the arbitration proceeding who does not comply to the extent permitted by law as if the
controversy were the subject of a civil action in this state.

(e) An arbitrator may issue a protective order to prevent the disclosure of privileged
information, confidential information, trade secrets, <u>data classified as nonpublic or private</u>
<u>pursuant to chapter 13</u>, and other information protected from disclosure as if the controversy
were the subject of a civil action in this state.

(f) All laws compelling a person under subpoena to testify and all fees for attending a
judicial proceeding, a deposition, or a discovery proceeding as a witness apply to an
arbitration proceeding as if the controversy were the subject of a civil action under the laws
and rules of civil procedure of this state.

11.1	(g) The court may enforce a subpoena or discovery-related order for the attendance of
11.2	a witness within this state and for the production of records and other evidence issued by
11.3	an arbitrator in connection with an arbitration proceeding in another state upon conditions
11.4	determined by the court in order to make the arbitration proceeding fair, expeditious, and
11.5	cost-effective. A subpoena or discovery-related order issued by an arbitrator must be served
11.6	in the manner provided by law for service of subpoenas in a civil action in this state and,
