1.11	Subd. 1b. Registration required. (a) A person shall register under this section if:
1.12	(1) the person was charged with or petitioned for a felony violation of or attempt to
1.13	violate, or aiding, abetting, or conspiracy to commit, any of the following, and convicted
1.14	of or adjudicated delinquent for that offense or another offense arising out of the same set
1.15	of circumstances:

- (c) A person also shall register under this section if the person was committed pursuan to a court commitment order under Minnesota Statutes 2012, section 253B.185, chapter 253D, Minnesota Statutes 1992, section 526.10, or a similar law of another state or the United States, regardless of whether the person was convicted of any offense.
 - (d) A person also shall register under this section if:

- (1) the person was charged with or petitioned for a felony violation or attempt to violate any of the offenses listed in paragraph (a), clause (1), or a similar law of another state or the United States, or the person was charged with or petitioned for a violation of any of the offenses listed in paragraph (a), clause (2), or a similar law of another state or the United States;
- (2) the person was found not guilty by reason of mental illness or mental deficiency after a trial for that offense, or found guilty but mentally ill after a trial for that offense, in states with a guilty but mentally ill verdict; and
- (3) the person was committed pursuant to a court commitment order under section 253B.18 or a similar law of another state or the United States.
- (e) A person also shall register under this section if the person received a stay of adjudication under section 609.095, paragraph (b), for a charge of violating section 243.166, 609.342, 609.343, 609.344, 609.345, 609.3451, subdivision 3, or 609.3453, unless the offender is a juvenile and the court finds, on the record, that there is good cause to waive the registration requirement.

609.095 LIMITS OF SENTENCES.

- (a) The legislature has the exclusive authority to define crimes and offenses and the range of the sentences or punishments for their violation. No other or different sentence or punishment shall be imposed for the commission of a crime than is authorized by this chapter or other applicable law.
