[347.66] DEFINITIONS. 1.10 Subdivision 1. **Scope.** For the purposes of sections 347.66 to 347.75, the terms defined 1.11 in this section have the meanings given them. 1.12 Subd. 2. **Board.** "Board" means the Companion Animal Board. 1.13 Subd. 3. Companion animal. "Companion animal" means a pet or companion animal 1.14 as defined in section 343.20, subdivision 6. 1.15 Sec. 2. [347.67] COMPANION ANIMAL BOARD; PURPOSE. 1.16 (a) The board's purpose is to protect and promote the welfare, social well-being, and 1.17 physical and mental health of companion animals. The board shall serve the broader 1 18 community, including the public, state and local governments, nonprofit animal welfare 1.19 organizations, and those dedicated to promoting and serving the health and welfare of 1.20 companion animals through the administration and enforcement of sections 347.68 to 347.74. 1.21 (b) The board has primary authority for regulating companion animals in this state. 1.22

(c) Sections 347.67 to 347.72 do not apply to the care or treatment of an agricultural 2.1 animal or farm animal that is used for food, other farm or agricultural products, or other 2.2 2.3 agricultural uses. Sec. 3. [347.68] BOARD STRUCTURE. 2.4 Subdivision 1. **Members; officers.** (a) The Companion Animal Board is created to carry 2.5 out and enforce the purposes, powers, and duties of sections 347.67 to 347.72. The board 2.6 has nine members appointed by the governor represented by the following companion animal 2.7 interests and experience: 2.8 (1) two members must be veterinarians who are licensed and practice veterinary medicine 2.9 in this state; 2.10 (2) one member must be a Minnesota animal control officer; 2.11 (3) two members must be employed in management at a Minnesota nonprofit humane 2.12 2.13 society, one of whom must be from the Animal Humane Society; (4) one member must be from the College of Veterinary Medicine at the University of 2.14 2.15 Minnesota; (5) one member must be a current board member for the past two years of a Minnesota 2.16 nonprofit animal rescue and re-homing organization qualifying as a nonprofit under section 2.17 501(c)(3) of the Internal Revenue Code; 2.18 (6) one member must be employed by the board of animal health; and 2.19 (7) one member must be employed by a county or municipality representing community 2.20 needs and local governance; 2.21 (b) Appointments to fill unexpired terms must be made from the classes to which the 2.22 retiring members belong. The board shall elect a president and a vice-president from among 2.23 its members and a non-member to be the board's executive director for a term of one year 2.24 and until a successor qualifies. The board shall set the duties of the executive director. 2.25 (c) The board shall meet at least quarterly. Officers must be elected each April. 2.26 Subd. 2. Terms; compensation; removal; vacancies. The membership terms, 2.27 2.28 compensation, removal of members, and filling of vacancies on the board are governed by section 15.0575. 2.29

3.27	Subd. 2. Advisory task force. The board may create an advisory task force under section

nι	ist be deposited in the state treasury and credited to the companion animal account in the
spe	ecial revenue fund. Money in the account, including interest on the account, is annually

Sec. 10. RULEMAKING AUTHORITY.

The Companion Animal Board shall amend Minnesota Rules, parts 1721.0490, subpart 3, and 1721.0520, to make conforming changes related to the transfer of duties under section 8. The Companion Animal Board may use the good cause exemption under Minnesota Statutes, section 14.388, subdivision 1, clause (3), to adopt rules under this section, and Minnesota Statutes, section 14.386, does not apply except as provided under Minnesota Statutes, section 14.388.

Sec. 11. APPROPRIATION; COMPANION ANIMAL BOARD.

\$..... in fiscal year 2020 and \$..... in fiscal year 2021 are appropriated from the general fund to the Companion Animal Board for the purposes of carrying out the board's duties under Minnesota Statutes, chapter 347.

Sec. 12. **EFFECTIVE DATE.**

Unless otherwise specified, this article is effective July 1, 2019.

5.19 **BOARD OF ANIMAL HEALTH CHANGES**

Section 1. Minnesota Statutes 2018, section 35.02, subdivision 1, is amended to read:

Subdivision 1. **Members; officers.** The board has five members appointed by the governor with the advice and consent of the senate, three of whom are producers of livestock in the state, and two of whom are practicing veterinarians licensed in Minnesota. The commissioners of agriculture, natural resources, and health, the dean of the College of Veterinary Medicine, the executive director of the Companion Animal Board, and the director of the Veterinary Diagnostic Laboratory of the University of Minnesota may serve as consultants to the board without vote. Appointments to fill unexpired terms must be made from the classes to which the retiring members belong. The board shall elect a president and a vice-president from among its members and a veterinarian licensed in Minnesota who is not a member to be its executive director for a term of one year and until a successor qualifies. The board shall set the duties of the director.

- (a) The board shall protect the health of Minnesota domestic animals and carry out the provisions of this chapter. The board shall make rules necessary to protect the health of domestic animals. The board shall meet at least quarterly. Officers must be elected each April. On or before November 1 of each year the board shall publish an annual report. The University of Minnesota Veterinary Diagnostic Laboratory is the official laboratory for the board. At least quarterly, the director of the Veterinary Diagnostic Laboratory must report on the laboratory's activities.
- 6.11 (b) The board must not adopt or enforce a rule or policy that conflicts with the duties or purposes of the Companion Animal Board under chapter 347.
- 6.13 **EFFECTIVE DATE.** This section is effective July 1, 2019.

Sec. 3. COOPERATION WITH COMPANION ANIMAL BOARD.

- The Board of Animal Health shall cooperate with the Companion Animal Board in the transference of duties under article 1, section 8. This cooperation must include providing the Companion Animal Board with access to any documentation or record keeping:
- (1) related to the duties being transferred from the Board of Animal Health to the
 Companion Animal Board; and
- 6.20 (2) collected and maintained by the Board of Animal Health relating to companion animals.
- 6.22 **EFFECTIVE DATE.** This section is effective July 1, 2019.
