Minnesota Statutes 2022, section 611A.033, is amended to read: 1.6 611A.033 SPEEDY TRIAL; NOTICE OF HEARINGS AND SCHEDULE 1.7 CHANGE. 1.8 (a) A victim has the right to request that the prosecutor make a demand under rule 11.09 1.9 of the Rules of Criminal Procedure that the trial be commenced within 60 days of the demand. 1.10 The prosecutor shall make reasonable efforts to comply with the victim's request. 1.11 (b) A prosecutor shall make reasonable efforts to provide to a victim the date and time 1.12 of the sentencing hearing and the hearing during which the plea is to be presented to the 1.13 court. 1.14 1.15 (b) (c) A prosecutor shall make reasonable efforts to provide advance notice of any change in the schedule of the court proceedings to a victim who has been subpoenaed or 1.16 requested to testify. 1.17 (e) (d) In a criminal proceeding in which a vulnerable adult, as defined in section 609.232, 1.18 subdivision 11, is a victim, the state may move the court for a speedy trial. Subdivision 1. **Notice required.** (a) Except as otherwise provided in subdivision 2, within 15 working days after a conviction, acquittal, or dismissal in a criminal case in which there is an identifiable crime victim, the prosecutor shall make reasonable good faith efforts to provide to each affected crime victim oral or written notice of the final disposition of the case and of the victim rights under section 611A.06. When the court is considering modifying the sentence for a felony or a crime of violence or an attempted crime of violence, the eourt or its designee prosecutor shall make a reasonable and good faith effort to notify the victim of the crime. If the victim is incapacitated or deceased, notice must be given to the victim's family. If the victim is a minor, notice must be given to the victim's parent or guardian. The notice must include:

- (1) the date and approximate time of the review;
