1.6	Section 1. [299A.90] OFFICE FOR MISSING AND MURDERED BLACK WOMEN
1.7	AND GIRLS.
1.8	Subdivision 1. Establishment. The commissioner shall establish and maintain an office
1.9	dedicated to preventing and ending the targeting of Black women and girls within the
1.10	Minnesota Office of Justice Programs.
1.11	Subd. 2. Director; staff. (a) The commissioner must appoint a director who is a person
1.12	closely connected to the Black community and who is highly knowledgeable about criminal
1.13	investigations. The commissioner is encouraged to consider candidates for appointment
1.14	who are recommended by members of the Black community.
1.15	(b) The director may select, appoint, and compensate out of available funds assistants
1.16	and employees as necessary to discharge the office's responsibilities.
1.17	(c) The director and full-time staff shall be members of the Minnesota State Retirement
1.18	Association.
1.19	Subd. 3. Duties. (a) The office has the following duties:

4.12	Subd. 5. Reports. The office must report on measurable outcomes achieved to meet its
4.13	statutory duties, along with specific objectives and outcome measures proposed for the
4.14	following year. The report must include data and statistics on missing and murdered Black
4.15	women and girls in Minnesota, including names, dates of disappearance, and dates of death,
4.16	to the extent the data is publicly available. The office must submit the report by January 15
4.17	each year to the chairs and ranking minority members of the legislative committees with
4.18	primary jurisdiction over public safety.
4.19	Subd. 6. Grants. The office may apply for and receive grants from public and private
4.20	entities for purposes of carrying out the office's duties under this section.
4.21	Subd. 7. Access to data. Notwithstanding section 13.384 or 13.85, the director has access
4.22	to corrections and detention data and medical data maintained by an agency and classified
4.23	as private data on individuals or confidential data on individuals to the extent the data is
4.24	necessary for the office to perform its duties under this section.
4.25	EFFECTIVE DATE. This section is effective July 1, 2023.
